

Hospital practice in COVID-19 times: perceptions of the midwifery interns in Peru

ABSTRACT

Objective: To evaluate the perception of midwifery interns regarding hospital practices during COVID-19. **Material and methods:** Study of qualitative approach, of phenomenological design, where 80 midwifery interns from the different regions of Peru participated, who are also representatives of their hospital headquarters. An in-depth interview was applied where the perception of hospital practices was addressed according to: i) current problems and ii) solution proposals. **Results:** Midwifery interns have been removed from hospital practices, mainly due to the absence of personal protective equipment and health insurance, financially affecting those who must continue to make rent and food payments; Likewise, a large part of the universities have not offered proposals for solutions to the delay in internships, raising concerns about delays in administrative procedures, even more so for students from non-licensed universities. Among the proposals, those who are close to graduating suggest being exempted from the months when there were no activities, so as not to delay future processes such as tuition and rural service; likewise, suspend payment for these months and strengthen knowledge through the discussion of clinical cases, which could be virtual. **Conclusions:** The cessation of hospital practice responds to a lack of guarantees in the health care of the student, generating economic repercussions and a negative perception regarding university management. Finally, solutions that could be considered for the next decisions made by the institutions are reported.

INTRODUCTION

At the end of the year 2019, in the city of Wuhan, China, the outbreak of cases with atypical pneumonia began, spreading in various countries and finally being named as “Coronavirus Disease 2019” (COVID-19) (1,2). Faced with the rapid spread of COVID-19, the World Health Organization declared a state of international health emergency (3). With which, countries from all regions of the world opted for measures that reduce the chain of contagion, among which the obligatory social isolation stands out, the same that has generated repercussions on different activities of the population (4,5).

In the educational field, this situation has led to the suspension of face-to-face academic activities and the requirement for remote education at the basic and higher levels (6). Case is presented in health science students, who part of their professional training involves in-hospital practices, being affected by the restriction of access to facilities. In this regard, guidelines have been proposed to include students in the surveillance of patients with COVID-19, for which minimum requirements must be taken into account, such as the availability of personal protective equipment and screening tests, as well as the assessment of their competences to accept responsibility, regardless of the year of study (7,8). Among other proposals is also the inclusion of the student in public health programs, with previous training in the preventive measures corresponding to COVID-19 (9).

In Peru, the state of national emergency was declared on March 16, 2020 (10), along with other policies and measures in favour of national public health. Meanwhile, the National Superintendence of University Higher Education urged that higher education institutions reprogram their academic and administrative activities in person and invoked the use of information technologies to continue university education (11). The specific situation of the training of future health professionals in the face of the recent situation is unknown, due to the lack of communication spaces between public and private universities with their student group. In addition to this, it is still uncertain how and when the process of reincorporation of midwifery interns to hospital teaching facilities will begin (12,13), especially considering the educational and social needs that each one

presents in the different regions. From Peru. In this sense, this investigation was carried out with the objective of evaluating the perception of midwifery interns from the regions of Peru regarding hospital practices in the days of COVID-19.

MATERIAL Y METHODS

TYPE OF STUDY

Inductive qualitative approach study developed under the phenomenological paradigm, where the experience of an event is studied from the perspective of the individual, being significant in subtracting the personal perspective and its interpretation and sidestepping assumptions predisposed as true (14).

PARTICIPANTS

Students from the last year of midwife (midwifery interns) who were appointed as representatives, also considered as “delegates”, were selected from a group of students who carry out their hospital practices. The representatives are also those who maintain communication with the coordinators or "tutors" of each hospital site, who represent the university in their institution.

The list of inmates fulfilling the role of representatives in the regions of Peru was requested from the National Association of Midwifery Students of Peru (ANEOP, in Spanish), which numbered 98 students, who were invited to participate voluntarily in the study. Finally, 80 representatives agreed to join the study, who were enrolled to participate in an in-depth personal interview remotely (online).

VARIABLES

The student's perception of hospital practice in a COVID-19 context was considered as the main characteristic to be evaluated. To address this perception, a guide to questions was prepared, which was made up of two sections: i) Current situation and perceived problems and ii) Proposals for solutions considered by the group they represent.

ANALYSIS OF THE INFORMATION

The information obtained was reviewed by the researchers, selecting per student the message or messages that summarize or represent the main idea that they sought to communicate, which were transcribed in an Excel database, where

each row corresponded to an midwifery representative and each column the questions asked.

During the review of the responses regarding the “current situation and perceived problems”, four recurring topics were observed, which were considered as research codes: i) Health care, ii) Economic repercussions, iii) University management (Procedures and Posture of the universities). Therefore, a thematic analysis was then carried out based on the codes finally considered.

ETHICAL ASPECTS

The study had the review and approval of the ethics committee of the "Committee for Ethics in Specific Research for COVID-19" of the Institute for Health Technology Assessment and Research, in Lima Peru. During the investigation, it was guaranteed that all participation was voluntary and informed. Finally, the identification of the students was coded before transcription from the database.

RESULTS

Eighty midwifery students at the national level were interviewed, who resided mainly in the Lima (22.5%) and Huancavelica (13.75%) regions. (**Table 1**) Likewise, each participant represented, on average, 12.58 ± 14.14 (Me: 8) midwifery inmates in their respective hospital centres. On the other hand, 17.50% of the interviewees reported that the hospital's internship practices were scheduled to end in December 2020, just as 13.75% reported that this would end in November.

Next, the problems or perceptions of the current situation of hospital practices were evaluated. **Figure 1** shows the responses obtained regarding the lack of personal protective equipment (PPE), which became constant in the establishments; likewise, they refer that the hospital authorities do not guarantee that during the return to the practices the necessary equipment will be provided, since these are only available to the professionals who work there; On the other hand, in the face of hospital exposure, they state that there is a lack of affiliation to comprehensive insurance that would respond immediately to a possible contagion.

Another perceived problem was the economic repercussions, summarized in **Figure 2**. It was found that there are regions where students must travel to another province in order to complete their internship, with which they are currently obliged to continue paying for accommodation and food, despite not be doing clinical practices since the return to the boarding school is constantly postponed.

Figure 3 shows the perceived problems regarding university management, among which were: i) the delay in completing certain procedures, which causes concern for students nearing graduation who require the degree to start their schooling, as well as those inmates from universities that did not obtain a university degree, and ii) the position adopted by certain institutions, who have suggested an immediate return to clinical practices, where inmates have usually preferred not to go due to lack of necessary protection and In other situations, they have been mandatory, referring that not attending their hospital rotations would be sanctioned with a suspension of their previous rotations, proposing that they begin the internship again next year.

Finally, **Figure 4** reports the comments regarding the proposed solutions by the student representatives. It was found that the students are aware that the state of emergency limits the immediate return to hospital services and that the security protocol does not include inmates, which is why they suggest the provision of PPE and the activation of comprehensive insurance. Likewise, they recommend that this time could be used with the presence of virtual "clinical case" classes, to maintain a constant practice of how to solve problems in a hospital environment and not forget prior knowledge. Finally, they suggest not continuing the tuition and monthly charges on the inmates until they return to the hospitals, because they do not benefit from the educational proposals of the universities. All the original answers, in Spanish, are found in the document "**Supplementary material**".

DISCUSSION

Health personnel are a population exposed to the contagion of COVID-19. Although it is true that the inmates have not yet finished their university studies, the tasks they carry out and the risk of contagion can become the same as any

hired worker (15,16). Even so, there are no guarantees in the delivery of personal protective equipment (PPE) and comprehensive insurance. Recent studies and the World Health Organization (WHO) agree that there is a global shortage of PPE, as well as medical furniture, mechanical ventilators, and hospital beds, which shows how this problem is replicated internationally (17-19)

On the other hand, the suspension of clinical practices and academic activities has substantially affected those students who were doing their internship in cities far from their origin, which has forced them to assume expenses that allow them to maintain their accommodation and food before the possibility of resume practice at any time. International evidence has reported this problem in those students who study abroad, where it is shown that they not only face the financial problem, but also a constant concern for their families in their cities of origin, being susceptible to anxiety and stress (20 -22).

Regarding the perception of university management in a context of COVID-19, the midwifery interns report that in certain cases their coordinators have not commented on any definite position on the start of academic activities. This situation has been taking place in various countries. Studies carried out in China, where they have experienced a similar stage with SARS, suggest the implementation of virtual training on the current disease, maintain constant communication between students, teachers and administrative staff and, finally, manage remote psychological services for their student staff (2. 3); Likewise, the University of Washington suggests an active stance of academic institutions, where alliances are generated with local public entities that allow student healthcare support and scientific development (24).

One of the solutions proposed by the midwifery inmates was the reduction of the duration of the internship, due to the exposure time they could have in the hospital. We assume that the measure could be feasible depending on the evaluation of the missing time and the achievement of the competencies proposed for the boarding school. A previous study has established as a strategy that, in order not to postpone the wait, they begin with virtual classes on epidemiology, and then include the inmates in the disease control and prevention programs in first-level establishments, where there is a lower risk of contagion.

The demand for the suspension of the monthly payment or other expenses towards the universities while the compulsory social immobilization lasts has been based on the student's dissatisfaction with paying an incomplete or poorly delivered service; however, this attitude can be enhanced by the economic limitations inherent in the context, which escape the academic-hospital environment and also includes the loss of massive jobs and the increase in costs of certain foods due to panic, greatly limiting the economic income due to family (26).

It is necessary to consider that the results found are limited to the subjectivity of the midwifery student, with which it could be replicated in other fields of the health sciences or the perspective of the authorities, both hospital and university, could be evaluated. However, the strength of this study lies in the representativeness that has been sought, considering the presence of students from all regions of Peru.

Finally, we conclude that midwifery inmates perceive that the lack of personal protective equipment, the economic repercussions and the delay of procedures are the main problems where they have been affected. Likewise, this study reports solutions that could be considered for the next policies to be formulated.

Health care

"... In a meeting with all the staff, it was concluded that the inmates should leave the boarding school, since they did not have the Personal Protective Equipment and would not ensure our protection, which is why the establishment would not be responsible if is that one of the inmates was contagious " (Ayacucho)

"We were withdrawn on March 16 because we did not have any insurance to protect us if something happens to us, the hospital is not responsible for us ..." (Ayacucho)

"It has not been pronounced (the hospital), we do not know when we are going to return, apart from that the hospital does not provide us with masks, they say that it is only for the staff that works" (Junin)

"... The midwifery interns do not have any financial support, health insurance, or the necessary biosecurity teams to support us. If something happened to us, who? He will be responsible ... " (Lima)

"... in the hospital they gave us masks to continue doing the internship, but in the other venues they did not give them, indicating that they (interns) are in charge of the university" (Lima)

Economic impact

"We where we do the internship are foreign and we are making an extra expense by paying the rent for the room that at the moment we do not even occupy" (Huancavelica)

"The hospitals withdrew us until further notice, ... there are colleagues who are interning in Satipo, for this reason there are expenses that they have made and continue to do, such as renting and other things" (Junin)

"They are still charging us fees (the university) and they do not inform us if there will be a default (by not paying) ... since we may not have the means to cancel everything" (Lima)

"Our headquarters do not have a residence, my colleagues must pay for a room and their food ... and in this emergency it is almost impossible to find a place to pay for the menu (low cost food)" (San Martin)

"... there are comrades who want to exempt us from the time that we are going to be in quarantine, due to the pandemic, so as not to fall behind" (Lambayeque)

"... depends on how long the quarantine lasts, ... if it continues there should be virtual reviews, especially clinical cases" (Huancavelica)

"You can avoid rotating for services for which we have previously rotated in the externship, such as psychoprophylaxis, outpatient office or family planning, since we can see that in health centres or maternity centres" (Lima)

"Do not charge late payment for late payments, and during these months" (Lima)

"That they also provide us with mobility for those who do not have them, such as university buses or police officers, ... they have to tip us, at least to be able to support us all this time from quarantine, since nobody works and we would leave our family out in the open " (Loreto)
