Abstract 200 —(max. 200; structured)

Objective: To investigate COVID-19 epidemiology in Alberta, British Columbia and Ontario, Canada.

Methods: We calculated the incidence rate ratio (January 1—July 6, 2020) between the 3 provinces, and

estimated time-varying reproduction number, R_t , starting from March 1, using EpiEstim package in R.

Results: Using British Columbia as a reference, the incidence rate ratios in Alberta and Ontario are 3.1

and 4.3 among females, and 3.4 and 4.0 among males. In Ontario, R_t fluctuated ~1 in March, reached

values >1 in early and mid-April, then dropped <1 in late April and early May. R_t rose to ~1 in mid-May

and then remained <1 from late May through early July. In British Columbia, R_t dropped <1 in early

April, but it increased towards the end of April. $R_t < 1$ in May while it fluctuated around 1.0 in June and

early July. In Alberta, $R_t > 1$ in March; R_t dropped in early April and rose again in late April. In much of

May, $R_t < 1$, but R_t increases in early June and fluctuates ~ 1 since mid-June.

Conclusions: R_t wavering around 1.0 indicated that three provinces of Canada have managed to achieve

limited onward transmission of SARS-CoV-2 as of early July 2020.

Introduction

In 2020, the pandemic of coronavirus disease 2019 (COVID-19), caused by the severe acute respiratory syndrome virus 2 (SARS-CoV-2), spread across Canada. The first imported case was presented in a Toronto hospital on January 23. 2020.^{1,2} On March 13, Quebec was the first province to declare a public health emergency;³ four days later, Alberta, British Columbia and Ontario also declared public health emergencies (Table S1).⁴ As of July 10, a cumulative total of 107,126 cases, including 8759 deaths, have been reported in Canada.⁵ As seen in the Canadian government's outbreak update,^{6,7} the national epidemic trajectory appears to have stabilized in early July, but spatial-temporal pattern displays substantial heterogeneity across provinces.

Epidemiologists have explored various aspects of the pandemic in Canada, including data availability,⁸ syndromic surveillance,⁹ disease burden and mortality,¹⁰ as well as the epidemiology in specific settings or subpopulations, such as nursing homes,¹¹ and intensive care units.¹² Mathematical modelers have also made projections of epidemic trajectories to assist Ottawa and the provincial governments in their decision-making.^{7,13-16} Against the backdrop of recent literature, our study provides a unique perspective by estimating and interpreting the time-varying reproduction number, *R_t*, of SARS-CoV-2 at both provincial and subprovincial levels in 3 Canadian provinces.

This study described the COVID-19 pandemic as it unfolded in Alberta, British Columbia, and Ontario. Our objectives are to compare COVID-19 incidence rates from January 1 to July 6, 2020, and to estimate the time-varying reproduction number, R_t , of SARS-CoV-2 since the beginning of March 2020.

Methods

Scope and data sources. We investigated the descriptive epidemiology and the R_t of SARS-CoV-2 in Alberta, British Columbia, and Ontario, and their public health subdivisions, using publicly available line lists of COVID-19 case data downloaded from provincial government websites. Alberta, British

Columbia, and Ontario were chosen for this analysis given their line list data availability. These datasets contained no personal identifiers to protect patients' privacy. Population data by age and sex for Alberta, British Columbia and Ontario was downloaded from Alberta government website. At the time of our study, Quebec has not yet made the line list of cases publicly available and was not included herein. As of early July, the cumulative number of cases in the other provinces were relatively small and therefore those provinces were not included. The Canadian government's national line list dataset provided the accurate episode time in epidemiologic weeks instead of dates, and thus could not be analyzed using our method here. All the subprovincial incidence curves and R_t trajectories were presented in the Supplementary Materials.

Timeframe. The timeframe of this study started on January 1, 2020 (the accurate episode date of the earliest confirmed case in Ontario) and ended on July 5 (Alberta and Ontario) or 6 (British Columbia), the last episode date or reported date in each of our datasets. This timeframe is characterized by importation of cases from overseas followed by community transmission while social distancing measures were gradually introduced. March 17 was the day when the public health emergency was declared in Alberta, British Columbia and Ontario.⁴ By early July, some mandatory social distancing measures remain implemented therein.

The timeframe for R_t estimation began with March 1. We did not estimate R_t in January and February because the small number of cases in Ontario and British Columbia during that time would lead to very uncertain R_t estimates. No cases were reported in Alberta before March.

Ontario dataset. The Ontario dataset included cases until the end of July 5, 2020 and was downloaded on July 6, 2020, at 5.34pm (EDT). ¹⁸ In Ontario, the subprovincial unit is a Public Health Unit (PHU). The Ontario dataset contained the following variables: accurate episode date, case reported date, test reported date, specimen date, age group, gender, case acquisition information, clinical outcome, outbreak-related (yes or no), reporting PHU, and the address, city, postal code, website, latitude and longitude of the reporting PHU.

In contrast to the Alberta and British Columbia datasets, which did not contain information on how the case-patients acquired the virus, the Ontario dataset provided information on how a case-patient acquired the virus ("Case Acquisition Info"): 1761 travel-related cases, 10839 "close contact" cases, 6687 cases with "no epi-link", 14259 outbreak-related cases, 1120 cases with "no info-missing" and 1280 cases with "no info-unknown". In our R_t estimation, we categorized all travel-related cases as "imported" cases and all others as "local" as per user instructions for the EpiEstim package. Please note that to run the EpiEstim package, the first case(s) on the first day of a time series must be rendered as "imported" cases. Thus, if the first case(s) of a time series was not travel-related, we manually denoted them as "imported" cases so that R_t can be estimated using the EpiEstim package.

Alberta dataset. The Alberta dataset included cases until the end of July 5, 2020 and was downloaded on July 7, 2020 at 7.59am (Eastern Daylight Time, EDT).¹⁹ In Alberta, each subprovincial unit is a Health Services Zone. The Alberta dataset contained the following variables: date of report, health services zone, gender, age group, case status (clinical outcome) and case type (confirmed or probable). The Alberta dataset contained 7678 confirmed cases and 711 probable cases; both types are included in the main analysis. In the sensitivity analysis, only confirmed cases were analyzed.

British Columbia dataset. The British Columbia dataset included cases until July 6, 2020 and was downloaded on July 7 at 8.01am (EDT).²⁰ In British Columbia, each subprovincial unit is a Health Authority. The British Columbia dataset contained the following variables: date of report, health authorities, sex, age group and classification reported ("Epi-linked" versus laboratory-diagnosed). The British Columbia dataset contained 2970 laboratory-diagnosed cases (aka confirmed cases) and 8 "epi-linked" cases (aka probable cases); both are included in the main analysis. In the sensitivity analysis, only laboratory-diagnosed cases were analyzed.

Incidence rate ratio. The incidence rate was calculated by dividing the cumulative number of cases in a province by its total population in 2019. Given that the timeframe of our datasets is essentially the same (with only a difference in 1 day), we did not use person-time as the denominator. We used British

Columbia as the reference, and calculate the incidence rate ratio (IRR) of Alberta and that of Ontario. We did not calculate the 95% confidence interval for the estimates, because the estimates were true population estimates and not sample estimates, as we used data from province-wide surveillance systems that cover everyone in the province.

Case fatality ratio. We limited our analysis to individuals whose clinical outcomes are known (either deaths or recovered), and used the following simple estimator to obtain an approximation of the case fatality ratio: case fatality ratio = number of deaths / (number of deaths + number of recovered).²¹

Time-varying reproduction number. In contrast with the basic reproduction number, R_0 , which represents the average number of secondary cases generated by an infectious individual in a totally susceptible population in the absence of interventions or behavioral changes, R_t is a time-varying indicator which represents the average number of secondary cases per infectious individual in a population as the epidemic unfolds in the presence of interventions and behavioral changes. $R_t > 1$ indicates sustained transmission and epidemic growth; $R_t < 1$ indicates unsustainable transmission and epidemic decline. As the epidemic runs its course, it is possible to quantify R_t over time after accounting for reductions in susceptibility in the population as more people acquire immunity through natural infection, behavior changes in the population, and interventions that mitigate the transmission rate.²²

Instantaneous reproduction number method implemented in R package EpiEstim. There are multiple statistical methods available for R_t estimation, 23,24 one of which is the instantaneous reproduction number method implemented in the R package EpiEstim. This method is considered to be well-suited to near-real-time estimation of R_t , and is sensitive to signals of changes in transmission potential given recent implementation and cessation of interventions or behavioral changes. This method has been applied in various studies to estimate the R_t of SARS-CoV-2 in different locations globally. A summary of the instantaneous reproduction number method is provided in the Online Supplementary Materials.

Software version. Data management and analysis (except for maps) was performed using Microsoft Excel and R version 3.6.2 (R Core Team, Vienna, Austria). Version 2.2-3 of the EpiEstim package was used. Maps were made in R version 3.5.1 (R Core Team, Vienna, Austria).

Ethics. The Georgia Southern University Institutional Review Board made a non–human subjects determination for this project (H20364), under the G8 exemption category.

Results

The dates of the first cases and the total number of cases in our datasets by each subprovincial public health unit in Alberta, British Columbia and Ontario are presented in Table S2.

Incidence rate ratio and case-fatality ratio at the provincial level. Table S3 presents the number of cases per 100,000 population, stratified by sex/gender and age groups (see Tables S4-S6 for details).

Interestingly, the incidence rates in Alberta and Ontario were higher than those in British Columbia, which served as the reference group. Among females, the respective IRR in Alberta and Ontario were 3.1 (187.3/59.9) and 4.3 (259.9/59.9). Among males, the respective IRR in Alberta and Ontario were 3.4 (196.2/57.2) and 4.0 (196.2/57.2). This may reflect a more aggressive testing strategy in Alberta and Ontario. As of July 11, 2020, Alberta and Ontario had the highest rate of testing in Canada (102,299 and 110,612 tests per million population, respectively) whereas in British Columbia the rate was only 36,059 tests per million population.⁶ In both provinces, anyone who feels needing a test, including asymptomatic individuals, can get a test without referral. For example, Ontario waived the requirement to get a referral to qualify for testing on May 24, 2020, and increased testing capacity to over 20,000 a day. ³⁵ Likewise, Alberta started testing asymptomatic cases around mid-May. The alternative hypothesis was that this might reflect a genuine difference across the 3 provinces in their epidemiology of COVID-19. Tables S7 and S8 present the clinical outcomes of cases in Alberta and Ontario. As expected, the elderly has a high case-fatality ratio than other age groups, as described in a recent study by Bignami and Van Assche, ¹⁰ and

this is similar to observations in other parts of the world, such as England.³⁶ Likewise, as in other countries, there had been outbreaks in long-term care facilities in Canada.^{11,37,38}

Epidemic curve and R_t.

The accurate episode date of the first two cases in Ontario was January 1, 2020, one without epi-link and one being a close contact. The "no epi-link" case was a male in his 80s whose specimen date was April 23 and whose test result was reported on April 24 (case reported on the same date). The "close contact" case was a male in his 50s whose specimen date was May 15 and whose test result was reported on May 17 (case reported on the same date). A third case was a male in his 50s whose accurate episode date was January 10 and was a "close contact" case but whose specimen was taken on June 9 (test reported and case reported on the next day). This cluster of 3 cases had episode dates before the first two reported cases in Ontario (date of report: January 23, 2020) whose accurate episode dates were January 21 and 22 respectively. In Ontario (Figure 1), R_t fluctuated around 1 in March, rose to >1 but <1.25 in early and mid-April, then dropped <1 in late April and early May. R_t rose to ~1 in mid-May and then remained <1 from late May through early July.

A map showing the cumulative number of cases over time by PHU in Ontario is presented in Figure 2, and a similar map showing the cumulative number of deaths is in Figure S1. Epidemic trajectories in selected PHUs are as follows. In City of Toronto PHU (Figure S2) and its neighbors, namely, Durham Regional PHU (Figure S3), Peel Regional PHU (Figure S4), and York Regional PHU (Figure S5), we observed similar tragectories: $R_t \ge 1$ in sustained period of time from late March to mid-April. R_t subsided to <1 in late April and early May but rose to ~1 in mid-May. R_t decreased to <1 consistently in early June but it was on an increasing trend towards early July. Slightly further away from Toronto, in Halton Regional PHU (Figure S6), R_t fluctuates around 1 through the study period. It was <1 in much of June. In City of Hamilton PHU (Figure S7), R_t fluctuates around 1 through the timeframe of this study, except for mid-May when R_t reached a peak of 2 (1-window estimate). In Region of Waterloo PHU (Figure S8), R_t fluctuates around 1 in March but increases steadily to >1 in mid-April, followed by a continuous drop to

<1, until late May when R_t rebounded to around 1 in June. In Niagara Region PHU (Figure S9), R_t fluctuates around 1 across the timeframe of this study, except for late May when there was a surge in cases leading to R_t >1 in late May followed by a trough <1 in June. In Ottawa PHU (Figure S10), R_t was <1 in late March but it increased to slightly >1 in April. It maintained <1 in much of May and fluctuates around 1 in June. For the other PHUs from Algoma PHU to Windsor-Essex County Health PHU, see Figures S11 to S35.

The first case in British Columbia was reported by Vancouver Coastal Health Authority on January 26, 2020. In British Columbia, R_t dropped below 1 the first time in early April, but it increased towards the end of April. For most of May, $R_t < 1$ while it fluctuated around 1 in June and early July (Figure 3). Figure 4 is a map showing the cumulative number of cases in British Columbia by Health Authority over time. Below are epidemic trajectories in selected Health Authorities. In Vancouver Coastal Health Authority (Figure S36), R_t was ~ 2 in mid-March and dropped to 1 by April and below < 1 in mid-April but increased in late April to ~ 1 . It fluctuates < 1 for much for May but rose to ~ 2 in mid-June, followed by fluctuation around 1 in late June and early July. In Fraser Health Authority (Figure S37), R_t fluctuated between 1.5 and 2 in mid-March before dropping to ~ 1 through April. In May it fluctuated < 1 but increased to 1 and fluctuated around 1 in June and early July. For Interior, Northern and Vancouver Island Health Authorities, see Figure S38 to S40. As a sensitivity analysis we analyzed the data excluding 8 probable cases ("epi-linked cases") (Table S9); focusing at the 2970 confirmed cases, the results in R_t are similar (Figure S41).

The first case in Alberta was reported in Calgary Zone on March 6, 2020. In Alberta, $R_t > 1$ in March, corresponding to reaching a peak in incidence in late March and early April. A small dip in R_t happened in early April and R_t rose again in late April, as the incidence increased and reached a peak in late April. In much of May, $R_t < 1$, but R_t increases in early June and fluctuates around 1 (slightly above 1) since mid-June (Figure 5). Figure 6 is a map showing the cumulative number of cases in Alberta by Health Services Zone over time, while Figure S42 is a similar map showing the cumulative number of deaths. Below are

epidemic trajectories in selected Health Services Zones. In Calgary Zone (Figure S43), R_t began at ~2 in mid-March and dropped to ~1 in early April and rose again to ~1.5 and maintained >1 in the second half of April. In May and early July, R_t was <1, but increased to ~1 from mid-June through early July. In Edmonton Zone (Figure S44), it fluctuates around 1.5 in late March, dropped to 1 in early April and <1 in mid-April. R_t rose to ~1 in late April and then maintained at a <1 level for much of May. R_t increased to ~2 in late May and early June, and then gradually dropped to ~1 in early July. In South Zone (Figure S45), Rt fluctuated around 1 in late March and early April and rose to ~3 in the second half of April as there was an outbreak from mid-April to early May. Rt below <1 in much of May and fluctuated around 1 in much of June and made a sharp increase to ~2 in early July. For Central and North Zones, see Figures S46 and S47. As a sensitivity analysis we analyzed the data excluding 711 probable cases; focusing at 7678 confirmed cases only, the results in R_t are similar (Figure S48).

Specimen collection date in Ontario dataset. Among the 35948 case-patients in Ontario, the median delay in specimen collection for testing is 1 day after symptom onset (accurate episode date), with an interquartile range from 0 to 5 days. A decrease over time in the average time difference between date of symptom onset and the date of specimen taken, and the variance of that time difference (Figure 7 Panel a) represents the improvement in the testing capacity allowing individuals to get tested promptly after symptom onset. As seen in Figure 4a, the delay on March 1 would be 7.4 days and the delay was close to 0 around June 21. See Appendix for details of the regression model. The longest time difference (an outlier) was a delay of 151 days (that might suggest that these were serological tests and not polymerase chain reaction tests, ³⁹ but the dataset do not provide further details). A total of 305 (0.8%) individuals do not have specimen dates. There were 2391 (6.7%) whose specimens were collected prior to date of symptom onset, i.e. (accurate episode date − specimen date) < 0. Of these 2391 individuals, 926, 766, 397 and 302 individuals developed symptom 1, 2, 3 or ≥4 days, respectively, *after* having specimen taken for testing (Table S10). Most of these 2391 case-patients were outbreak-related (n=1473) or close contacts of cases (n=619), while 28 were travel-related. However, 211 of them did not have any epi-link, and 24 and

36 were without case acquisition info ("missing" or "unknown" respectively) (Table S11). This is not surprising, since Ontario enhanced testing capacity for testing asymptomatic people at risk of exposure. Of these 2391 individuals whose specimens taken prior to symptom onset, except for 8 who did not have a test report date, 1463 (61%) had their tests reported the same day as their symptom onset; 307 (13%), 1 day after symptom onset, 385 (16%), \geq 2 days later, and 228 (9.5%) had their test reported *before* symptom onset (Table S10). Of these 2391 individuals, 1641 (69%) had their case reported the day they developed symptoms, 337 (14%) on the next day of symptom onset, 413 (17%), \geq 2 days after symptom onset (Table S10).

Delay in test report and case report in Ontario dataset. The delay in test report decreased over time. On March 1, the delay was approximately 11 days, while on July 5, it was about 1 day (Figure S49). The delay in case report has also decreased over time. On March 1, the delay was approximately 10 days, while on July 5, it was about 1 day (Figure 7 panel b). See Appendix for details of the regression models.

Discussion


- Figure 1. The epidemic trajectory of coronavirus disease 2019 in Ontario, January 1-July 5, 2020: Upper

Alberta, British Columbia and Ontario, Canada, appeared to have managed to achieve limited transmission of SARS-CoV-2 with R_i ~1 at the time of writing in early July 2020 (Figures 1, 3, 5), through a combination of multiple interventions, including community social distancing, increased testing of individuals at higher risk or suspected of SARS-CoV-2 infection, and isolation of COVID-19 cases. Canada's experience with SARS epidemic in 2003 may have contributed to the coordinated government's response in COVID-19. The 2003 SARS epidemic in Canada resulted in a set of recommendations to federal, provincial, and territorial leader, and in particular, led to the creation of the Public Health Agency of Canada which has been leading the response to COVID-19.

Our results show that since mid-March in the 3 Canadian provinces under study, SARS-CoV-2 has been spreading with an R_t <2 that is smaller than the estimated R_0 of >2.^{41,42} For the majority of the time period

under study, R_t fluctuated around 1. Our analysis of the COVID-19 epidemic by Canadian subprovincial units present a similar picture as our province-level analysis with few exceptions. Nowhere in Canada experienced the trauma that residents in Wuhan, Milan and New York City had experienced. While Canadian provinces have substantial administrative authority over COVID-19 response, the federal and provincial government have collaborated to produce a coordinated response to the pandemic, as evidenced by the similar COVID-19 response measures in the three provinces, as well as the united politicians' communications on the nature and severity of the COVID-19 pandemic, and the necessity of social distancing across the different Canadian political parties. As the three provinces began reopening businesses, services, and public spaces, all three provinces have been gradually relaunching by stages which depended on local infection rate and the capacity of the healthcare system.

Our study has several limitations. First, our R_i estimation for Alberta and British Columbia relied on data by reporting date and not date of onset, as the latter was unavailable to us. Only Ontario provided the accurate episode date. Future research can study the epidemic data by date of onset when it is available to researchers to better estimate R_i . Second, the number of reported cases per day in the Alberta and British Columbia datasets would be influenced by the testing rate, since limited testing capacity could lead to underdiagnosis. We did not attempt to do a nationwide analysis for Canada because the testing criteria has not been consistent across Canadian provinces. Third, our estimates are contingent that the testing ratio does not change significantly over the study period. However, provincial governments might have been ramping out testing capacity during the early epidemic phase in their jurisdiction. Fourth, reporting delays are known to vary over time and could influence the observed trajectory of the epidemics by date of report in Alberta and British Columbia. For Ontario, our results showed that the delay to testing has been reduced over time and Ontario achieved testing on the same or next date since symptom onset in June. It is possible that similar improvement in reduction in testing delay may have happened in Alberta and British Columbia, but we do not have such data. Fifth, improvement in testing over time could potentially reduce generation time over time. As we do not have data on infector-infectee pairs, we cannot estimate if

serial interval has changed over time. In our R_t estimation, our serial interval distribution is parametrically determined *a priori* based on the literature. Sixth, the Ontario dataset is by date of symptom onset and therefore the most recent data points may be lower than what they should have been, because there could be cases who had not yet been reported to the provincial government. Thus, the low R_t estimate for Ontario in the 1st week of July may be an artifact due to right-censoring of the data. Seventh, we obtained an approximation of the case-fatality ratio using a simple estimator by restricting the analysis to cases with known outcomes. There are estimation methods that are more statistically advanced, 21,48,49 but they are less accessible to practitioners of applied epidemiology and they are beyond the scope of this paper.

Conclusions

In conclusion, Alberta, British Columbia, and Ontario managed to keep the R_t of SARS-CoV-2 wavering around 1, with our recent estimates indicating sporadic episodes of sustained transmission in Alberta and British Columbia where R_t fluctuates around 1 or slightly >1 in the first week of July. In Ontario, R_t may have been suppressed <1 in early July. Sustained social distancing interventions and further limiting case importations could potentially suppress the epidemic by driving R_t <1 for a sustained period of time.








- 16 Figure 7. (a) Scatter plot of the time difference between symptom onset (accurate episode date) and

- report date of each case-patient in Ontario over time (accurate episode date), Jan 1-July 6, 2020.









Instantaneous reproduction number method implemented in R package EpiEstim

We summarized the instantaneous reproduction number method below, of which detailed description has been made available elsewhere. 4,5 The instantaneous reproduction number is the ratio between the number of incident cases at time t, and the total infectiousness of all the infected individuals at time t: $R_t = I_t/\Lambda_t$, where $\Lambda_t = \sum_{s=1}^t I_{t-s} w_s$. The total infectiousness is the sum of infection incidence up to the previous time point (t-1) weighted by an infectivity function w_s . The infectivity function is a probability distribution that describes the average infectiousness profile of an individual after being infected, and it is usually represented by the serial interval distribution as an approximation to the generation time distribution. The number of new cases at time t is therefore a Poisson distribution with a mean of $R_t \sum_{s=1}^t I_{t-s} w_s$. Given the reproduction number R_t , and conditional on the time series of daily new cases, $I_0, ..., I_{t-1}$, the likelihood of the incidence I_t is therefore, $(I_t|I_0, ..., I_{t-1}, w, R_t) = \frac{(R_t \Lambda_t)^{I_t} e^{-R_t \Lambda_t}}{I_t!}$ where $\Lambda_t = \sum_{s=1}^t I_{t-s} w_s$. Therefore, $R_t = I_t / (\sum_{s=1}^t I_{t-s} w_s)$. We can interpret the instantaneous reproduction number as the average number of secondary cases that an infectious person will infect at time t, if conditions in previous time points remain the same at time t. Given this formulation of the instantaneous reproduction number, R_t is highly sensitive to fluctuation in the incidence data. To minimize R_t variation, the EpiEstim package allows user to specify a time window over which the R_t estimate is assumed to be constant. The window is of size τ and ends at time t. If transmissibility is assumed constant over time from $(t-\tau+1)$ to t, and is denoted by a reproduction number, $R_{t,\tau}$, the likelihood of the incidence during the time period, from $I_{(t-\tau+1)}$ to I_t , conditional on incidence prior to the time period, from I_0 , to $I_{(t-\tau)}$, is found to be:5

$$P(I_{t-\tau+1},...,I_{t}|I_{0},...,I_{t-\tau},w,R_{t,\tau}) = \prod_{s=t-\tau+1}^{t} {[{(R_{t,\tau}\Lambda_{s})}^{I_{s}}e^{-R_{t,\tau}\Lambda_{s}}/I_{s}!]}$$

The EpiEstim package utilized a Bayesian framework with a Gamma-distributed prior for $R_{t,\tau}$, and the analytical expression of the posterior distribution of R_t and estimated its median, the variance and the 95% credible interval (CrI).⁵

Given the small number of cases in January and February and thus wide uncertainty bounds of the R_t estimates, we presented R_t estimates from March to early July. R_t estimates of two respective time windows of 7 days and 14 days, over which the R_t estimates is assumed to be constant, were presented with their 95% CrI, as in Muniz-Rodriguez et al. ¹⁴ As a sensitivity analysis, the 14-day time window provides a more stable estimate as it would not be as responsive to sudden fluctuations in incident case count. We did not use a time window shorter than 7 days because such R_t estimate would be very sensitive to daily incidence fluctuation. Furthermore, for surveillance data by date of report (Alberta and British Columbia), weekend effect is common given the 5-day work week, i.e., daily number of cases reported over Saturday and Sunday would be lower than those from Monday to Friday. Therefore, it is reasonable to use time-windows of 7 or 14 days.

Serial interval is assumed to follow a gamma distribution (mean: 4.60 days; standard deviation: 5.55).

Map creation. The health region boundaries shapefile was downloaded at Statistics Canada at
https://www150.statcan.gc.ca/n1/pub/82-402-x/2018001/hrbf-flrs-eng.htm. The health regions were based
on 2016 Census geographic units. Maps were made in R version 3.5.1 (R Core Team, Vienna, Austria).
The boundaries shapefiles are transformed by R packages rnaturalearth (version 0.1.0) and sf (version 0.9.0), merged with the study data by health regions, and presented by R package ggplot2 (version 3.3.0).
The maps show the cumulative number of cases and fatal cases on the last day of each month between
January 2020 to June 2020, and the last date of the data (5 or 6 July 2020) with non-missing values.

Time delay in specimen collection, test report and case report in Ontario, January 1-July 5, 2020

We ran linear regression models to obtain the trend line over time.

a) Time delay in specimen collection

With (accurate episode date – specimen date) as the outcome variable (y) and accurate episode date as the predictor variable (x), the linear model is:

$$y = -0.06627x + 1221.67026$$

Given that in R, date is counted from Jan 1, 1970 (when it is "day 0"), for January 1, 2020, x = 18262, y = 11.41 days; for March 1, 2020, x = 18322, y = 7.43 days; for June 21, 2020, x = 18434, y = 0.0062 day(s).

b) Time delay in test report

With (accurate episode date – test report date) as y and accurate episode date as x, the linear model is:

$$y = -0.08383x + 1547.21994$$

For January 1, 2020, x = 18262, y = 16.31 days; for March 1, 2020, x = 18322, y = 11.29 days; for July 5, 2020, x = 18448, y = 0.72 day(s).

c) Time delay in case report

With (accurate episode date – case report date) as y and accurate episode date as x, the linear model is:

$$y = -0.07254 + 1339.42505$$

For January 1, 2020, x = 18262, y = 14.67 days; for March 1, 2020, x = 18322, y = 10.32 days; for July 5, 2020, x = 18448, y = 1.18 day(s).
