#### 19 Evidence before this study

- 21 Comparative risk assessment (CRA) systematic literature review-based methodology has been
- 22 used in worldwide global burden of disease (GBD) analysis to determine population attributable
- 23 fraction(s) (PAF(s)) for one or more risk factors for various health outcomes. So far, CRA has
- 24 not been applied to derive PAFs for dietary and other risk factors for worldwide BMI.
- 25 Artificial intelligence (AI) analytics has not yet been applied to worldwide GBD data as an
- alternative to the CRA methodology for determining risk factor PAFs for health outcomes.

#### 27 Added value of this study $\Box$

- 28 A multiple regression derived BMI formula (BMI formula) including PAFs of 20 dietary risk
- 29 factors, physical activity, childhood severe underweight, and sex satisfied all nine Bradford Hill
- 30 causality criteria. The BMI formula also plausibly predicted the long-term BMI outcomes related
- 31 to various dietary and physical activity scenarios. All the BMI formula's 24 risk factor PAFs
- 32 were consistent in sign (+ or -) with the preponderance of previously published studies on those
- 33 risk factors related to BMI.

#### 35 Implications of all the available evidence

36 The AI analytics methodology of GBD data modeling of BMI and associated risk factors infers

- 37 causality of the BMI formula estimates with BMI worldwide and BMIs of subsets. This
- 38 methodology may enable multiple regression formulas for risk factors of health outcomes for a
- 39 range of non-communicable diseases—testable by Bradford Hill causality criteria.

#### 40 Summary

41 **Background:** Artificial intelligence (AI) analytics have not been applied to global burden of 42 disease (GBD) risk factor data to study population health. The comparative risk assessment 43 (CRA) systematic literature review-based methodology for population attributable fractions 44 (PAFs in percent's) calculations has not been utilised for quantifying dietary and other risk factors for body mass index  $kg/M^2$  (BMI). 45 46 Methods: Institute of Health Metrics and Evaluation (IHME) staff and volunteer collaborators 47 analysed over 12,000 GBD risk factor surveys of people from 195 countries and synthesized the 48 data into representative mean cohort BMI and risk factor values. We formatted IHME GBD data 49 relevant to BMI and associated risk factors. We empirically explored the univariate and multiple 50 regression correlations of BMI risk factors with worldwide BMI to derive a BMI multiple 51 regression formula (BMI formula). Main outcome measures included the performances of the 52 BMI formula when tested with all nine Bradford Hill causality criteria each scored on a 0-5 53 scale: 0=negative to 5=very strong support. 54 Findings: The BMI formula derived, with all foods in kilocalories/day (kcal/day), BMI formula 55 risk factor coefficients were adjusted to equate with their PAFs. BMI increasing foods had "+" 56 signs and BMI decreasing foods "-" signs. Total BMI formula PAF=80.96%. BMI 57 formula=(0.37% \*processed meat + 4.23% \*red meat + 0.02% \*fish + 2.24% \*milk + 58 5.67% \*poultry + 1.77% \*eggs + 0.34% \*alcohol + 0.99% \*sugary beverages + 0.04% \*corn + 59 0.72% \*potatoes + 8.48% \*saturated fatty acids + 3.89% \*polyunsaturated fatty acids + 0.27% \*trans fatty acids - 2.99% \*fruit - 4.07% \*vegetables - 0.37% \*nuts and seeds -60 61 0.45% \* whole grains - 1.49% \* legumes - 8.62% \* rice - 0.10% \* sweet potatoes - 7.45% physical 62 activity (METs/week) - 20.38%\*child underweight + 6.02%\*sex (male=1, female=2))\*0.05012

- 67 Interpretation: Nine Bradford Hill causality criteria strongly supported a causal relationship
- between the BMI formula derived and mean BMIs of worldwide cohorts. The artificial
- 69 intelligence methodology introduced could inform individual, clinical, and public health
- 70 strategies regarding overweight/obesity prevention/treatment and other health outcomes.

### 73 Introduction

74 Comparable risk assessment (CRA) methodology by the World Health Organization and the 75 Institute of Health Metrics and Evaluation (IHME) is defined as, "the systematic evaluation of 76 the changes in population health which result from modifying the population distribution of exposure to a risk factor or a group of risk factors."<sup>1, 2</sup> While CRA methodologies have used 77 body mass index kg/ $M^2$  (BMI) in risk factor—health outcome pairs for numerous health 78 79 outcomes (e.g., BMI-ischemic heart disease, BMI-colon cancer, BMI-type 2 diabetes, etc.), CRA 80 has not been attempted to quantify the largely nutritional risk factors related to BMI itself. 81 Influential Stanford University meta researcher, Dr. John Ioannidis provided a likely reason for 82 this in an editorial in the BMJ titled, "Implausible results in human nutrition research." He said, 83 "definitive solutions won't come from another million observational papers or small randomized trials."<sup>3</sup> Dr. Ioannidis called for radical reform of nutritional epidemiology methodologies used 84 85 to influence food/agricultural policies and to produce dietary guidelines for clinicians and the public.4 86

According to IBM Cloud Education, "At its simplest form, artificial intelligence (AI) is a
field, which combines computer science and robust datasets, to enable problemsolving."<sup>5</sup> AI will be used instead of the CRA methodology in this paper.

Satisfying Bradford Hill causality criteria is considered validating in epidemiological research.<sup>6</sup>
We used Bradford Hill causality criteria to test the BMI formula. We hypothesized that AI
analytics with GBD big data would be able to quantify the determinants of worldwide cohort
BMIs and thereby to better our understanding the dietary and other risk factors driving the

- 96 obesity epidemic. We hope this paper answers Dr. Ioannidis' call for innovation in
- 97 epidemiology, particularly nutritional epidemiology.

#### 99 Methods

100 As volunteer collaborators with the IHME we received raw GBD ecological data ( $\approx 1.4$ 101 Gigabytes) on mean BMIs of male and female cohorts 15-49 years old and 50-69 years old from 102 each year 1990-2017 from 195 countries and 365 subnational locations (n=1120 cohorts). We 103 also utilised GBD data on exposures to 32 risk factors and covariates potentially related to BMI. 104 105 Food risk factors came from surveys of individuals as g/day. IHME dietary covariate data 106 originally came from Food and Agriculture Organisation data on animal and plant food 107 commodities available percapita in countries worldwide—as opposed to consumption data from participant interviews.<sup>7</sup> Supplementary Table 1 lists the relevant GBD risk factors, covariates, 108 109 and other available variables with definitions of those risk factor exposures.<sup>8</sup> 110 111 GBD worldwide citations of over 12,000 surveys constituting ecological data inputs for this analysis are available from IHME.<sup>7</sup> The main characteristics of IHME GBD data sources for 112 113 BMI, the protocol for the GBD study, and all risk factor values have been published by IHME GBD data researchers and discussed elsewhere.<sup>9-12</sup> These included detailed descriptions of 114 115 categories of input data, potentially important biases, and methodologies of analysis. We did not 116 clean or pre-process any of the GBD data. GBD cohort risk factor and BMI data from the IHME 117 had no missing records. The updated 2019 raw data with variables we used for this analysis may be obtained by volunteer researchers collaborating with IHME.<sup>13</sup> 118 119

To maximally utilise the available data, we averaged the values for ages 15-49 years old together
with 50-69 years old for BMI and for each risk factor exposure for each male and female cohort

for each year. Finally, for each male and female cohort, data from all 28 years (1990-2017) on
mean BMI and on each of the risk factor exposures were averaged using the computer software
program R.

126 To weigh the country and subnational data according to population, internet searches (mostly 127 Wikipedia) yielded the most recent population estimates for countries and subnational states, 128 provinces, and regions. World population data from the World Bank and the Organisation for 129 Economic Co-operation and Development could not be used because they did not include all 195 130 countries or any subnational data. 131 132 Using the above-described formatted dataset of risk factors, covariates, and BMIs, a software 133 program in R generated a population-weighted analysis dataset. Each male or female cohort in 134 the population-weighted analysis dataset represented approximately 1 million people (range: < 135 100,000 to 1.5 million). The analysis dataset had n=7846 cohorts (rows of data), half male and 136 half female, representative of over seven billion people.

Supplementary Table 2 details how we converted omega-3 fatty acid g/day to fish g/day using data on the omega-3 fatty acid content of frequently eaten fish from the National Institutes of Health Office of Dietary Supplements (USA).<sup>14</sup> As shown in Supplementary Table 3, we converted all of the animal and plant food data, including alcohol and sugary beverage consumption, from g/day to kcal/day. For the g to kcal conversions, we used the Nutritionix track app,<sup>15</sup> which tracks types and quantities of foods consumed. Saturated fatty acids (SFA) risk factor (0-1 portion of the entire diet) was not available with GBD data from 2017, so GBD SFA

145	risk factor data from 2016 was used. Polyunsaturated fatty acid (PUFA) and trans fatty acid
146	(TFA) GBD risk factor data from 2017 (0-1 portion of the entire diet) were also utilised. These
147	fatty acid data were converted to kcal/day by multiplying the fatty acid 0-1 portion of the entire
148	diet by the kcal/day available for each cohort.
149	
150	Statistical methods
151	To determine the strengths of the risk factor correlations with mean BMIs of population
152	weighted worldwide cohorts (7846 cohorts) or subgroups of cohorts (e.g., continents, socio-
153	demographic quartiles, etc.), we utilised Pearson correlation coefficients: r, 95% confidence
154	intervals (95% CIs), and p values.
155	
156	In this first attempt ever to use AI analytics with GBD data, we determined our methodology for
157	deriving a BMI formula as we proceeded by experimenting with strategies to optimise the
158	functioning of candidate BMI formulas. We
159	
160	1. included as many as possible of the available dietary variables,
161	2. combined dietary variables if appropriate, and
162	3. included physical activity and other plausibly informative variables.
163	
164	Appendix 1 explains the use of Bradford Hill causality criteria to assess whether the risk factors
165	in the BMI formula derived accurately modeled the worldwide mean BMI. Briefly, we tested the
166	BMI formula output with the Bradford Hill causality criteria (1) strength, (2) experimentation,
167	(3) consistency, (4) dose response, (5) temporality, (6 analogy, (7) plausibility, (8) specificity,

- and (9) coherence. For each criterion, we used a 0-5 scale to assess the magnitude of support of
- 169 the BMI formula output being causally related to the BMIs worldwide (0=no support of causality
- 170 to 5=very strong support of causality, total possible points=45.
- 171
- 172 In determining the variables to include and exclude in worldwide BMI formula, we set the
- 173 statistical threshold for a variable to enter and to remain in the formula at p < 0.25. We used SAS
- and SAS Studio statistical software 9.4 (SAS Institute, Cary, NC) for the data analysis.

# 177 **Results**

178	Table 1 shows the basic statistics and univariate correlations of mean cohort BMI worldwide
179	with mean dietary and other risk factor values. Whole grains, legumes, rice, and sweet potatoes
180	negatively correlated with BMI. We designated them, "BMI decreasing foods." The six animal
181	foods (processed meat, red meat, fish, milk, poultry, and eggs), alcohol, sugary beverages, corn
182	availability, potato availability, added SFA, added PUFA, and added TFA all positively
183	correlated with BMI. We designated them, "BMI increasing foods."
184	
185	In Supplementary Table 4, which shows BMI risk factor to risk factor correlations, corn
186	availability (kcal/day percapita, a covariate) correlated moderately strongly with sugary
187	beverages (r=0.419, 95% CI 0.400 to 0.437, $p$ <0.0001), suggesting that high fructose corn syrup
188	may have accounted for the unexpected positive correlation of corn with BMI.
189	
190	The strong positive correlations of fruits, vegetables, and nuts and seeds with BMI (Table 1)
191	were unexpected. These findings suggested likely multicollinearity of fruits, vegetables, and nuts
192	and seeds with BMI increasing foods (when an independent variable is highly correlated with
193	one or more known or unknown other independent variables). Supplementary Table 4 shows that
194	fruits, vegetables and nuts and seeds strongly positively correlated with 10 of the 13 dietary
195	variables that positively correlated with BMI (six animal-based foods, alcohol, SFA, PUFA, and
196	TFA). Fruits, vegetables and nuts and seeds negatively correlated with the four other plant-based
197	foods (whole grains, legumes, rice, and sweet potatoes), except fruits was not significantly
198	correlated with whole grains. Together, these findings strongly suggested that multicollinearities

201	Supplementary Table 5 shows the Excel spreadsheet calculations, which were coordinated with
202	SAS multiple regressions involved in the derivation of the worldwide BMI formula. Appendix 2
203	detailed the steps in the multiple regression formula derivation of BMI (dependent variable)
204	versus BMI risk factors (independent variables). As seen in Supplementary Table 5 and
205	described in Appendix 2, the BMI formula versus BMI variance ( $R^2$ =0.8096) * 100 determined
206	the total PAF (80.96%) accounted for by the BMI formula. The 23 risk factor coefficients could
207	then be equated to the PAFs of those individual risk factors. The resulting BMI formula is shown
208	below (all foods in kcal/day):

#### 220 BMI formula output analysed by Bradford Hill causality criteria

- As mentioned in the methods and detailed in Appendix 1, the nine Bradford Hill causality
- criteria tested the functionality of the BMI formula:
- 1. Strength score=5 for r>0.500, p<0.0001—The BMI formula's output regressed with
- 224 mean BMI of worldwide cohorts gave r = 0.907 (95% CI: 0.903 to 0.911) p < 0.0001),
- 225  $R^2$ =0.8096, total percent weight=80.96%.
- 226 **2.** Experiment score=5 for all 20 bootstrap trial BMI formulas with r>0.500, p<0.0001)—
- Table 2 shows bootstrapping the BMI formula related to mean worldwide BMI with 20
- trials (repeated sampling from the worldwide analysis dataset with replacements<sup>16</sup>). Each
- trial had 100 randomly selected cohorts to generate a unique BMI formula. As Table 2
- shows, the mean values for BMI and the risk factor PAFs were all quite close to the mean
- values for BMI and BMI risk factors in the worldwide BMI formula (last column).
- **3.** Consistency score=5 for the mean of absolute differences of BMI formula outputs and
- 233 mean BMI <  $0.300 \text{ kg/M}^2$ —In Table 3, we used 37 subsets of worldwide BMI and risk
- factor data to test the consistency of BMI formula outputs, utilising the 20 bootstrap trials
- 235 (#2 Experiment) to generate 80% confidence intervals for each subset. Table 3 shows the
- 236 average absolute difference between the 37 subgroups mean BMIs and BMI formula

237 outputs averaged  $0.252 \text{ kg/M}^2$ .

4. Dose-response (Biological gradient) score=5 for the mean of absolute differences of BMI formula outputs and mean BMI for the dose-response quartiles< 0.300 kg/M<sup>2</sup>—Table 3 also shows that the mean of the BMI absolute differences between the BMI formula estimates and mean BMIs in the four dose-response quartiles averaged 0.220 kg/M<sup>2</sup>.

242	5.	Temporality score=5 for the BMI trend formula versus BMI trend r>0.500,
243		p < 0.0001—Table 4 shows the mean trends the r values and the R <sup>2</sup> values for each of
244		the 22 risk factors. As is shown in Supplementary Table 6 and detailed in Appendix
245		1, a multiple regression analysis with the worldwide BMI trend 1990-2007
246		(dependent variable) versus 22 of the 23 risk factor mean trends and $R^2$ values from
247		Table 4 (independent variables excluding sex) generated a BMI trend formula (All
248		foods are in Kcal/day.):

258		As with the BMI formula, the coefficients of the BMI risk factor trends formula were
259		equated to their PAFs. BMI trend formula r=0.592 (H24 in Supplementary Table 6),
260		95% CI: 0.577 to 0.606, <i>p</i> <0.0001, and total PAF=35.02%.
261	6.	Analogy score=4—The three metabolic risk factors correlated with BMI to test
262		analogy were systolic blood pressure (SBP), low density lipoprotein cholesterol
263		(LDL-C), and fasting plasma glucose (FPG).
264		• BMI correlated with SBP: r=0.102, 95% CI: 0.080 to 0.124, <i>p</i> <0.0001.
265		• BMI correlated with FPG: r=0.558, 95% CI: 0.542 to 0.573, <i>p</i> <0.0001.

266	• BMI correlated with LDL-C: r=0.756, 95% CI: 0.746 to 0.765, <i>p</i> <0.0001.
267	Since BMI versus SBP r<0.500, Bradford Hill causality score=4.
268	7. Plausibility: Score=5—Based on systematic medical literature reviews, physical
269	activity inversely correlated with BMI, <sup>17</sup> and BMI directly correlated with intakes
270	of sugary beverages, <sup>18</sup> alcohol, <sup>19</sup> and animal foods. <sup>20</sup> The relationship of adult
271	BMI with early childhood severe underweight has not been reported worldwide.
272	Since people in poor countries with high infant/childhood malnutrition have fewer
273	resources to obtain animal foods, fatty acids, and alcohol and more need for
274	physical exercise than in developed countries, it is highly plausible that childhood
275	severe underweight negatively correlated with lower BMI in adulthood.
276	8. Specificity: Score=5 for the BMI formula being unique—the BMI formula was
277	specific to worldwide BMI and would have been different from risk factor
278	formulas modeling SBP, FPG, LDL-C, or any health outcome.
279	9. Coherence: Score=5—As evidenced by the near perfect score 39/40 on the first eight
280	criteria, the BMI formula accurately modeled worldwide mean BMI-total causality
281	criteria score: 44/45.
282	
283	Table 5 shows BMI formula estimates for various patterns of diet and/or other BMI formula risk
284	factors. For instance, increasing physical activity by adding a run for 1 hour/day at six miles/hour
285	on average along with decreasing BMI increasing foods by isocalorically shifting 25% of BMI
286	increasing foods (Kcal/day) to BMI decreasing foods was projected to reduce the mean cohort
287	BMI from 26.66 kg/M <sup>2</sup> to mean BMI=22.26 kg/M <sup>2</sup> .
288	

# 290 **Discussion**

291 This paper's analysis dataset formatted from GBD worldwide data used with the BMI 292 formula enabled quantifying 23 risk factor PAFs for worldwide mean BMI for cohorts 293 of 15-69-year-old people. This quantitatively rigorous methodology satisfied all nine 294 Bradford Hill criteria for showing the BMI formula derived accurately modeled BMI. 295 296 The BMI formula PAFs are quite consistent with a 20-year-long observational study with 297 120,877 US male and female adults reported by Mozaffarian, et. al. They measured weight 298 change per four-year period per 1.00 increased serving per day of various foods. It found the 299 following foods associated with increased weights over four years: potato chips (0.77 kg), 300 potatoes (0.58 kg), sugar-sweetened beverages (0.45 kg), unprocessed red meats (0.43 kg), and 301 processed meats (0.42 kg). With the same methodology, the following foods associated with 302 decreased weights: vegetables (-0.10 kg), whole grains (-0.17 kg), fruits (-0.22 kg), nuts (-0.26 kg)kg), and yogurt (-0.37 kg) ( $p \le 0.005$  for each comparison).<sup>21</sup> 303 304 305 According to the International Potato Center, potato availability (a covariate), which positively correlated with BMI, included >50% highly processed potato products worldwide.<sup>22</sup> This likely 306

307 partially accounted for the positive correlation of potatoes with BMI. Higher intakes of ultra-

308 processed foods overall have been associated with overweight/obesity.<sup>23</sup> Ultra-processed food

309 intakes have increased dramatically in developed countries in recent decades and are now

310 increasing in middle-income countries.<sup>24</sup>

311

312 With the results of this paper consistent with and adding to previous findings, we should consider 313 including the quantification of BMI risk factors demonstrated here into US Department of Health 314 and Human Services (USDHHS)/ US Department of Agriculture (USDA) health policy 315 discussions and clinical nutrition guideline deliberations. For instance, the Supplemental 316 Nutrition Assistance Program (SNAP-formerly Food Stamps) spent an estimated 22.6% of its \$73 billion/year budget in 2019<sup>25</sup> on payments to low-income Americans for "sweetened 317 beverages, prepared desserts, salty snacks, candy, and sugar."<sup>26</sup> Additionally, the USDA has 318 319 subsidised crops that go primarily for animal feed or that are processed into sugars while not subsidising fruits and vegetables.<sup>27</sup> While the USDA recognises the relatively low intake of fruits 320 321 and vegetables in the USA and sponsors a publicity campaign to increase fruits and vegetables consumption,<sup>28</sup> USDA expenditures should promote reduced prices of BMI decreasing foods and 322 323 increased prices of BMI increasing foods.

324

A review of the literature on food costs relative to nutrient quality found that the median costs of fruits and vegetables ( $\notin 0.82/100$  kcal) were quite high relative meat/eggs/fish ( $\notin 0.64/100$  kcal), fresh dairy ( $\notin 0.32/100$  kcal), nuts ( $\notin 0.25/100$  kcal), and starches ( $\notin 0.14/100$  kcal).<sup>29</sup> The economics of food, including the high cost of fruits and vegetables relative to animal foods, starchy potatoes, and sugary beverages, may contribute to overweight and obesity in the USA and in other affluent countries.

331

Following a low-carbohydrate, high-fat diet has been demonstrated to cause modest short term
 weight loss in obese people,<sup>30</sup> However, the BMI formula projects that the long-term effect of a

low-carb, high fat diet would be a mean cohort BMI of 29.05 kg/M<sup>2</sup> 80% CI: 27.92 to 29.54 kg/M<sup>2</sup> (Table 5).

337 Limitations

338 The GBD data on animal foods, plant foods, alcohol, and fatty acids were not comprehensive and

339 comprised only 1191.4 Kcal/day on average worldwide. Subnational data were available on only

340 four countries. Because the data formatting and statistical methodology were new, this was

341 necessarily a post hoc analysis and no pre-analysis protocol or Bradford Hill causality criteria

342 scoring system was possible. As detailed in the Foresight Report on obesity,<sup>31</sup> obesity is affected

343 by a complex system of interacting factors besides diet, physical activity, and childhood feeding

344 patterns, and sex. So genes,<sup>32</sup> gut microbiome,<sup>33</sup> ultra-processing of food,<sup>34, 35</sup> and other

influences on BMI were outside of the purview of this analysis.

346

#### 347 Generalisability

348 Over 70% of the cohorts in analysis dataset had low to moderate BMI levels ( $BMI < 23 \text{ kg/M}^2$ ),

349 so the results could be further refined for relatively high SDI countries. For results more

applicable to high BMI countries, BMI formulas might also be derived from (1) the four

351 countries that have subnational data (UK, USA, Mexico, and Japan n=730 cohorts, mean

352 BMI=24.85 kg/M<sup>2</sup>) (2) the cohorts with mean BMI  $\ge$  23 kg/M<sup>2</sup> (n=2256 cohorts, mean

353 BMI=24.84 kg/ $M^2$ ), or (3) high SDI countries (n=1926 cohorts, mean BMI=24.49 kg/ $M^2$ ).

# 354 Conclusions

- 355 Nine Bradford Hill causality criteria strongly supported that the BMI formula derived with 23
- risk factors in proportion to their PAFs accurately modeled worldwide cohort mean BMI. While
- this study dealt only with dietary and other available risk factors for BMI (overweight/obesity),
- the AI methodology introduced could easily apply to estimating PAFs of multiple dietary and
- 359 other risk factors that pertain to dozens of non-communicable disease health outcomes, for which
- the IHME have GBD data.
