# 22 ABSTRACT

23

Background: To investigate the effect of COVID-19 home confinement on levels of physical
activity, sedentary behavior and health-related quality of life (HRQL) in older women previously
participating in exercise and educational programs.

27 **Methods:** 64 older women (age =  $72\pm5$  ys) who participated in a physical exercise/educational 28 program and adhered to government home confinement recommendations have their levels of 29 physical activity, sedentary behavior and HRQL assessed before and during (11 to 13 weeks after 30 introduction of government recommendations to reduce virus transmission) COVID-19 pandemic.

**Results:** There were significant reductions in total physical activity (-259 METs/week, P = 0.02), as

a result of a ~17.0 % reduction in walking (-30.8 min/week, P = 0.004) and ~41.8 % reduction in

vigorous-intensity activity (-29.6 min/week, P < 0.001). Sedentary behavior also increased (2.24

h/week, P < 0.001; 1.07 h/week days, P < 0.001; and 1.54 h/weekend days, P < 0.001). However, no significant change occurred in moderate-intensity physical activity, and HRQL domains and facets,

36 except for an improvement in environment domain.

37 Conclusion: Home confinement due to COVID-19 pandemic decreased levels of physical activity 38 and increased levels of sedentary behavior in previously active older women who participated in an 39 educational program. However, there were no significant changes in HRQL. These results suggest 40 that educational programs promoting healthy behaviors may attenuate the impact of home 41 confinement in older women.

# 45 **1. Introduction**

The outbreak of coronavirus disease 2019 (COVID-19) is a global public health emergency, responsible for 75,479,471 confirmed cases and 1,686,267 deaths worldwide (data as of December 21, 2020)<sup>1</sup>. Older individuals and those with diabetics, hypertension, and cardiovascular and respiratory diseases are at higher risk of COVID-19 complications and mortality <sup>2</sup>.

Although the measures to contain the spread of the virus (i.e.: social distancing, home 50 confinement, quarantine and/or lockdown) are effective for reducing incidence and mortality of 51 COVID-19<sup>3</sup>, they may result in negative behaviors that have important repercussions for both 52 individual health and global burden of noncommunicable chronic disease (NCDs). For example, the 53 adoption of these measures has been associated with reduced levels of physical activity <sup>4,5</sup>, increased 54 levels of sedentary behavior <sup>4,5</sup>, and a more unhealthy food consumption<sup>4</sup>. Few weeks of these 55 negative behaviors may result in several deleterious cardiometabolic and functional consequences 56 that impact management of NCDs <sup>6</sup>, mainly in older and high-risk populations <sup>6–8</sup>. 57

However, little is known about the effect of measures to contain COVID-19 spread on physical activity levels and health-related quality life (HRQL) of older individuals that are physically active, particularly those who had their group exercise routine interrupted, which may also result in social relation impairments. Thus, our aim was to investigate the effect of COVID-19 home confinement on levels of physical activity, sedentary behavior and HRQL in older women that were previously participating in community-based exercise programs. We hypothesized that home confinement would result in impairments on physical activity, sedentary behavior and HRQL.


## 66 **2. Methods**

#### 67 2.1 Population and Study Design

The present study is a longitudinal, mixed-methods, observational study, assessing older 68 women (age > 65 years) that were previously participating in the Ativa Melhor Idade project. The 69 Ativa Melhor Idade is a university extension program (São Paulo State University [UNESP] at Bauru) 70 that promotes twice-weekly community-based exercise programs and a health-related educational 71 program (i.e.: importance and how to meet the recommended levels of physical activity, to avoid 72 sedentary behavior, and to have good nutritional habits). Participants have their levels of physical 73 activity, sedentary behavior and HRQL assessed before (between January and February 2020) and 11 74 75 to 13 weeks after introduction of societal shutdown, self-isolation and social-distancing measures to reduce virus transmission (June 2020) by State of Sao Paulo (Brazil) government. Inclusion criteria 76 included (1) age > 65 ys, (2) regular participation (at least 60% of compliance) in the Ativa Melhor 77 Idade project for a minimum of six months prior inclusion in the study, (3) to have responded the 78 physical activity/sedentary behavior and HRQL questionnaires during the project annual assessment 79

before beginning of COVID-19 pandemic, and (4) to adhere the government home confinement recommendations to reduce virus transmission. Participants with cognitive impairment who were unable to answer the questionnaires accurately were not included. Participants who did not answer any questionnaire in the follow-up assessment were excluded. A total of 130 older women volunteered to participate in the study, ninety women met the inclusion criteria and were included in the study. However, only 64 women (age =  $72\pm5$  ys; body mass index =  $29.0\pm5.2$  kg/m<sup>2</sup>) responded the questionnaires during follow-up assessment and were included in final analysis (Figure 1).

90 Baseline assessment were performed in the Exercise and Chronic Disease Research Laboratory at UNESP (Bauru-SP, Brazil), during the annual assessment of Ativa Melhor Idade 91 project (between January and February 2020), and included anamnesis (health status and medications 92 used), and measures of physical activity/sedentary behavior (questionnaire), HRQL (questionnaires), 93 anthropometrics (weight, height and body mass index [BMI]), hemodynamics (blood pressure, heart 94 rate and arterial stiffness), functional levels (flexibility, balance, muscle strength and endurance 95 96 performance). Follow-up assessment was performed by a telephone call interview (average duration of 50 min), and included anamnesis (health and behavioral status, medications used, compliance to 97 social isolation/home confinement measures, and participants' perception about the effects of 98 pandemic) and measures of physical activity/sedentary behavior and HRQL. All procedures were 99

approved by the Research Ethics Committee of School of Sciences of UNESP (CAEE
21220919.0.0000.5398) and all participants provided written informed consent.

## 103 2.2 Measurements

Baseline and follow-up assessments were performed by trained evaluators, during the 104 afternoon. Anamnesis and questionnaires were applied in the following sequence: (1) anamnesis and 105 physical evaluations (only at baseline) to characterize the sample profile; (2) levels of physical 106 activity and sedentary behavior (International Physical Activity Questionnaire [IPAQ] short version) 107 <sup>9</sup>; (3) a questionnaire assessing compliance to home confinement and to other preventive measures of 108 virus spread (only during follow-up); (4) a questionnaire assessing participants' perception about the 109 effects of pandemic on daily living activities, health and anxiety, sleep quality, pain, medication use, 110 eating habits, weight, and alcohol and cigarettes consumption (only during follow-up); and (5) HRQL 111 questionnaires (WHOQOL-BREF and WHOQOL-OLD)<sup>10,11</sup>. Weekly time and metabolic equivalents 112 113 (METs)<sup>12</sup> levels of physical activity, as well as the total, domains and facets scores of HRQL were compared between baseline and follow-up. 114

# 116 *2.3. Statistical Analysis*

The Shapiro-Wilk and Levene's tests were applied to test normality and homoscedasticity of 117 the data assessed before and during COVID-19 pandemic (IPAQ and WHOQOL). Paired samples t-118 test and Wilcoxon signed-rank test were used to analyze the differences between pre and during 119 COVID-19 variables in parametric and non- parametric data, respectively. Data are presented in mean 120 ± standard deviation (SD), median (interquartile range) or median (minimum-maximum). 121 Participants' perception about the effects of COVID-19 pandemic are presented descriptively. 122 Statistical software SPSS 17.0<sup>TM</sup> (SPSS Inc., Chicago, IL, USA) was used to perform the statistical 123 analyses. The statistically significant level was considered when P < 0.05. 124

# 126 **3. Results**


127 All participants had at least one comorbidity (hypertension: N = 44; musculoskeletal disorders: 128 N = 28; type 2 diabetes Mellitus: N = 23; dyslipidemia: N = 13; thyroid diseases: N = 6; and heart 129 diseases: N = 6) and were ~81 days in social isolation/home confinement. During the pandemic, all 130 participants reported to leave their homes once a week or once every two weeks to buy food and/or 131 medications. Participants reported several behavioral alterations as a consequence of the social


isolation/home confinement, including sleeping quality (24 participants reported that their sleep 132 worsened, and 28 participants reported to wake up later than normal), and eating habits (22 133 participants reported worsening of eating habits, 31 participants reported weight gain and 11 134 participants reported weight loss). Among the participants who consumed alcoholic beverages (15 135 136 participants), three participants reported decreasing weekly alcohol consumption, and 12 participants reported no change. Among smokers (10 participants), two participants reported an increase in 137 cigarette consumption, and eight participants reported no change. Sixty participants reported to have 138 some kind of pain in their body, where 15 participants reported an increase and 11 participants 139 reported a decrease during COVID-19 pandemic. Fifty-eight participants reported to maintain routine 140 medication consumption, and six participants reported an increase (N = 3) or decrease (N = 3) in 141 142 routine medication consumption.

Participants also reported that COVID-19 pandemic affected very much or completely their 143 physical activity routine (N = 44). Fifty-one participants reported that were exercising regularly 144 during this period, where 44 participants were exercising at home and seven participants were 145 exercising outdoor (public spaces). Among those who were exercising, 29 participants reported to 146 receive professional guidance remotely. The pre vs. during COVID-19 pandemic assessment showed 147 significant reductions in total physical activity (-259 METs/week, Z = -2.32, P = 0.02), as a result of 148 a ~17.0 % reduction in walking (-30.8 min/week; Z = -2.90, P = 0.004) and ~41.8 % reduction in 149 vigorous-intensity activity (-29.6 min/week, Z = -3.93, P < 0.001); however, no significant change 150 occurred in moderate-intensity activity (Figure 2). Sedentary behavior (total sitting time) also 151 increased (2.24 h/week, Z = -3.70, P < 0.001) during COVID-19 pandemic in both week days (1.07 152 h/week, Z = -3.64, P < 0.001) and weekend days (1.54 h/week, Z = -3.48, P < 0.001) (Figure 2). 153

However, HRQL domains and facets did not change during COVID-19 pandemic, except for 158 an improvement in environment domain (Table 1). 159

#### 4. Discussion 164

The main findings of present study were that older women who were physically active prior 165 to COVID-19 pandemic showed substantial reduction in physical activity and increase in sedentary 166 167 behavior during the first months of home confinement. However, there were no significant changes in HRQL, except for a small improvement in environment domain. According to our knowledge, this 168 is the first longitudinal study that investigated the effect of COVID-19 home confinement on physical 169 activity, sedentary behavior and HRQL in older women that were physically active prior to pandemic. 170

Cross-sectional studies has shown that social isolation and home confinement imposed during 171 COVID-19 pandemic reduced the vigorous activities and walking in reduced levels of physical 172 activity and increased levels of sedentary behavior in individuals aged < 65 ys <sup>4,13</sup> In addition, a small 173 qualitative study also suggested that home confinement affected the number of older people who 174 participated in group physical activity programs<sup>14</sup>. The reduced levels of physical activity and 175 increased levels of sedentary behavior in the present study, as well as the high prevalence (69 %) of 176 participants reporting that COVID-19 pandemic affected very much or completely their physical 177 activity routine study, is in accordance with previous cross-sectional <sup>4,13</sup> and qualitative <sup>14</sup> studies. 178 However, it is important to note that the reduction in walking found in the present study (17.1 %) was 179 lower than the reductions in the previous studies with participants aged < 65 vs (34 % to 58.2 %)<sup>4,13</sup>. 180 In addition, the previous cross-sectional studies showed reductions in substantial reductions in 181 moderate-intensity physical activity <sup>4,13</sup>, which did not change in the present study. Although 182 differences in age of the population and in study design may not be discharged as reasons for the 183 lower physical activity reduction in the present than previous studies  $^{4,13}$ , the fact that participants of 184 present study were physically active and participated in an educational program to promote healthy 185 186 behaviors prior to pandemic should be considered. Educational programs promoting healthy behaviors has shown to be effective in improving physical activity <sup>15,16</sup>. Thus, it is possible that the 187 participation in the educational program prior to COVID-19 pandemic may be attenuated the walking 188 and moderate-intensity activity reduction in the present study. Future studies are welcome to confirm 189 190 this hypothesis.

The positive effects of physical activity on HRQL in older individuals are well known<sup>17,18</sup>. 191 In this context, we hypothesized that home confinement due to COVID-19 pandemic would result in 192 reduction of physical activity and, consequently, HRQL in participants of present. However, despite 193 194 reduction in physical activity, there were no significant changes in 10 out of 11 domains/facets of HRQL. The small reduction in physical activity and the prior participation in the educational program 195 may be associated with the no change in HRQL in the present study. It is important to note that, in 196 contrast to our hypothesis, there was a significant increase in environment domain of HRQL during 197

follow-up. This improvement may have occurred because participants felt more secure and protected at home during a pandemic. In addition, as participants of present study were retired women who have no change in retirement salary, it is possible that home confinement resulted in greater savings in financial resources, affecting positively HRQL environment domain during follow-up.

The lack of a comparison group with older individuals who were not participating in physical activity programs and/or an educational program prior to COVID-19 pandemic is a limitation of present study, because it does not allow us to affirm that the present small reduction in physical activity and the no change in HRQL was due to prior physical exercise and/or educational program participation. The measure of physical activity levels by questionnaire, instead of more accurate tools such as accelerometers is also a limitation that should be acknowledged.

208 The present study has also important implications. Low levels of physical activity is associated with innumerous age-related cardiometabolic and functional impairments <sup>6,7,19</sup>. For example, few 209 210 weeks of reduction in levels of physical activity may result in deleterious effects on glycemic control, 211 body composition, inflammatory cytokines, blood pressure, vascular function, cardiorespiratory/muscle fitness, balance and agility <sup>6,7,19</sup>. In addition, reductions in levels of physical 212 activity, as the observed in the present study, may result in increased incidence of NCDs and mortality 213 if persisting for long periods <sup>6</sup>. Finally, it is also important to note that we found substantial increases 214 in the levels of sedentary behavior, which may potentiate the above-mentioned deleterious effects of 215 reduced levels of physical activity <sup>6</sup>. In this context, strategies for promoting adequate levels of 216 physical activity and reducing sedentary behavior during COVID-19 home confinement should be 217 urgently implemented. 218

#### 220 **5. Conclusion**

In summary, home confinement due to COVID-19 pandemic resulted in decreased levels of physical activity and increased levels of sedentary behavior in previously active older women who participate in an educational program promoting healthy behaviors. However, there were no significant changes in HRQL. As the reduction in physical activity was lower in the present study than in previous cross-sectional studies <sup>4,13</sup>, it can be suggested that educational programs promoting healthy behaviors may attenuate the impact of home confinement in physical activity. Future studies addressing this hypothesis are welcome.
