Application of the Weight Self-Stigma Questionnaire (WSSQ) in Subjects with Overweight and

Obesity living in Italy

Abstract

Aims: Although weight-based stigmatization is widespread in everyday life, a suitable measure of weight

self-stigma is currently unavailable for those with overweight/obesity whose primary language is Italian.

The purpose of this study was to translate and test the psychometric properties of the Italian version of the

Weight Self-stigma Questionnaire (I-WSSQ) to administer it to adults with overweight/obesity.

Materials and Methods: A cross-sectional study was conducted on 214 adults with overweight or obesity.

Data including Body Mass Index (BMI), I-WSSQ, and Body Uneasiness Test (BUT) scores were collected

from April the 2nd to July the 6th, 2021.

Results: Reliability was assessed through internal consistency: the Cronbach α of the I-WSSQ was $\alpha = .814$,

indicating good reliability. The exploratory factor analysis revealed a two-factor structure of I-WSSQ (self-

devaluation and fear of enacted stigma, respectively) that explained 49,25% of the total variance. In addition,

the I-WSSQ score directly correlated with BMI and BUT score, indicating an acceptable criterion-related

validity.

Conclusion: The I-WSSQ shows adequate reliability and validity. Health professionals may use the I-

WSSQ to assess the weight self-stigma of adults with overweight/obesity whose primary language is Italian.

Introduction

Obesity is a significant public health problem worldwide, with numbers rapidly growing in Italy as well ^{1,2}. Not only weight excess leads to physical complications, some of which are well established ³⁻⁶ and some others are emerging^{7,8}, but it also substantially affects the psychological^{9,10}, emotional ¹¹ and social dimensions ^{12,13}. The simple imbalance between energy intake and expenditure explains a small part of the obesity pandemic we face, and several other factors, such as endocrine disruptors, epigenetics, infections, increased maternal age, and medications, may play a significant role 14-16. However, to date, the pathogenesis of obesity is far from being fully elucidated, leading to the frequent misconception that weight gain is solely due to the "bad" habits of the individual. In fact, the lives of those with obesity may be disrupted by the multiple forms of prejudice and discrimination to which they are exposed ¹⁷⁻¹⁹: obesity is often seen as dependent on internal factors which are directly controllable, such as the absence of physical activity, overeating, and, more generally, the lack of willpower ^{20,21}, with the consequence that these people are often pointed out as lazy, lacking in intelligence and self-control, less competent and not compliant with medical care and with poor self-discipline ²²⁻²⁴. These stereotypes generate the stigma of obesity and influence social interactions, resulting in a significant psychosocial and depression-related stressor in highincome countries ^{24,25}. Therefore, in recent years, the concept of social stigmatization and its influence on medical and psychological research has gained increasing interest ²⁶⁻²⁸.

Sikorski and colleagues ²⁹ have highlighted how the attribution of obesity to internal factors is the primary source of stigmatization and discrimination of subjects suffering from this condition, leading to less empathy and willingness to support them. The internalization of stigmatizing attitudes and behaviours even by the individual concerned or family members increases the emotional distress, leading to social isolation and psychological deterioration ^{30,31}. Candidates to bariatric surgery also suffer from the same stigma: in a recent study, 87% of bariatric surgery candidates reported being stigmatized due to the choice of undergoing surgery, a decision seen as lack of willpower and "cheating", as opposed to losing weight with more effort through diet and exercise. As a result, over half of the interviewed subjects reported hiding the surgery from at least one person ^{32,33}. Unfortunately, these pervasive stereotypes contribute to prejudice

and discrimination in many areas of daily life, such as employment, healthcare, education, and the media.

Thus, the availability of recent, high-quality data on health-related stigma or self-stigma is critical to improve interventions and programs addressing them, yet such data are often lacking, also due to a lack of assessment tools validated in languages other than English ³⁴. Moreover, patients with obesity living in Italy may differ from those living in English speaking countries for the cultural environment, dietary habits (i.e. Mediterranean diet) and psychosocial characteristics, and self-stigma therefore needs to be evaluated in this specific population with appropriate tools. The Weight Self-Stigma Questionnaire (WSSQ) estimates weight-related self-assessment and stigmatization of people with obesity³⁵. However, it is currently not validated in Italian, making it not applicable to this population.

We therefore aimed to translate the WSSQ into Italian (I-WSSQ) and test its psychometric properties to validate its use in individuals with overweight/obesity whose primary language is Italian.

Methods

Methodology

The WSSQ was translated from English into Italian through the following steps: *Preparation*: we contacted the questionnaire's creator, obtaining written permission to use and translate the tool. *Forward translation*: two freelance translators individually translated the WSSQ into Italian (I-WSSQ). *Reconciliation*: the I-WSSQ was reviewed, and disagreement was reconciled through an expert panel discussion. *Back translation*: the I-WSSQ was back-translated into English by a third translator. Then, two expert panel members reviewed the back-translated I-WSSQ to guarantee the conceptual equivalence of the wording ³⁶.

The local ethics committee approved this study (Prot.: PAR 31.21 (OSS) 31/03/2021). Written informed consent was obtained from all participants prior to enrolment. All the procedures performed in the study complied with the Helsinki Declaration.

Participants

Two hundred fourteen patients whose primary language is Italian, with a Body Mass Index (BMI) ≥25 Kg/m², were enrolled in the study and recruited through consecutive random enrolment lasted three months (from April to July 2021).

Structured questionnaires were used to collect sociodemographic and anthropometric data (age, gender, and the I-WSSQ and Body Uneasiness Test (BUT) were administered in person. The BMI was measured as weight in kilograms divided by the square of height in meters by registered dietitians.

Instruments/ Measures

The current study involved the administration of the self-report questionnaires listed below:

- Italian version of the Weight Self-stigma Questionnaire (I-WSSQ)

As the WSSQ, the I-WSSQ comprises a 12 item Likert-type scale that measures weight-related self-stigma. It consists of two subscales of 6 elements each for measuring weight-related self-devaluation (item number 1 to 6) and fear of enacted stigma (item number 7 to 12), with no reverse-scored items ³⁵. The I-WSSQ asks participants to rate their perception of stigma from others, ranging from 1 (completely disagree) to 5 (completely agree). Total scores are calculated for the two subscales ranging from 12 to 60, with higher scores indicating higher weight-related self-devaluation and fear of enacted stigma.

- Body Uneasiness Test (BUT)

The BUT is a multidimensional self-administered questionnaire for the clinical assessment of body uneasiness in subjects suffering from eating disorders and/or obesity³⁷. It consists of two parts: the first part (BUT-A) includes 34 items, and scores are combined into a global severity index (GSI) and five subscales that evaluate weight phobia, concern for body image, compulsive control, avoidance behaviours and the sense of detachment and depersonalization towards one's body (e.i. Item 1 - *I spend a lot of time in front of the mirror*, or Item 10 - *I make detailed comparisons between my appearance and that of others*); the second part (BUT-B) includes 37 elements and scores are combined into two global measures (total positive symptoms (PST) and positive symptom distress index (PSDI) and eight factors that evaluates specific

concerns regarding various parts of the body and other related aspects such as concerns related to one's smell, redness, sweat and noises produced by one's body (e.i. of my body, in particular, I hate. Item 3- The shape of my face). The score is distributed on a 6-point Likert scale from 0 to 5, where 0 corresponds to never and 5 to always; the sum corresponds to the total BUT score. Higher scores indicate greater physical

In the original validations study, the levels of Cronbach's alpha coefficients range between .64 and .89.

Data Analysis

discomfort.

Similar to the original WSSQ validation process 2 , the internal consistency of the I-WSSQ was assessed using the Cronbach α coefficient. Analyses of the correlation between the scale items were conducted using the Kaiser-Meyer-Olkin sample adequacy measure and the Bartlett test to assess the suitability of exploratory factor analysis. An exploratory factor analysis using principal factor extraction was performed to examine the factorial structure of the scales, the oblique rotation method was used to obtain clear factorial structures and enable comparison with the original study results 33 ; moreover, factor extraction was done with eigenvalues above 1, while estimation method applied was the minimum residual. Finally, also a confirmatory factor analysis has been run.

Finally, a criterion-related validity was examined by performing a correlation analysis between the BMI, BUT-A (GSI TOT and DISTRESS), BUT-B (PST and DISTRESS), and the I-WSSQ. There were no missing data. All statistical tests were performed using the SPSS statistical package (version 25). The statistical significance for the analyses was set at $p \le .05$.

Results

Characteristics of study participants

A total of 214 participants participated in this study: the descriptive statistics of the sample are displayed in **Table 1**. Briefly, 61 males (28.5%) and 153 females (71.%) were enrolled, with an age between

18 and 74 years old, average 46 ± 11 years old. Among these, 15 (7%) had a BMI between 25 and 29, 19

(8.9%) between 30 and 35, 73 (34.1%) between 36 and 40 and 107 (50%) with a BMI \geq 40.

Concerning the education level, four subjects (1.9%) completed primary school, 53 (24.8%) had a

secondary junior school degree, 127 (59.3%) had a high school degree, 30 (14%) had a university degree.

The mean score of each item for the I-WSSQ ranged from 2.03 to 3.78 on the self-devaluation

subscale and from 1.94 to 3.48 on the fear of enacted stigma subscale. The skewness of each item for the

I-WSSQ ranged from -0.73 to 0.85 on the self-devaluation subscale and from -0.50 to 2.11 on the fear of

enacted stigma subscale.

Reliability

Internal consistency measures for both the subscales and the overall scale were sufficiently good.

The internal consistency of the full I-WSSQ was $\alpha = .814$, and for the subscales—factor 1 and factor 2—

internal consistency was α =. 733 and α =. 797, respectively.

Factor Structure

The mean coefficient correlation among the 12 items was 0.23. However, some correlations resulted

low, particularly for items 1 and 2. The Kaiser-Meyer-Oklin value was 0.741, and Bartlett's test of

sphericity reached statistical significance (P<0.00001).

The principal component analysis revealed two components (self-devaluation and fear of enacted stigma)

that explained 33.85% and 15.4% of the variance, respectively. Item 1 did not load, as expected, in factor

1 (**Table 2**). The model fit emerging from confirmatory factor analysis was highly significant (γ^2 53=226.06;

p<0.0000001), with factor loading estimates ranging between 0.39 and 1.13.

The criterion-related validity was examined by performing a correlation analysis between the BMI

and scored of BUT A (GSI TOT, global severity index), BUT B (PST, positive symptom total), and I-

WSSQ: the Pearson product moment correlation coefficients reported in Table 3 indicate acceptable

criterion-related validity.

Discussion

We herein translated and tested the Italian version of the WSSQ for reliability and validity. Compared to the original English version of the WSSQ, with a reported Cronbach α ranging from .812 to .878 (19), the I-WSSQ showed adequate, consistent reliability, comparable to that of the English version, with a Cronbach α value of .733 for the fear of enacted stigma subscale (factor 1) and .797 for the self-devaluation subscale (factor 2). Moreover, the inter-item correlation and item-scale correlation analyses revealed that the I-WSSQ had appropriate congruence constructs. The item discrimination analysis indicated that the items in the I-WSSQ had sufficient discriminating power. Furthermore, present results showed that the I-WSSQ had qualitative items to discriminate between the response levels of different participants.

Regarding validity, Lillis et al. reported that the WSSQ fits the 2-factor extraction closely on the self-devaluation and fear of enacted stigma subscales ³⁵. In the present study, exploratory factor analysis was used to distinguish between the domain structures of the I-WSSQ and the original English version of the WSSQ, and the domain structures were similar. However, the Italian WSSQ loading of the items was consistent with the original WSSQ, except for item 1 (i.e., "I'll always go back to being overweight"), which did not significantly load in any factor. This result may be explained by the enrolment of some candidates to bariatric surgery, who did not expect to regain weight postoperatively.

Raves and collaborators have shown that internalized stigma and general experience of weight-related stigma predicted poorer diet adherence, even after weight loss in postoperative patients ³⁸. While patients do not recognize this correlation, healthcare professionals think it is due to low patients' compliance. The candidates for bariatric surgery likely expect to lose weight after surgery and never become overweight again. Therefore, this data could be read as a factor of tenacity and resilience. However, more work is needed to understand whether weight stigma plays a role in weight loss outcomes among people undergoing bariatric surgery.

The literature confirms that weight stigma not only exacerbates mental health problems but also hinders physical health maintenance ^{25,39}. People with obesity often internalize the weight stigma of others, experiencing psychological distress, including higher body dissatisfaction. This leads to the adoption of behaviours causing weight gain, such as overeating and physical inactivity. It is, therefore, crucial that health professionals assess the weight self-stigma of patients with obesity before any intervention takes place to facilitate the improvement of weight-loss programs ⁴⁰⁻⁴².

This is the first study that aimed to translate the WSSQ into Italian. In this study, we performed basic item analysis and internal consistency analysis, and we also conducted a factor analysis and criterion-related correlation analysis. Overall, these results indicate that the I-WSSQ has good reliability and validity and can facilitate verifying the weight self-stigma of people with overweight/obesity whose primary language is Italian.

The I-WSSQ exhibits acceptable reliability and validity and can be applied to people with obesity whose primary language is Italian, allowing to assess self-stigma in this population, with its cultural, psychosocial, and dietary peculiarities. However, the present study has several limitations regarding generalizability. Although the sample size was sufficient to perform factor and correlation analysis, further analysis of the I-WSSQ requires a larger and more heterogeneous sample. Second, the I-WSSQ is a direct translation of the WSSQ, and further research should detect and compare the impact of different cultures on the scale content.

Conclusions

In conclusion, more attention should be directed to weight-related stigma as a relevant psychosocial factor in obesity-focused prevention and treatment. Therefore, efforts are needed to develop weight stigmatization assessment and measurement tools.

Broadly, this study found that the I-WSSQ has adequate reliability and validity to be used with people with overweight/obesity whose primary language is Italian. Given these acceptable psychometric properties, the I-WSSQ is a valuable tool that enables the rapid assessment of the weight self-stigma within 3 to 5 minutes. Indeed, it could be used to monitor the impact of weight-based stigma and provide helpful

Moreover, it may be a reliable tool to explore the issue of self-stigma in different clinical situations, such as weight loss programs involving bariatric surgery, although further *ad hoc* studies are warranted.
