

## Variants in Interferon Lambda are Associated with Very Early Onset Inflammatory Bowel Disease

## Abstract:

Inflammatory bowel diseases (IBD) are chronic inflammatory disorders of the intestine that affect children and adults. The etiology is multifactorial with the contribution of genetic, immune, microbial, and environmental risk factors with a substantial involvement of host:microbial cross-talk in the lumen. Whether and how antiviral responses contribute to IBD pathogenesis is under intense investigation. Here, we identified two unrelated patients diagnosed with very early onset IBD (VEOIBD) with rare variants in type III Interferons (IFNs), also known as interferon lambdas (IFN $\lambda$ s), a group of IFNs that play key roles in the protection against enteric viruses. The first patient was found to have homozygous variants in both *IFNL2* and *IFNL3*, the genes encoding, IFN- $\lambda$ 2 and IFN- $\lambda$ 3, respectively. The second patient was found to have inherited compound heterozygous variants in *IFNL3*, with one of the two alleles bearing the same variant as the first patient. Functional analyses revealed that the proteins coded for by these variant IFN- $\lambda$  genes exhibited defects in the induction of IFN signaling. More detailed assessment of the variants identified in Patient 1 demonstrated defects in their ability to bind to IFN- $\lambda$  receptor 1 (IFNLR1), as well as their ability to induce heterodimerization of IFNLR1 and IL10RB, which together compromise the functional receptor for IFN- $\lambda$  (IFNLR). These patient-encoded IFN- $\lambda$  variants also exhibit defects in the ability to induce robust downstream IFN-stimulated genes (ISGs) in patient-derived intestinal organoids. All in all, we demonstrate that VEOIBD is associated with variants in IFN- $\lambda$ s and defective induction of downstream IFN signaling.

## Introduction:

Inflammatory bowel diseases (IBDs), encompassing Crohn's disease and ulcerative colitis, are chronic inflammatory conditions affecting the intestines. IBD is now considered a global disease, with prevalence exceeding 0.3% in North America<sup>1</sup>. While most patients are diagnosed in adulthood, IBD also affects infants and young children. Diagnosis before 6 years of age, referred to as very early onset IBD (VEOIBD)<sup>2</sup>, represents the group with the fastest rising incidence of IBD<sup>3</sup>. Overall, the etiology of IBD is felt to be multifactorial with contributions of genetic, immune, microbial, and environmental risk factors.

Large adult-based Genome Wide Association Studies (GWAS) have identified nearly 250 loci that confer significant risk for IBD susceptibility<sup>4-6</sup>. It has been hypothesized that the genetic contribution of VEOIBD is larger than that in patients diagnosed at older ages; currently over 75 monogenic causes of VEOIBD have been identified with many reflecting underlying primary immune deficiencies<sup>7-11</sup>. These advances have not only significantly expanded our understanding of the pathophysiology of IBD but importantly, they also enable personalized and often curative interventions.

Crosstalk between the microbiome and the genetically susceptible host<sup>12-18</sup> is a central factor in the development of IBD. However, recent data has also implicated the *virome* in mucosal homeostasis<sup>19-25</sup>, and interestingly, to date, none of the currently identified monogenic causes of VEOIBD directly implicate defects in viral recognition or clearance. Interferons (IFNs) are most known for their inherent anti-viral activities and protect against enteric viral infections<sup>26-34</sup>. IFNs are divided into three classes: type I IFNs (including IFN- $\alpha$  and IFN- $\beta$ ), type II IFN (IFN- $\gamma$ ) and the more recently identified type III IFNs or IFN- $\lambda$ s (including IFN- $\lambda$ 1-4 in humans<sup>35-37</sup>). Murine models have suggested potential anti-inflammatory functions for type I IFNs within the intestine<sup>38</sup>, and based on this, type I IFNs were assessed for therapeutic efficacy in IBD<sup>39,40</sup>. However, these trials failed to demonstrate therapeutic efficacy; in fact type I IFNs exacerbated intestinal inflammation

in some cases<sup>41</sup>. Recent murine studies revealed potential insight into these failures including opposing effects of type I IFN signaling on individual cell types<sup>42</sup>. Also, type I IFN-dependent ISGylation of proteins produces reactive oxygen species and augments colonic inflammation<sup>43</sup>.

IFN- $\lambda$ s were initially believed to have functions redundant with those of type I IFNs. However, more recent research by our group has established unique characteristics of IFN- $\lambda$ s. IFN- $\lambda$ s can induce signaling in both murine and human neutrophils<sup>44</sup>. IFN- $\lambda$  suppresses the tissue damaging functions of neutrophils and the specific loss of IFN- $\lambda$  signaling in neutrophils exacerbates DSS-induced colitis in mice<sup>44</sup>. This may have important therapeutic implications as the exogenous administration of IFN- $\lambda$  reduces intestinal inflammation, whereas IFN- $\lambda$  blockade enhances intestinal inflammation<sup>44</sup>. Also, it has recently been shown in mice that IFN- $\lambda$  participates in the generation of amphiregulin for regeneration of intestinal epithelium<sup>45</sup>. While previous studies have demonstrated that expression of IFN- $\lambda$  and its receptor, the interferon lambda receptor (IFNLR), are upregulated within the colon of patients with IBD, the effects of IFN- $\lambda$  signaling during IBD development are incompletely understood<sup>46,47</sup>. Nonetheless, IFN- $\lambda$  demonstrates features which support a potential role in protection against intestinal inflammation<sup>48-51</sup>. First, IFN- $\lambda$  belongs to the IL-10 cytokine family and IFN- $\lambda$ s are structurally more similar to the anti-inflammatory cytokine IL-10 than type I IFNs. The IFNLR comprises a heterodimer consisting of IL10RB (shared by IL-10, IL-22 and other cytokines) and IFNLR1, which confers IFN- $\lambda$  recognition. Pertaining specifically to impaired mucosal homeostasis, the absence of IL10RB signaling in innate immune cells results in life-threatening VEOIBD, with a major role for IL-10 signaling residing in phagocytes<sup>52</sup>. Secondly, IFN- $\lambda$ s activate only a subset of the genes that are activated by type I IFNs, with the different signaling capacities of the two IFN groups explained, at least in part, by their activation of different JAK-STAT members<sup>44,49,53</sup> that have been found to be associated to IBD through GWAS studies<sup>54-56</sup>. Finally, the cellular targets of IFN- $\lambda$ s are much more limited and

defined, compared to those of type I IFNs, because the IFNLR1 is almost exclusively expressed on epithelial cells and neutrophils, suggesting tissue-specific functionality<sup>48,57</sup>.

Here, we describe two patients from two unrelated families that have rare variants in IFN- $\lambda$  in association with VEOIBD. Functional studies demonstrate that the variants lead to defects in binding to the heterodimeric IFNLR and induction of IFN signaling.

## **Results:**

### **Clinical presentation of two unrelated patients with VEOIBD**

The first patient, P1, presented with bloody diarrhea in the first months of life. He was formally diagnosed with indeterminate colitis at 1 year of age following endoscopic (**Figure 1A**) and histologic findings consistent with VEOIBD. He also experienced large joint arthritis and intermittent fevers. His disease was well managed on the immune modulator 6-mercaptopurine. The medication was discontinued by 5 years of age but symptoms recurred several years later. Reinitiation of 6-mercaptopurine with adequate levels failed to control disease.

The second patient, P2, presented with bloody stools also in the first months of life. By 1 year of age he was found to have endoscopic (**Figure 1A**) features consistent with VEOIBD. Parents refused medical therapeutic intervention. By 5 years of age, parents report that his condition spontaneously improved with complete resolution of his bloody stools.

### **Variants in interferon lambda are associated with VEOIBD**

To identify potential monogenic causes of VEOIBD, whole genome sequencing (WGS) was performed on P1 and his healthy parents. No rare variants in genes known to be responsible for VEOIBD were identified. Whole exome sequencing (WES) was performed on P2 and his healthy parents and similarly did not reveal rare variants in genes associated with VEOIBD.

To identify potential novel monogenic causes of P1 and P2's VEOIBD, we evaluated the presence of rare variants in genes not currently known to be related to VEOIBD. In P1, we identified homozygous missense mutations in both IFN- $\lambda$ 2 and IFN- $\lambda$ 3, which are arranged in a cluster of IFN- $\lambda$  genes on chromosome 19. The mutation in IFN- $\lambda$ 2 is c.461G>A; p.Arg154His, referred to as "IFN- $\lambda$ 2Var" for the remainder of this manuscript. The mutation in IFN- $\lambda$ 3 is c.383A>G; p.His128Arg, referred to as "IFN- $\lambda$ 3Var1" for the remainder of this manuscript (**Figure 1B and 1C**). The IFN- $\lambda$ 2Var had a minor allele frequency (MAF) of <0.1% in both 1000 Genomes Project<sup>58</sup>



and ExAC<sup>59</sup>. It was reported a single time in a homozygous fashion in ExAC. IFN- $\lambda$ 3Var1 was reported <0.1% in 1000 genomes and ExAC and had never been reported in a homozygous fashion. Both variants were confirmed by Sanger sequencing and present in a homozygous fashion in patient P1 and inherited in a heterozygous fashion in his healthy parents and healthy brother (*not shown*).

In P2, we identified biallelic rare missense variants in IFN- $\lambda$ 3 (**Figure 1B and 1C**); specifically, c.383A>G; His128Arg (i.e., IFN- $\lambda$ 3Var1 identified in P1), as well as c.511G>A; p.Glu171Lys, referred to as “IFN- $\lambda$ 3Var2” for the remainder of this manuscript. The latter missense mutation had a minor allele frequency < 0.1% and was reported 9 times in a homozygous recessive fashion in ExAC. These mutations were confirmed by Sanger sequencing (*not shown*) and found to be present in a compound heterozygous fashion in the patient as illustrated in the pedigree in **Figure 1B**.

Mapping of the mutation on a published crystal structure of IFN- $\lambda$ 3 complexed with the heterodimeric receptor, consisting of IFNLR1 and IL10RB,<sup>60</sup> revealed that IFN- $\lambda$ 3Var1 was situated in a site close to the residues critical for IL10RB binding (**Figure 1D, right panel**). IFN- $\lambda$ 3Var2 is located closer to the binding site of IFNLR1 (**Figure 1D, right panel**). Given the great similarity between IFN- $\lambda$ 3 and IFN- $\lambda$ 2 (which share 96% amino acidic sequence identity)<sup>61</sup>, we mapped the location of IFN- $\lambda$ 2Var on the IFN- $\lambda$ 3-IL10RB-IFNLR1 crystal complex. IFN- $\lambda$ 2Var appeared situated near the binding site of IFNLR1 (**Figure 1D, left panel**).

### **Patient-encoded variants in IFN- $\lambda$ 2 and IFN- $\lambda$ 3 result in reduced activation of interferon signaling**

We sought to determine whether the rare patient-encoded variants in IFN- $\lambda$ 2/3 resulted in defective downstream signaling. Upon binding of IFN- $\lambda$  to the IFNLR, activation of JAK1 and JAK2 or TYK2 results in phosphorylation of STAT1, STAT2 and recruitment of IRF9, and formation of

the ISGF3 complex. ISGF3 binds IFN sensitive response elements (ISREs) and induces a variety of downstream IFN-stimulated genes (ISGs) which confer antiviral activity. To determine the capacity of the patient-encoded variants to induce signaling downstream of the IFNLR, we employed a luciferase reporter assay driven by the ISRE promoter and assessed relative luciferase activity as a proxy for induction of downstream ISGs in 293T cells<sup>49</sup>. Cells were treated overnight with a range of doses of either wild type (WT) or patient-encoded variant IFN- $\lambda$ 2 or IFN- $\lambda$ 3. Patient-encoded variants IFN- $\lambda$ 2Var, IFN- $\lambda$ 3Var1 and IFN- $\lambda$ 3Var2 had significantly reduced signaling as compared to WT IFN- $\lambda$ 2 or IFN- $\lambda$ 3 (**Figure 2A-D, Supp Figure 1A-E**). Importantly, the shared variant IFN- $\lambda$ 3Var1 resulted in negligible downstream induction of signaling (**Figure 2C-D, Supp Figure 1B-C**).

#### **Patient 1- and parent-derived intestinal organoids respond to wild-type but not Patient 1-encoded variant IFN- $\lambda$ 2 and IFN- $\lambda$ 3.**

We have shown that both P1 and P2 harbor variants in IFN- $\lambda$ 2 and IFN- $\lambda$ 3 that display defective signaling in a reporter cell line. To assess whether these defects are conserved in patient-derived intestinal epithelial cells, we focused on P1 and differentiated, as previously described<sup>62</sup>, human intestinal organoids (HIOs) from induced pluripotent stem cells (iPSCs) derived from his PBMCs as well as from his parents. These *in vitro* HIOs were then transplanted in immunodeficient mice, subsequently the epithelium of the transplanted HIOs (tHIOs) were extracted and expanded to facilitate further study. As controls, we also evaluated human intestinal enteroids derived from duodenal biopsies (SI) or colon biopsies (CO) of healthy controls. We then determined whether P1 or P1 parent tHIOs responded to WT or mutant IFN- $\lambda$ s by measuring by qPCR the induction of a set of 3 ISGs, whose mean expression was quantitated as an “ISG score” as previously described<sup>63</sup>. Our data not only confirmed that IFN- $\lambda$ 2 and IFN- $\lambda$ 3 variants are hypoactive (**Figure 2E, Supp Figure 1F**), but also demonstrated that P1 tHIOs responded normally to WT IFN- $\lambda$ 3 (**Figure 2E**).

## **Patient 1-encoded mutations in IFN- $\lambda$ result in altered binding and dimerization of the IFN- $\lambda$ heterodimeric receptor**

To interrogate the basis for the deficient downstream signaling of patient-encoded variants, we sought to determine in P1 whether the IFN- $\lambda$ 2 and IFN- $\lambda$ 3 variants resulted in either altered receptor binding and/or impaired dimerization of the heterodimeric IFN- $\lambda$  receptor. As IFN- $\lambda$  directly binds IFNLR1, and does not bind directly to the IL10RB component of the heterodimeric receptor<sup>60</sup>, we focused our attention on the capacity of WT IFN- $\lambda$ s and variant IFN- $\lambda$ s to bind IFNLR1.

We employed a bio-layer interferometry (BLI)-based receptor binding affinity assay to assess binding of WT IFN- $\lambda$ 2 and P1-encoded IFN- $\lambda$ 2Var to IFNLR1. Reduced binding affinity was detected in the patient-encoded protein ( $K_D$   $2.5 \times 10^{-6}$  M, versus  $2.0 \times 10^{-7}$  M) (**Figure 3A**). The receptor binding affinity assay was also performed with WT IFN- $\lambda$ 3 and the shared patient-encoded IFN- $\lambda$ 3Var1. Compared to WT IFN- $\lambda$ 3, IFN- $\lambda$ 3Var1 had reduced binding affinity to IFNLR1 ( $K_D$   $1.0 \times 10^{-6}$  M, versus  $5.9 \times 10^{-8}$  M) (**Figure 3B**).

Similar to other IL-10 family cytokines, IFN- $\lambda$ s are recognized first by the specific subunit of their dimeric receptor, i.e., IFNLR1. Upon binding to IFNLR1, they recruit and bind to IL10RB. Receptor dimerization is thus the first step to induce signaling. As described above, IFN- $\lambda$ 3Var1 and IFN- $\lambda$ 2Var had reduced binding affinity to IFNLR1. We then sought to assess whether P1-associated variants resulted in impaired dimerization of the IFNLR heterodimeric receptor. We used an IFNLR1/IL10RB dimerization assay (PathHunter eXpress, Europhins DiscoverX Products) in which each component of the heterodimeric receptor is linked to a portion of an enzyme with  $\beta$ -galactosidase activity. Namely IFNLR1 is linked to an enzyme acceptor (EA) and IL10RB is linked to a ProLink (PK) enzyme. Each component individually lacks  $\beta$ -galactosidase activity (**Figure**

**3C**); however, upon cytokine-induced receptor dimerization, a functional  $\beta$ -galactosidase is formed that can hydrolyze a chemiluminescent substrate. As expected from its IFNLR1 binding defect, patient-encoded IFN- $\lambda$ 2Var induced defective receptor dimerization (**Figure 3D-E, Supp Figure 1G**). Patient derived IFN- $\lambda$ 3Var1 induced a severe reduced dimerization of the receptor (**Figure 3F-G, Supp Figure 1H**), consistent with the localization of the mutation in the IL10RB binding region (**Figure 1D, right panel**) and the severe defect in signaling induced by IFN- $\lambda$ 3Var1 (**Figure 2C-D, Supp Figure 1B-C**).

## Discussion:

While an abundance of genetic and functional studies has supported dysregulation of intestinal bacteria in association with IBD, there has been enhanced focus on the contribution of other microbes, and notably viruses, in disease pathogenesis<sup>19-25</sup>. IBD risk polymorphisms have been described (e.g., FUT2 and FUT3) that may regulate the replication of enteric viruses<sup>25,64</sup>. Nonetheless, to our knowledge, no monogenic cause of IBD associated with a specific defect in enteric virus infection has been reported to date.

Here we present two unrelated patients with VEOIBD who inherited rare recessive missense variants in IFN- $\lambda$ s. P1 inherited rare homozygous recessive mutations in both IFN- $\lambda$ 2 and IFN- $\lambda$ 3, while P2 inherited a compound heterozygous mutation in IFN- $\lambda$ 3, and of interest, one of the variants was shared with P1. We provide functional evidence of deleterious downstream signaling of each of the patient-encoded mutations (IFN- $\lambda$ 2Var; IFN- $\lambda$ 3Var1; IFN- $\lambda$ Var2) as evidenced by significantly attenuated dose response curves of generation of downstream ISG activation using a luciferase reporter assay, with the most pronounced deficit identified in the shared variant IFN- $\lambda$ 3Var1. We focused on the patient-encoded variants in P1 and determined that IFN- $\lambda$ 2Var and IFN- $\lambda$ 3Var1 elicit defective induction of ISGs in both patient- and control-thIOs and reduced binding affinity to the IFNLR1 component of the heterodimeric IFNLR, as evidenced by a higher  $K_D$  than in their respective WT proteins. Moreover, we found that IFN- $\lambda$ 2Var and IFN- $\lambda$ 3Var1 result in reduced dimerization of the components (IFNLR1 and IL10RB) of the IFNLR.

Relevance of IFN- $\lambda$  in regulating intestinal mucosal homeostasis has been clearly demonstrated in mice<sup>44,65</sup>. Mice unable to signal through IFNLR1 have enhanced mucosal inflammation and mice devoid of both IFN- $\lambda$ 2 and IFN- $\lambda$ 3 (IFN- $\lambda$ 1 is a pseudogene in mice) have defective mucosal anti-viral responses<sup>65</sup>. Murine norovirus, reovirus, and influenza A virus have enhanced intestinal replication in mice lacking either IFNLR1 or both IFN- $\lambda$ 2 and IFN- $\lambda$ 3<sup>65</sup>. Moreover, exogenous

administration of IFN- $\lambda$  can suppress intestinal inflammation in wild-type mice following DSS-induced colitis<sup>44</sup>. These data are especially supportive of the intestinal disease identified in P1.

It is intriguing that both patients improved significantly over time, as evidenced by the lack of flares and discontinuation of medical therapy by 5 years of age in P1 and the spontaneous resolution of bloody stools in P2 by 5 years of age without any medical intervention. There are several hypotheses that may explain this atypical clinical progression of their VEOIBD. One possibility is that since humans have 4 IFN- $\lambda$  cytokines, the members of the type III IFN family are differentially regulated over time. IFN- $\lambda$ 4 is a pseudogene in a large part of the population<sup>66</sup>, while IFN- $\lambda$ 1, IFN- $\lambda$ 2 and IFN- $\lambda$ 3 are highly homologous (81%-96% at the aminoacid level).<sup>67</sup> It is thus possible that in our affected patients (with defective IFN- $\lambda$ 2 and/or IFN- $\lambda$ 3) the expression of one of the other intestinal IFN- $\lambda$ s (i.e., IFN- $\lambda$ 1) may have compensated for the lack of function. Notably, a recent study by our group has shown that there is compartmentalization of IFN- $\lambda$  expression in the respiratory tract of SARS-CoV-2 infected patients depending on disease severity<sup>68</sup>. Specifically, IFN- $\lambda$ 1 and IFN- $\lambda$ 3 drive protective ISGs in the upper airways of mildly ill patients, whereas critically ill patients express IFN- $\lambda$ 2 and have low ISG expression. Moreover, we demonstrated that different cell types (i.e., epithelial cells vs. phagocytes), preferentially produce specific members of the type III IFN family. The nature of the IFNs produced, the cell origin, and the transcriptional programs initiated by specific members of the IFN- $\lambda$  family will need to be taken into consideration to explain how these IFNs impact health and disease in the human intestine. In particular, while ISGs that are induced by type III IFNs are expressed in subsets of mature enterocytes in the small intestine at homeostasis<sup>69</sup>, a comprehensive understanding of the specific cellular, developmental (e.g., peri-natal versus post-natal), and geographic (e.g., small versus large intestine) landscape of type III IFN expression in the human intestine is lacking.

While we have identified rare IFN- $\lambda$  variants that are functionally deficient in our described patients, it remains to be determined definitively whether these functional deficits relate directly to impaired mucosal homeostasis and development of VEOIBD. These possibilities are not mutually exclusive and require further investigation needs to be pursued.

## Materials and Methods

### Patient identification:

Patients were referred to us at Boston Children's Hospital from offsite centers through the very early onset IBD consortium ([www.veoibd.org](http://www.veoibd.org)). Patients and parents included in this study provided informed consent and assent where applicable. Consent was obtained as per our research protocols as was publication of de-identified information in this work, through our Institutional Review Board (protocol# P00000529). De-identified information was stored on RedCap through the Boston Children's Hospital (BCH) Pediatric Gastrointestinal Data Registry and BioRepository.

### Whole Exome and Whole Genome Sequencing:

Whole Exome Sequencing (WES) was performed in collaboration with Merck Research Labs using an Agilent v5 Sureselect capture kit and Illumina 2500 sequencing technology as previously described<sup>70</sup>. For each sample, paired end reads (2X100 bp) were obtained, processed and mapped to the human reference genome (hg19). We used the BWA mem algorithm (version 0.7.12)<sup>71</sup> for alignment of the sequence reads. The HaplotypeCaller algorithm of GATK version 3.4 was applied for variant calling, as recommended in the best practice pipeline<sup>72</sup>. KGG-seq v.08 was used for annotation of identified variants<sup>73</sup> and in house scripts were applied for filtering based on family pedigree and local dataset of variants detected in previous sequencing projects.

Whole genome sequencing was performed as described<sup>74</sup> using the HiSeq platform (Illumina) with the Burrows–Wheeler aligner, and Picard was used for basic alignment and sequence quality control. The same capture kits and strategies were employed for the genome sequencing as described above for whole exome sequencing.

Next Generation Sequencing data was analyzed by a biostatistician (MF) in conjunction with trained gastroenterologists (JO, SBS). Proband variants were filtered by rare, loss-of-function (LOF) or missense variants inherited according to standard Mendelian inheritance patterns. Rare variants were those with minor allele frequency (MAF) <1% for homozygous, hemizygous, and de novo mutations and <5% for compound heterozygous mutations according to ExAC<sup>59</sup> and the 1000 genomes project<sup>58</sup>.

### **Protein purification of IFN- $\lambda$ 2, IFN- $\lambda$ 3 and patient encoded IFN- $\lambda$ variants:**

Proteins were isolated and purified by two different methods. Both methods yielded comparable results.

First method: IFN- $\lambda$  proteins were expressed in the methylotrophic yeast *Pichia pastoris*. Genes corresponding to IFN- $\lambda$ 2 (wild type and variant R154->H) and IFN- $\lambda$ 3 (wild type and variant 1 H128->R), were synthesized by Integrated DNA Technologies (Coralville, IA) and cloned into PICZa-A with a C-terminal hexahistidine tag and secretion signal from EasySelect™ *Pichia* Expression Kit (ThermoFisher, MA). Following linearization and integration into *P. pastoris* strain GS115, the highest expressing clones were isolated and used for large scale expression. Protein was expressed over the course of 2-3 days at 1.5 mL scale at 30°C in BMMY media (1% yeast extract, 2% peptone, 100mM potassium phosphate pH 6.0, 1.34% YNB, 0.04 mg% biotin and 0.5% methanol) and expression induced by addition of methanol to 1%. Media was harvested and secreted proteins purified by Ni-NTA (GoldBio, MO) after pH adjustment to 7.7. Further purification was done by SP-HiTrap cation exchange column (Cytiva, MA) and buffer exchanged into PBS by Amicon centrifugal filtration (SigmaMillipore, MA). Final purity of constructs was estimated >97% based Coomassie gel and Western blot. Protein concentration was assessed by UV absorbance at 280nm.

Second method: IFN- $\lambda$ 2 and IFN- $\lambda$ 3 and patient-derived mutant constructs were PCR amplified using Phusion GC Master Mix (New England Biolabs, Ipswich, MA) and subcloned into pcDNA4-myc-his-B expression vector (Thermo Fisher, Waltham, MA) using EcoRI and AgeI restriction sites to yield a C-terminal His6 tag. All constructs were verified by Sanger sequencing. Plasmids were propagated in NEB5alpha cells (New England Biolabs) and purified using PureLink Expi Endotoxin-Free Mega Plasmid Purification Kit (Thermo Fisher). His-tagged constructs were expressed by transient transfection in Expi293 suspension cells according to manufacturer's instructions (Thermo Fisher). At 4-5 days post-transfection, the conditioned media was collected and adjusted to 20 mM HEPES, 300 mM NaCl, 20 mM imidazole, and 1X Complete protease inhibitor. His-tagged proteins were bound to cobalt resin (GoldBio, St Louis MO) equilibrated in wash buffer (20 mM HEPES pH 7.4, 300 mM NaCl, 20 mM imidazole), washed with 2 column volumes (CV) of wash buffer, and eluted with 8x 0.5 CV fractions of elution buffer (20 mM HEPES pH 7.4, 150 mM NaCl, 250 mM imidazole). Elution fractions were assayed by SDS-PAGE and Coomassie staining, pooled, and buffer exchanged into phosphate buffered saline using PD10 desalting columns. The concentrations were estimated by absorbance at 280 nm using calculated extinction coefficients of 12865 M<sup>-1</sup> cm<sup>-1</sup> for IFN- $\lambda$ 2 and 11375 M<sup>-1</sup> cm<sup>-1</sup> for IFN- $\lambda$ 3 (ProtParam). Samples were analyzed by gel filtration chromatography for monodispersity and differential scanning fluorimetry for thermal stability.

### **Assessment of ISG activation in response to IFN- $\lambda$ 2, IFN- $\lambda$ 3 and patient-encoded variants:**

293T cells expressing Luciferase under the control of an ISRE promoter<sup>49</sup> were plated at a concentration of 400,000 cells/ml of 293T medium (RPMI medium 1640 1X 500 ml, 1% glutamax, 10% filtered fetal bovine serum (FBS), 1% Pen-strep, 1% non-essential amino acids, 1% sodium pyruvate (ThermoFisher Scientific)) using 100ul per well on a 96-well flat bottom plate in the morning. After adhering to the well, the cells were stimulated with different concentrations of either WT purified protein or patient-encoded proteins. Following overnight stimulation at 37°C,

luciferase activity was quantified the following morning using Bright-Glo luciferase assay system (Promega, Madison, WI) on a Tecan plate reader (Männedorf, Switzerland). For assessment of IFN- $\lambda$ 2 and IFN- $\lambda$ 2Var, experiments were performed in triplicates, at concentrations between 0-1800 ng/ml. For assessment of IFN- $\lambda$ 3, IFN- $\lambda$ 3Var1 and IFN- $\lambda$ Var2, experiments were performed > 3 times, with consistent results at concentrations between 0-200 ng/ml.

### **Assessment of binding of IFN- $\lambda$ 2, IFN- $\lambda$ 3 and patient-encoded variants to heterodimeric IFN- $\lambda$ receptor via bio-layer interferometry (BLI)**

Binding of IFN- $\lambda$ 3, IFN- $\lambda$ 2 and patient derived variants to IFNLR1 was evaluated via biolayer interferometry (BLI) using an Octet RED384 (Fortebio). With BLI, one molecule is immobilized to a Dip and Read Biosensor and binding to a second molecule is measured as a shift in the light interference pattern measured in real time. We first loaded an anti-human IgG Fc Capture (AHC) Biosensor (Fortebio) with 10  $\mu$ g/ml of recombinant IFNLR1-Fc chimeric protein (R&D Systems) for 120 sec in the presence of assay buffer (PBS 0,5% Tween-20). The biosensor was then transferred to a different well containing IFN- $\lambda$ 2, IFN- $\lambda$ 3 or patient-derived variants. A range of concentration was assessed (2 $\mu$ M – 1 $\mu$ M – 0.5 $\mu$ M – 0.125  $\mu$ M – 0.0625  $\mu$ M) and association to IFNLR1 was measured over 300s. Following the association step, the biosensor was transferred in a well containing assay buffer alone and dissociation was measured over 600s. Association curves were normalized based on the signal of the last 2 seconds of the loading step. Dissociation constants ( $K_D$ ) were calculated using the Octet Data Analysis HT Software.

### **Assessment of dimerization of heterodimeric IFN- $\lambda$ receptor:**

As per the protocol for PathHunter eXpress IFNLR1/IL10RB dimerization Assay protocol (Eurofins DiscoverX Products, San Francisco, CA), cells provided in the kit were thawed as per protocol. Increasing concentrations of IFN- $\lambda$ 2 and IFN- $\lambda$ 3 and patient-encoded variants were added to a final concentration of 0 to 500ng/ml. Cells were stimulated for 6 hours at 37°C prior to adding

110ul of PathHunter Flash Detection reagents to each well, as per protocol. Cells were then incubated at room temperature in the dark for 1hr and luciferase was read using a Tecan plate reader (Männedorf, Switzerland).

### **Generation of patient and healthy control human intestinal organoids:**

Induced Pluripotent Stem Cells (iPSCs) were derived from patients' and healthy parents' Peripheral Blood Mononuclear Cells (PBMCs) as previously described<sup>75</sup>. Human intestinal organoids (HIOs) were generated from patient's and control (parents') iPSCs as outlined in McCracken et al<sup>62</sup>. To obtain epithelial only organoid lines, HIOs were transplanted into the kidney capsule of immunocompromised *Nod/Scid/Il-2r $\gamma$ <sup>-/-</sup>* mice and extracted after 8 weeks. The epithelium of transplants were then isolated and propagated as tHIOs, as previously described<sup>76</sup>. tHIOs were maintained in media adapted from Watson et al<sup>76</sup>, consisting of: Advanced DMEM/F12, glutaMAX-I (2 mM), HEPES (10 mM), Wnt, R-spondin, and noggin (WRN) condition media, B27 supplement (1x), N2 supplement (1x), N-acetylcysteine (1 mM), mouse recombinant EGF (50 ng/ml), A-83-01 (500 nM), SB202190 (10  $\mu$ M), nicotinamide (10 mM), [Leu15]-Gastrin I (10 nM), Y27632 (10  $\mu$ M), R-spondin condition media (1x), primocin (100  $\mu$ g/ml), normacin (100  $\mu$ g/ml).

### **Generation of healthy control small intestine and colonic biopsy-derived enteroids:**

Colonic and duodenal biopsy samples were obtained from routine diagnostic endoscopy under Boston Children's Hospital IRB protocol P00027983 and cultured with methods modified from Sato et al<sup>77</sup>. Briefly, crypts were dissociated from colonic and duodenal biopsy samples obtained from age-matched (<3yrs) healthy control individuals. Isolated crypts were suspended in Growth Factor Reduced Phenol Red Free Matrigel (Corning, Corning, NY) and plated as 50 $\mu$ L domes in a tissue culture-treated 24-well plates (Thermo Fisher Scientific, Waltham, MA) with growth factor (Wnt3, R-spondin, Noggin) supplemented media. Enteroids were passaged as previously

described. Briefly, enteroids were passaged by removal of Matrigel with Cell Recovery Solution (Corning) for 30 min at 4°C. After incubation organoids were mechanically dissociated and replated in Matrigel every 4 days.

### **Quantification and Statistical Analysis.**

To compare two groups unpaired t-test were performed. When data did not meet the normality assumption, significance was assessed by Mann-Whitney test. To establish the appropriate test, normal distribution and variance similarity were assessed with the D'Agostino-Pearson omnibus normality test. Dose response curves were fitted with a Richard's five parameters dose response curve. EC50 and area under the curve (AUC) were calculated with GraphPad PRISM software. All statistical analyses were two-sided and performed using GraphPad PRISM software software and are indicated in figure legends. Throughout the paper significant is defined as follows: ns, not significant ( $p > 0.05$ ); \* $p < 0.05$ , \*\* $p < 0.01$ , \*\*\* $p < 0.001$ , and \*\*\*\* $p < 0.0001$ .

## Figure Legends:

### Figure 1: Variants in IFN- $\lambda$ s identified in two unrelated patients with VEOIBD:

**(A)** Colonoscopy pictures of P1 and P2, revealing loss of vascular markings, and numerous discrete aphthous ulcerations throughout.

**(B)** Pedigrees of 2 unrelated patients with VEOIBD and mutations in IFN- $\lambda$ . P1 inherited 2 homozygous (solid color) mutations: One in IFN- $\lambda$ 2 (peach) the other in IFN- $\lambda$ 3 (green). His healthy parents and brother are heterozygous (hatched lines) for each variant. P2 inherited a compound heterozygous mutation in IFN- $\lambda$ 3, including the same variant in IFN- $\lambda$ 3 as does P1 (green), and another (fuchsia).

**(C)** Schematic representation of IFN- $\lambda$ 2 (orange) and IFN- $\lambda$ 3 (blue) genes within chromosome 19 (blue bar on top), illustrating 6 exons (cylinders) in IFN- $\lambda$ 2 and 5 exons in IFN- $\lambda$ 3. Black arrows reflect direction of transcription. The asterisk demonstrates the location of each mutation. Representation is not to scale.

**(D)** 3-dimensional crystalized structure of WT IFN- $\lambda$ 2 and estimated location IFN- $\lambda$ 2Var, extrapolated from WT IFN- $\lambda$ 3 using PyMOL software given that there is no available crystal structure of IFN- $\lambda$ 2 (left panel). 3-dimensional crystalized structure of WT IFN- $\lambda$ 3 and location of IFN- $\lambda$ 3Var1 and IFN- $\lambda$ 3Var2 with respect to its heterodimeric receptor (IL10RB and IFNLR1) using PyMOL software (right panel)

### Figure 2: Patient-encoded IFN- $\lambda$ 2/3 variants have reduced activation of ISGs:

**(A)** Dose-response curve of downstream ISG induction following stimulation with either IFN- $\lambda$ 2 or IFN- $\lambda$ 2Var protein. Normalized relative luciferase units (RLU) shown. Data was normalized to blank wells (no protein).

**(B)** AUC comparison between IFN- $\lambda$ 2 and IFN- $\lambda$ 2Var.

(C) Dose response curve of downstream ISG induction following stimulation with either WT or patient-encoded IFN- $\lambda$ 3 proteins (IFN- $\lambda$ 3Var1 and IFN- $\lambda$ 3Var2). Data was normalized to blank wells (no protein).

(D) AUC comparison among IFN- $\lambda$ 3, IFN- $\lambda$ 3Var1 and IFN- $\lambda$ 3Var2.

(E) Induction of ISGs following stimulation of patient-derived tHIOs with either wild-type IFN- $\lambda$ 3 (blue dots), patient-encoded IFN- $\lambda$ 3Var1 (green dots), or no treatment (black dots). P1 = Patient; HP = healthy parent; Co = colonic enteroids of unrelated healthy control; SI = small intestinal enteroids of unrelated healthy control. (A-D) 3 independent experiments are depicted; each data point is an independent experiment. RLU were normalized to blank wells (no protein) for each independent experiment. Statistical significance for (B,D) was assessed by one sample t (B) and Wilcoxon (D) test.

**Figure 3: Patient-encoded IFN- $\lambda$  variants have reduced IFNLR1 binding and elicit reduced IFN- $\lambda$  receptor dimerization**

(A)  $K_D$  calculated via receptor binding affinity assay (bio-layer interferometry) of wild type IFN- $\lambda$ 2 and patient-encoded IFN- $\lambda$ 2Var to IFNLR1. Mean and SEM of 6 replicates is depicted.

(B)  $K_D$  calculated via receptor binding affinity assay (bio-layer interferometry) of wild type IFN- $\lambda$ 3 and patient-encoded variant protein IFN- $\lambda$ 3Var1 to IFNLR1. Mean and SEM of 6 technical replicates is depicted.

(C) Schematization of dimerization assay.

(D) RLUs reflecting dimerization of IFNLR1 and IL10RB following binding with either IFN- $\lambda$ 2 or IFN- $\lambda$ 2Var.

(E) AUC comparison for dimerization assays of the heterodimeric receptor upon binding of IFN- $\lambda$ 2 or IFN- $\lambda$ 2Var.

(F) RLUs reflecting dimerization of IFNLR1 and IL10RB following binding with either IFN- $\lambda$ 3 or IFN- $\lambda$ 3Var1.



(G) AUCs comparison for dimerization assays of the heterodimeric receptor upon binding of IFN- $\lambda$ 3 or IFN- $\lambda$ 3Var1.

(D-G) Data representing two independent experiments (D, E) or three independent experiments (F, G), each being the average of two replicates. Significance of differences in (E, G) was assessed using a one sample t and Wilcoxon test.

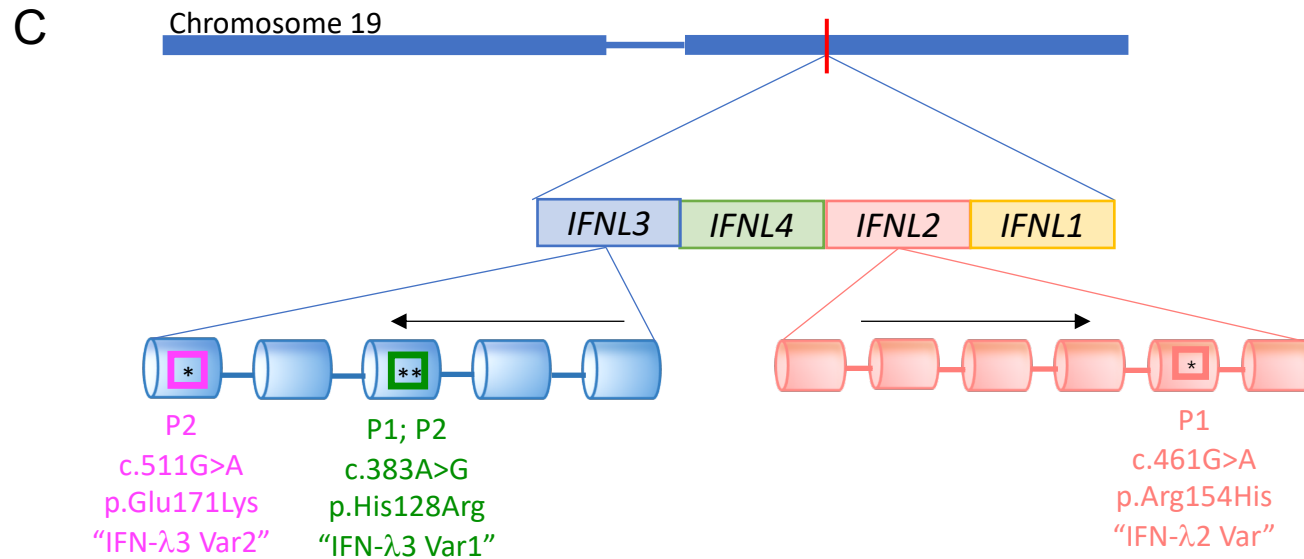
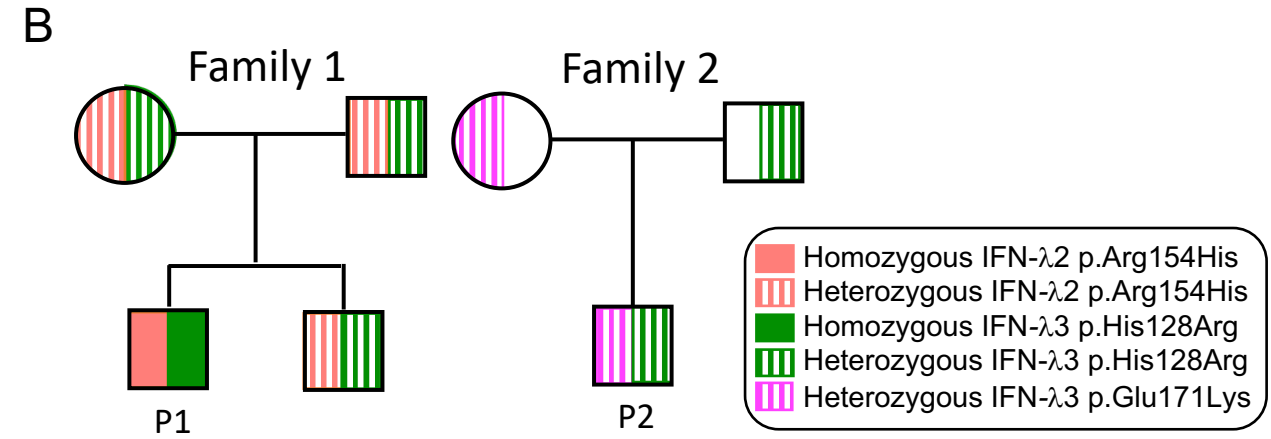
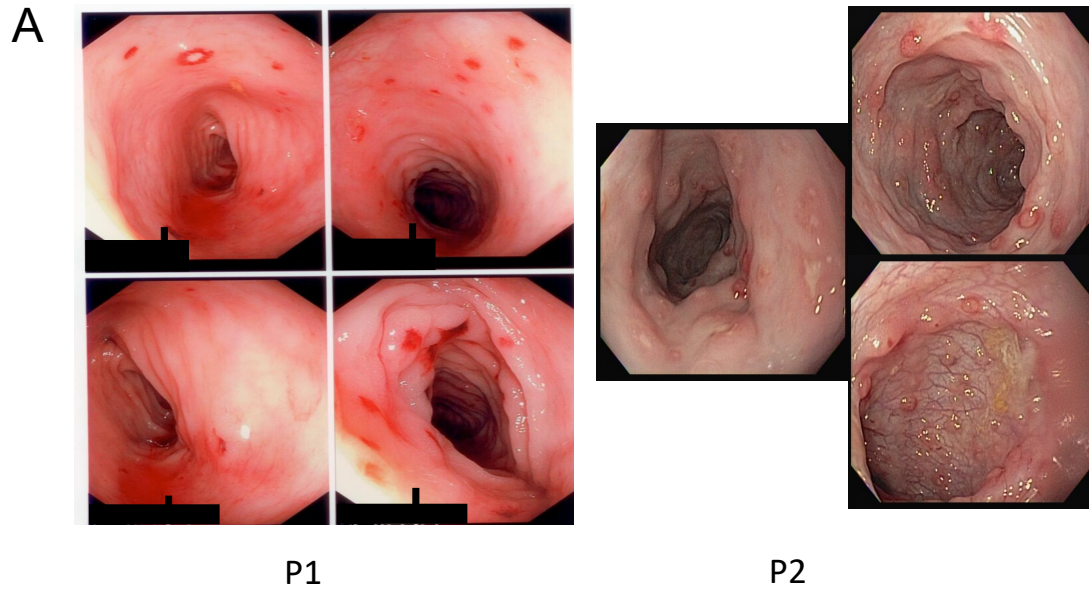

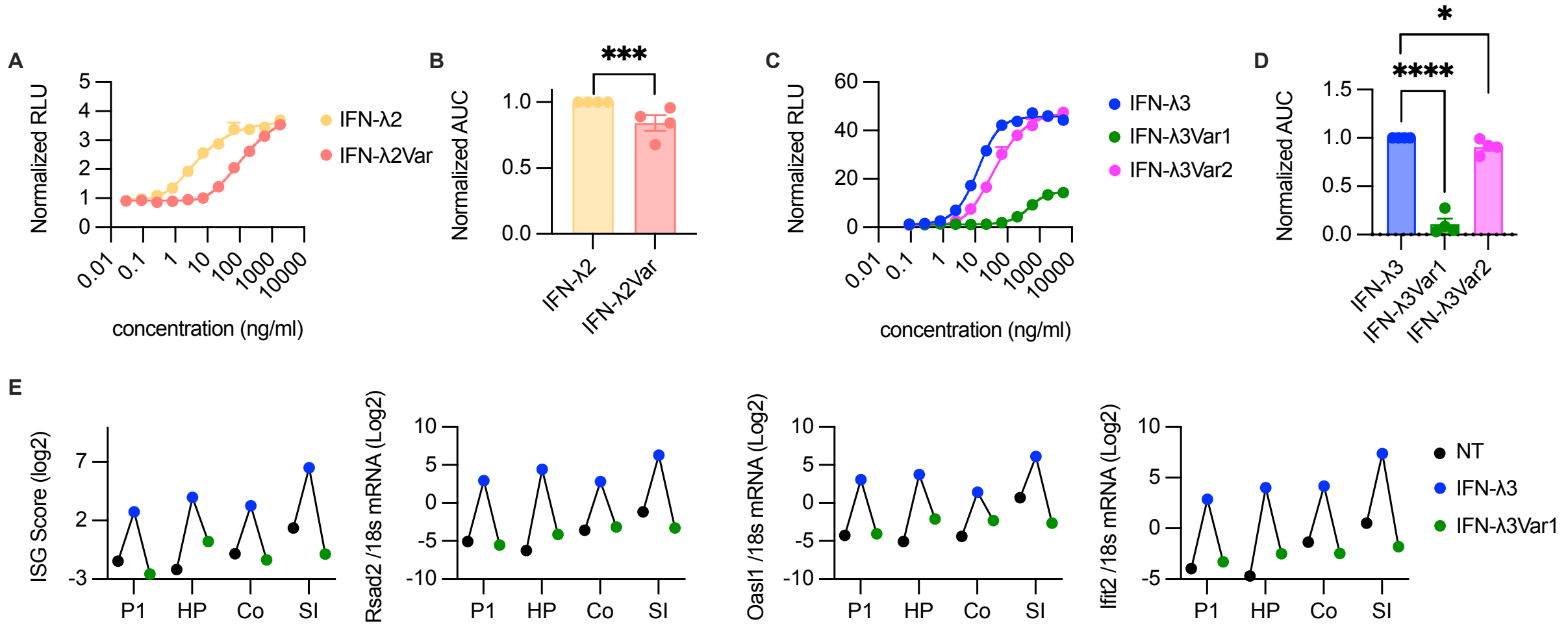
