59 Abstract

Introduction: Adolescents living with HIV (ALWH) experience higher mortality rates 60 compared to other age groups, exacerbated by suboptimal transition from pediatric to adult HIV 61 care in which decreased adherence to antiretroviral treatment (ART) and unsuppressed viremia 62 are frequent. Care transition—a process lasting months or years—ideally prepares ALWH for 63 adult care and can be improved by interventions that are youth-friendly and address psychosocial 64 issues affecting ART adherence; however, such interventions are infrequently operationalized. 65 66 Community-based accompaniment (CBA), in which laypeople provide individualized support and health system navigation, can improve health outcomes among adults with HIV. Here, we 67 describe patient and provider perceptions of a novel HIV CBA intervention called "PASEO" for 68 ALWH in Lima, Peru. 69

70 **Methods:** PASEO consisted of six core elements designed to support ALWH before, during, and after transition to adult HIV care. Community-based health workers provided tailored 71 72 accompaniment for ALWH aged 15-21 years over 9 months, after which adolescent participants were invited to provide feedback in a focus group or in-depth interview. HIV care personnel 73 74 were also interviewed to understand their perspectives on PASEO. A semi-structured interview 75 guide probing known acceptability constructs was used. Qualitative data were analyzed using a Framework Analysis approach and emergent themes were summarized with illustrative quotes. 76 77 Results: We conducted 5 focus groups and 11 in-depth interviews among N=26 ALWH and 9 78 key-informant interviews with HIV care personnel. ALWH participants included those with both

vertically- and behaviorally acquired HIV. ALWH praised PASEO, attributing increased ART
adherence to the project. Improved mental health, independence, self-acceptance, and knowledge
on how to manage their HIV were frequently cited. HIV professionals similarly voiced strong
support of PASEO. Both ALWH and HIV professionals expressed hope that PASEO would be
scaled. HIV professionals voiced concerns regarding financing PASEO in the future.

Conclusion: A multicomponent CBA intervention to increase ART adherence among ALWH in
Peru was highly acceptable by ALWH and HIV program personnel. Future research should
determine the efficacy and economic impact of the intervention.

88 Introduction

settings [5].

HIV is a manageable disease from which mortality should be rare; however, adolescents aged
10-19 living with HIV (ALWH)—about 1.8 million globally [1]—experience worse health
outcomes than other age groups. HIV is the second leading cause of death among adolescents
aged 10-19 years [1-3], and among youth aged 15-19 years, HIV-associated mortality is rising
[4]. For ALWH, becoming an adult is an especially precarious period. This is because, in
addition to the biopsychosocial changes during adolescence, ALWH also transition from
pediatric to adult HIV care and are frequently "lost in transition," especially in low-resource

Care transition is a process lasting months or years, that ideally ensures that ALWH are virally 98 suppressed before, during, and after transition [6]. Achieving viral suppression pre-transition is 99 100 vital; a 2020 systematic review (N=24 studies) of care transition research among ALWH found 101 the worst health outcomes among those with unsuppressed viremia [7]. However, in ALWH, viral suppression rates are disappointing. For example, among a cohort of 1411 U.S. adolescents 102 aged 13-29 years with mostly behaviorally acquired HIV, after a median follow up of 5 months, 103 only 34% were retained in HIV care and started antiretroviral therapy (ART), and just 12% 104 105 achieved viral suppression [8]. Another study among N=401 Spanish adolescents with vertically acquired HIV found that 3.5% (n=14) had died within ten years post-transition [9]. 106 107 108 Knowledge on the factors affecting care transition among ALHW is rapidly expanding [10-16], though data are primarily from Africa, the U.S., and Europe. Nonetheless, the need for 109 interventions that are individualized, youth-friendly, collaborative between youth and medical 110 providers, and responsive to ALWH's mental/psychosocial needs are consistently noted [17-22]. 111 Several studies highlight ALWH's transition experiences, emphasizing attention to issues related 112 113 to becoming an adult (e.g., learning core competencies needed to manage HIV autonomously 114 [23]), and not limited to only ART adherence [24]. Only one review included Latin America

115 [25], but again found that structural- and individual-level barriers (e.g., lack of family support,

116 HIV stigma, poverty, later HIV disclosure), negatively affect ALWH's treatment outcomes.

117

118 Despite the evidence on facilitators of successful care transition, research to improve ALWH's

119 experiences is scant. An approach that enhances HIV outcomes among adults—community-

based accompaniment (CBA)—holds promise [26]. CBA trains lay people to provide support,

education, and assistance navigating the HIV care system. For example, adults living with HIV

in Peru and Rwanda who received HIV CBA had higher suppressed viremia rates and improved

mental and social health outcomes relative to control groups [27-30]; however, CBA for ALWH

transitioning to adult HIV care has not yet been tested.

In Peru, approximately 76,000 people live with HIV, of which 11,000 are aged 15-24 years [31].

127 ALWH in Peru are diverse, consisting of youth with perinatally and behaviorally acquired HIV,

128 young men who have sex with men (MSM), and transgender women; the epidemic is

129 concentrated among the latter two groups, with those aged 19-26 years most affected [31]. Here,

130 we describe ALWH's and HIV provider perspectives of a novel CBA intervention for ALWH

131 transition to adult HIV care in Lima, Peru.

133 Methods

134 **Participants and procedures**

135 During 2019-2021, we pilot-tested a CBA intervention called "PASEO" ('crossing' or 'passage'

in Spanish) implemented by the community-based organization Socios En Salud (SES) in Lima.

137 Building on barriers to ART adherence experienced by Peruvian ALWH [32], PASEO provided

138 CBA to ALWH aged 15-22 years commencing or already taking ART as they prepared for

and/or transitioned to adult HIV care. Adolescents that had already transitioned to but

140 disengaged from adult HIV care also participated.

141

142 The PASEO intervention is described elsewhere [33]. Briefly, PASEO consisted of six core

143 components delivered during a six-month intensive phase followed by a three-month step-down

144 phase. The components were: 1. Health system navigation and clinic visit accompaniment; 2.

145 Social support groups; 3. Screening and referral to mental health services; 4. Resolution of acute

needs (e.g., psychosocial, medical, housing, transportation); 5. Health education and skills-

147 building; and 6. Individualized adherence support, including Directly Observed Treatment

148 (DOT), as needed.

149

ALWH with both vertically- and behaviorally acquired participated, including cisgender males and females, males identifying as homosexual, and transgender females. Some in-person PASEO components were delivered virtually when the COVID-19 pandemic emerged in March 2020, at which point participants had received between 1.4-5.3 months of the intervention [34].

155 An ALWH-comprised Youth Advisory Board gave feedback/suggestions throughout the study.

156 Ethics Committees of the following institutions gave ethical approval for this work: Hospital

157 Nacional Arzobispo Loayza, Lima, Peru [approval number: 11698]; Instituto Nacional de Salud

del Niño, Lima, Peru [approval number: 00213]; Hospital Nacional Hipólito Unanue, Lima, Peru

159 [approval number: 17845]; Harvard Medical School, Boston, United States [approval number:

160 19-0086]. Written informed consent, including permission to publish study results stripped of

161 personally identifying information, was obtained from adolescents ≥ 18 years of age and from

162 guardian(s) of adolescents <18 years with informed assent. Consent was waived for adolescents

aged <18 years without guardians; they provided informed assent. PASEO was registered with

- 164 ClinicalTrials.gov (Identifier: NCT05022706).

166 Data collection

167 Thirty ALWH participated in PASEO, and all were invited to participate in a focus group or in-

depth interview at study completion, conducted by MW, the PASEO study coordinator, and a

169 registered nurse, trained in qualitative research methods. Focus group composition was

170 determined *a priori*, based on participants' shared characteristics (Table 1). In-depth interviews

171 were also conducted among participants for a deeper understanding of their experience.

172 Additionally, we conducted key informant interviews with HIV care personnel (physicians, peer

- 173 counselors, psychologists, program officials).

- 177 The focus groups, in-depth, and key-informant interviews followed semi-structured interview
- guides exploring eight feasibility areas [35] (Table 2). Data collection occurred via video
- 179 conferencing due to COVID-19; for 3 participants, interviews occurred via encrypted text
- 180 messages because they relocated outside Lima and lacked internet. Interviews and focus groups
- 181 lasted approximately 60-minutes, were recorded, transcribed verbatim, and analyzed using
- 182 Dedoose [36].

190 Data Analysis

191 The qualitative analysis team was comprised of two coders (MW and BN) trained in framework

analysis [37]. Analysis began with the coders independently reading and coding five transcripts

using a preliminary codebook derived from the interview guides, adding *de novo* codes as

194 needed. Separate codebooks were created for ALWH and HIV personnel. Next, the team

195 compared the five coded transcripts and harmonized coding by consensus. Reports were

196 generated for each code, and related text across all transcripts was extracted into matrices for

197 granular analysis. Finally, crosscutting themes were identified and reported using illustrative

198 quotes. The Consolidated Criteria for Reporting Qualitative Data Checklist (COREQ) was

199 completed to enhance rigor and transparency (Additional File).

201 **Results**

202 **Participant characteristics**

- 203 Twenty-six ALWH participated in a focus group or in-depth interview (n=15 and n=11,
- respectively); n=4 participants were lost to follow-up/non-responsive to invitations to participate.

- Fifteen (58%) participants were male of which nearly all (93%) identified as cisgender. Most
- 206 (69%) ALWH acquired HIV during early childhood and over half (62%) had a parent die from
- 207 HIV (Table 3).

212 Nine key-informant interviews were conducted with HIV program personnel: three physicians,

one nurse, two peer counselors, two psychologists, and a group home coordinator.

214

215 **Qualitative findings**

For ALWH, qualitative data are organized under two domains, <u>Domain 1</u>: Overall acceptability

and <u>Domain 2</u>: ALWH's experiences with PASEO's six core components. For HIV personnel,

- data are grouped under <u>Domain 1</u>: Opinions of PASEO and <u>Domain 2</u>: Post-PASEO
- recommendations. Each category, theme, and sub-theme (as applicable) is presented with
- 220 illustrative quotes. For adolescent data, the attributions following the quote include focus group

- or in-depth interview (FG or IDI) and participant experience type (per Table 1, A, B, C, D, E).
- For HIV professionals' data, due to their small number, quote attributions do not include job role
- to preserve anonymity.

225 Adolescents

226 Domain 1, Experiences during PASEO - Overall acceptability

- 227 Likes: Overall, participants were positive about PASEO, repeatedly reporting feeling that
- PASEO was effective, and built camaraderie among ALWH. One participant stated, "If I had not
- [enrolled in PASEO], I would still be without treatment; of that, I am sure" (FG, A). Another
- 230 participant summed up their experience in three words: "When I think of PASEO, the three
- words that come to mind are]: community, teaching, help. Teaching because they taught us many
- things, things that I didn't know. Community because the program connected us with other

233 people just like us" (FG, B).

234

ALWH emphasized the social support aspect of PASEO; this participant found that PASEO had arrived at just the right time in their life:

- ...to be honest, I could say that I was totally lost—disoriented—and I didn't know how I
 was going to do it. Sometimes, I got so low that I felt horrible, but knowing that I had
 someone who supported me, that helped me, emotionally more than anything, that was
- 240 what I needed most at that time. (FG, E)
- 241 PASEO also had the impact of reducing social isolation, wherein new acquaintances were
- 242 nonjudgmental, and anything could be discussed without fear:
- 243 ...before [PASEO] I just stayed in my living room alone. But then I met new people and
 244 felt free to talk about things and not be judged, like any topic. They didn't judge you
 245 when you said something, whether it was right or wrong." (IDI, C)
- 246

Dislikes: Dislikes were logistical in nature, relating to the time required to participate in PASEO or the pivot to virtual activities when COVID-19 emerged. One participant found difficulty with the group sessions due to academic commitments, stating, "What I didn't like about PASEO was that the sessions didn't adapt very well to my schedule that I had to have for my virtual classes" (IDI, E). Another participant disliked the virtual sessions due to COVID-19: "The only thing I

252	didn't like was the pandemic, because due to the pandemic we couldn't meet in person, and
253	everything was virtual. [] I liked [PASEO] before the pandemic a thousand times more" (FG,
254	C).
255	
256	Another issue with virtual activities, necessary due to COVID, was related to technical problems
257	such as limited access to Wi-Fi or cellular data. One participant voiced, "Well, [I didn't like]
258	participating with video because sometimes my phone's megabytes would run out quickly, and
259	then I couldn't use it. After my data ran out, I had to use my neighbor's Wi-Fi when I wanted to
260	[] get into the [online support group]" (IDI, B).
261	
262	Intervention duration: When participants were asked their opinion regarding the duration of
263	PASEO, a consistently stated preference for a longer intervention period emerged, though some
264	participants voiced support for a variable length intervention responsive to the needs of the
265	adolescent. In this example, the ALWH used their own experience of sub-optimal ART
266	adherence to make the case for individualized duration of support:
267	I didn't take the pills, or if I took them, I took them every other day; I forgot at night or
268	in the morning because I had other things to do. I thought about other things and that's
269	why, right? [] I don't know, I guess like [another participant] said, [the duration]
270	depends on the person that needs the support. (FG, D)
271	
272	Recommendations specifically for a longer intervention duration were often framed in the
273	context of having more time to form/maintain social bonds with other PASEO peers, and some
274	participants expressed sadness that PASEO had ended:
275	thinking about being close to finishing the project really affects me a lot, because I love
276	the meetings that we have. I listen to everyone and compare myself to each person, and I
277	realize that I'm not the only person who has suffered or had those thoughts, and I like
278	that. (FG, A)
279	Another participant expressed, "the end of the project is painful, and it's a little sad. But the
280	truth is that the times that we've had have been really, really good" (FG, A).
281	

282 Domain 2: Experiences with the 6 PASEO core components

283 **Component 1 - Health system navigation and clinic visit accompaniment:** Participants praised the support received from the health promoter ("promotora" in Spanish), with three 284 285 interrelated themes emerging: immediate assistance and training; attenuating prior bad experiences with the health system; and ongoing, trust-based working relationships. This 286 287 participant notes how she learned to make clinic visit appointments on her own: [My promotora] was like a guide. For example, with the [health insurance program] she 288 told me, 'Look, you have to be there early, you have to be persistent, and explain your 289 situation well.' When it was time to make appointments [...] she made me do it so that I 290

would know what to do. Then if they didn't give me the appointment or if I couldn't

make the payment, she would show up and fight with who she needed to get the

292

appointment. (FG, A)

For another participant, accompaniment appeared to buffer against previous bad experiences 295 with the health system, restoring respect by health personnel: "... [in the hospital where I receive 296 care] everyone treated me really poorly the several times that I went alone. I recently went for a 297 family planning visit, and the doctor treated me as if I was from another world. But when you 298 have company, they respect you a little more" (FG, B). Feedback from one adolescent echoed the 299 common view by ALWH that the community health workers were more than project staff; they 300 were trusted friends who stood by their side, saying, "I am very grateful because [my promotora] 301 302 was there with me even though I refused to go back to my treatment. She was there with me until 303 I became undetectable, and I owe it all to her because she was there not only as a worker, but as 304 my friend" (FG, A).

305

Component 2 - Social support groups: Participants spoke profusely of the value of PASEO's
support groups; however, there were disparate views on group composition. Some participants
felt that groups comprised of all ALWH (regardless of sex, gender, and HIV acquisition route)
was a strength because they could learn from others with similar but different experiences:
"...I learned a lot, like at least one thing I feared was not being able to have a baby, and there I
learned that I can have one, because there were several guys, several girls [diagnosed with HIV]

that had a baby" (IDI, E).

313

314 Participant: "I liked how [the groups] were, I liked the group that I was in. We had great 315 conversations, and we became friends." 316 Interviewer: "So [you liked the] varied groups, with men, women, vertical transmission, or others." 317 318 Participant: "We're all the same." (FG, B) 319 320 In contrast, some participants felt that grouping ALWH with similar experiences could be 321 beneficial, for example, those just starting HIV treatment: ...for me, it would have been a little better if it had been the same people, those like me, 322 to see that they were going through the same thing. Those that had just started treatment 323 and things like that. Then, there'd be more things we have in common because, I don't 324 know, you get to help them faster and they can help themselves too. (FG, E) 325 326 327 **Component 3: Screening and referral to mental health services:** ALWH unanimously praised the PASEO's emphasis on mental wellbeing, often framing their experiences in the context of 328 personal growth and acceptance of living with HIV—even as a transformative experience—as in 329 this example: 330 [The psychologist] asked me, 'Have you really accepted yourself as you are, have you 331 really accepted yourself?' And that's when it struck me, I felt bad at that time, and I left 332 333 the question there in the air, meditating on it for a while, realizing what the problem was. That was the problem, no? That I didn't really accept my diagnosis, I hadn't come to 334 335 terms with the fact that I was an HIV carrier, that I have had to live this life. (IDI, A) 336 337 Another participant spoke of a traumatic past of being bullied, and how PASEO helped them develop self-acceptance: "I grew up getting bullied a lot, you know, they bullied me a lot and 338 339 then made me angry at what I have, until I got here and learned many things from the people 340 here and accepted what I have" (FG, B). 341 **Component 4 - Resolution of acute needs**: Participants spoke positively about the support they 342 received, again echoing a special connection with their promotora, and their ability to assess and 343

address adolescents' acute needs that impacted ART adherence, as for this participant who washomeless:

...I was going to die because I was on the street, and I was going to [northern Peru]. [...]
[The PASEO team] took me to the hospital and that's where I also learned about the
project. They saved my life because at that point I wasn't thinking about starting my
medication again. (FG, A)

350

351 Component 5 - Health education and skills-building: For this core element, participants' 352 experiences overlapped with thematic content for mental health and social support as they related 353 to personal growth. In the following example, a pregnant ALWH spoke about learning how to 354 manage her specific health needs, and with Component 1, also practiced self-directing her care:

- ...when I was pregnant and had to go to hematology, I didn't know much about what
 that was for. [My promotora] sometimes asked the doctor questions, and the doctor told
 her about my hemoglobin, about what I must take, and those things. [...] I usually kept
 quiet but ever since I saw [my promotora] ask the doctor questions and things like that,
 about her doubts, well, now I sometimes ask the doctor questions too. I learned that from
 her, how to speak to the doctor, because I was practically always mute in the hospital.
 (FG, C)
- 362

Component 6 – Individualized adherence support with directly observed treatment (DOT):
 For participants that required additional adherence support, and received DOT, their experiences
 were characterized as both a reminder to take ART and as an exercise in learning personal
 responsibility for ART adherence:

367 ...in my case, sometimes I didn't take my medication because I forgot to, or I lost track of
368 time. So then with the lady [from PASEO] 's calls on WhatsApp, I knew that at 8:00 PM
369 I had to take my pill, from my first call and on. So now, like all the other girls and guys
370 here, I think it's one's own responsibility. (FG, D)

371

In the following example, DOT—and the experience of being confronted by the CHW for nonadherence—was even framed as a reminder and also an act of support:

... I was very forgetful, I forgot to take my pills, I forgot my appointments, I forgot
everything. [...] More than anyone, the lady [from PASEO] helped me because she
yelled at me every time I forgot, well she chided me. She would ask me why I forgot, and
she chided me every time I forgot. I felt that she cared about me more than anyone else,
more than my family. (FG, B)

381 HIV Personnel

382 **Domain 1: Opinion of PASEO**

Overall acceptability - Improved contact with HIV care system: When asked about their perception of PASEO, HIV program personnel similarly spoke in positive terms and gave concrete examples of how the intervention affected ALWH. One observation made was that PASEO kept ALWH engaged with the health system, filling a "void" within the HIV care system, as this physician articulated:

- We've heard good things about the project, from participants' family members, and we've also seen that with several of our patients, especially the difficult ones, it's been possible to keep them connected with the health system. That's really good for us because there's not a system within the hospital that does that. There's a void there,
- really, and [PASEO] has come to fill it. (Participant-7)

A peer counselor felt that PASEO helped ALWH manage their care independently, saying,

³⁹⁵ "[PASEO was] guiding them to be able to do things on their own, because they didn't even have

a clue how to get to the hospitals. And now, they've restarted the treatments that they weretaking before" (Participant-3).

398

What worked - Personalized accompaniment: As with ALWH participants, HIV personnel
also emphasized the benefit of tailoring the level of support to the adolescents' needs, especially
when transitioning from pediatric to adult care:

402 ...for those who left [pediatric HIV services] to go to the other adult hospitals, [PASEO]
403 has been really important because of the accompaniment provided. I know that each of
404 them was given personalized support, because when you get to the adult hospital, it's

405	different, right? There is no one there to guide you, to support you, nothing.
406	(Participant-3)
407	The tailoring aspect, it was felt, "humanized" ALWH, suggesting that PASEO went beyond
408	health aspects to include social and educational support, too: "The most important thing [in
409	PASEO] is that we are seeing the life of a human being—right? —in all its context, not only
410	health, but also the social part, the educational part, [as well]" (Participant-1).
411	
412	Support groups: Likewise, feedback from HIV personnel was overwhelmingly positively about
413	PASEO's support groups; however, there was one respondent who noted the potential that
414	ALWH could also be exposed to other adolescents with undesirable behaviors: "But on the
415	negative side, [in the social support groups, ALWH] probably have access to all kinds of people
416	and could end up falling into risky behaviors" (Participant-4).
417	
418	What did not work or was lacking - Including parents/caregivers in PASEO: No aspect of
419	the intervention elements was noted as faulty; however, one respondent felt that PASEO could
420	be strengthened by including ALWH's parents in the intervention:
421	I am very concerned about the fact, I believe, that there is no consistent work with
422	parents [], because there are cases that I saw where parents did not really support the
423	child or the children [], and when there were in-person group meetings, I don't
424	knowI feel that there should have been work with [the parents] because they are the in-
425	home support [for their adolescent], right? (Participant-6)
426	
427	Intervention duration: HIV personnel also believed that PASEO would benefit from a longer
428	duration, as in this recommendation from a physician who felt that PASEO should last years:
429	I think that clearly a year is pretty short, perhaps as long as it takes [is the ideal amount
430	of time]. We could say that in this most critical time in adolescence, maybe, I don't
431	know, 3 years, or if overdoing it, maybe 5 years. I don't have the answer, but it seems to
432	me like one year is not enough to be able to guarantee long-term continuity of care.
433	(Participant-9)
434	

435 However, the feasibility of extending the intervention if it were financed by the HIV program 436 was doubted by another HIV care personnel. Still, even a shorter duration of 6 months was felt to 437 have benefit: ... for the Ministry of Health, I highly doubt that they would want to do it for a year, and I 438 really doubt that they would suddenly accept a full year. They would probably do fewer 439 months, but really, I think that even six months would be enough, and quite important for 440 the patient. (Participant-2) 441 442 **Specific to DOT:** DOT, which was delivered in-person pre-COVID and transitioned to 443 telephone and video delivered DOT ("teledot"), garnered differing opinions. On the one hand, 444 some personnel felt that teledot was a strength and should be considered as a HIV program 445 initiative, apart from PASEO: "...well, what actually caught my attention was teledot. It was a 446 really good strategy that we also should do, apart from this project. Seeing the experience and 447 good results that you've had, I think we should do it" (Participant-2). 448 449 450 On the other hand, others emphasized the importance that DOT be temporary, as it was in 451 PASEO, given the chronic nature of HIV: 452 HIV treatment is for life, so thinking about DOT doesn't make much sense, except in a 453 very conjunctural situation. But really, treatment and counseling must be the aim, they 454 must be incorporated into the lifestyle of someone living with HIV, and that's their 455 responsibility. (Participant-9) 456 **Regarding COVID-19:** When asked about how COVID-19 affected PASEO, HIV personnel 457 458 spoke more generally about the added stress that the pandemic placed on Peru's HIV treatment program, including hospital closures, medication stock-outs, and related structural issues. In this 459 460 sense, respondents felt that PASEO somewhat shielded ALWH from the negative impact of COVID-19 on the HIV care delivery system. One participant expressed, "...during the pandemic, 461 462 some days they didn't have access to medication [collection]. But because of the support from this project, they managed to continue taking their medications" (Participant-1). 463

464

465	Domain 2 - Post-PASEO, opinions, and recommendations: When asked about the future of
466	PASEO, specific to scaling up, two issues arose: who would implement the intervention and how
467	it would be paid for.
468	
469	Doubt that the public health system would implement PASEO: Concern from HIV personnel
470	regarding the public health system's ability to implement PASEO was expressed; however, the
471	concern appeared less of a budgetary issue and instead related to implementation capacity of the
472	public health system:
473	[Implementing PASEO is] going to depend on several factors, but what is clear is that it
474	can't be [part of the public health system's] services. It must be an external group that
475	intervenes. In what capacity, we'll have to see, and we'll see what the budget will be as
476	well (Participant-9)
477	
478	Another HIV care personnel believed that implementation would need to encompass all hospitals
479	that ALWH could transition to:
480	more than anything we'll have to see the resources, funding, to be able to have staff
481	that do the accompaniment part, because that should be done in practically all the
482	hospitals that care for adolescents and then transition them to adult hospitals.
483	(Participant-3)
484	
485	Finally, a concern arose regarding the potential for low-quality implementation of PASEO and
486	the potential negative consequences for ALWH:
487	maybe I'd worry that [the public health system] doesn't know how to do [implement
488	PASEO] properly, and there's a lot of attrition; the kids could lose confidence pretty
489	quickly. So, if they do it and do it poorly, people are going to leave. They're going to stop
490	following up and stop taking their pills, stop taking their treatment, you know. And that's
491	a big risk. (Participant-6)
492	Discussion
493	We found that a novel CBA intervention to support ART adherence among ALWH in Lima,

494 Peru—PASEO—was highly acceptable to both ALWH and HIV personnel. Among adolescents,

tailored accompaniment and social support groups were especially favored and characterized as
emotionally and psychologically transformative. Notably, even participants that engaged less
with the intervention found PASEO valuable. Likewise, HIV personnel spoke positively about
PASEO, citing favorable experiences they heard from their adolescent patient-participants.

PASEO aimed to improve unsuppressed viremia among ALWH (33); accordingly, the 500 501 intervention focused on identifying and resolving ALWH's ART adherence barriers. However, 502 when ALWH spoke about PASEO, responses invariably centered on how each core element 503 made them *feel* rather than the activity itself. ALWH frequently reported improved selfacceptance as they developed emotional bonds with other ALWH. PASEO's core components 504 appear aligned with the psychosocial stage of development "identity versus role confusion", in 505 which adolescents form their self-image and sense of direction in life, and in doing so, benefit 506 from greater self-confidence, independence, and an enhanced ability to authentically relate to 507 508 others [38].

509

510 DOT for HIV has yielded mixed findings among adults [39], but in PASEO, ALWH framed DOT as supportive and caring training for independent ART adherence rather than observed 511 512 verification of medication ingestion. This finding corroborates a study among Peruvian adults 513 with HIV that reported perceived psychosocial outcomes as the primary benefit of DOT [40]. In 514 that study, the stress buffer theory—which posits that community support mitigates perceptions of threat and improves both clinical and psychosocial outcomes—may explain the process by 515 516 which PASEO participants benefited from DOT [40, 41]. Further, our findings appear to support the positive impact found in a study of community-based DOT for youth with HIV in which 517 518 adolescents experienced reduced depression and increased coping skills [42].

519

No negative aspects of PASEO's core components were reported; however, one perceived deficit
was a lack of interaction with ALWH's parents and/or caregivers. While PASEO implicitly
included ALWH's parents/caregivers, it may benefit from more explicit involvement in
adolescents' support network, and research supports involving parents to enhance ALWH's ART
adherence [32, 43]. However, we note that even in our small sample of ALWH, over half had

lost parent(s) to HIV. Therefore, while PASEO might benefit from the option of a
parent/caregiver component, our emphasis on the adolescent appears to have been appropriate.

We were interested to understand differences in perceptions of PASEO between ALWH with 528 529 early childhood and recent HIV. Practically speaking, most ALWH in Peru with behaviorally acquired HIV will also identify as a sexual and/or gender minority (SGM) [44-46] and may 530 531 experience issues distinct from non-SGM and/or ALWH living with HIV from birth [47]. While there was the suggestion that separate groups for vertically vs. behaviorally (in this case, 532 recently) acquired HIV could help to share common experiences more easily, overall, ALWH 533 were grateful to hear experiences different than their own and endorsed the mixed-group 534 approach. None of the SGM reported feeling marginalized, information which could have 535 emerged during the individual interviews. This finding might be explained by the balance 536 between individual CBA tailored to each ALWH's specific needs and the support groups which 537 focused on themes that most ALWH could relate to regardless of their background. From an 538 implementation perspective, forming groups with open membership may be easier than multiple, 539 540 membership-specific groups in certain settings; further research should explore the pros and cons 541 to both approaches.

542

If PASEO is found to be efficacious in optimizing ART adherence among ALWH, its impact will be constrained unless it can be adequately scaled. HIV personnel voiced concerns regarding financing the intervention and had discrepant views on its duration. These findings speak to future research steps for PASEO, including economic analysis but also enhanced calibration of the dose of PASEO needed to achieve optimal outcomes.

As a pilot study, our findings are limited to the experiences of the study participants and cannot be generalized to all Peruvian ALWH. Though great effort was made to recruit a highly diverse group of adolescents, the sample lacked broad representation of transgender individuals. Future iterations of PASEO and the ability to extend its generalizability will benefit from greater participation by SGM.

554

Conclusions 555 556 A multicomponent CBA intervention which addresses physical, mental, reproductive, and 557 psychosocial wellbeing to support ART adherence among ALWH in Peru was highly acceptable. 558 Future research should determine the efficacy and economic impact of the intervention. 559 560 **Competing interests** 561 The authors declare that they have no competing interests. 562 563 564 **Authors' contributions** 565 566 MFF conceived the study.
