WHEN SEX MATTERS: A COMPARATIVE GENERALISED STRUCTURAL EQUATION MODEL (GSEM) FOR THE DETERMINANTS OF STUNTING AMONGST UNDER-FIVES IN UGANDA

1 Abstract

- 2 The main aim of this study was to establish the differences in both the determinants of stunting
- 3 and the causal mechanism through which the identified determinants influence stunting amongst
- 4 male and female under-fives in Uganda. Literature shows that male children below the age of five
- 5 years are at a higher risk of being stunted than their female counterparts. Specifically, studies in
- 6 Uganda indicate that being a male child is positively associated with stunting while being a female
- 7 is negatively associated with stunting.
- 8 Data for 904 male and 829 female under-fives was extracted form UDHS-2016 survey dataset.
- 9 Key variables for this study were identified and used in generating relevant models and paths.
- 10 Structural equation modeling techniques was used in its generalized form (GSEM). The
- 11 generalized nature necessitated specifying both the family and link functions for each response 12 variables in the system of the model. Sex of the child (b4) was used as a grouping factor and the
- height for age (HAZ) scores were used to construct the status for stunting of under-fives.
- 14 The estimated models and path clearly indicated that the set of underlying factors that influence
- 15 male and female under-fives respectively were different and the path through which they influence
- 16 stunting were different. However, some of the determinants that influenced stunting amongst male
- 17 under-fives also influenced stunting amongst the female under-fives.
- 18 To reduce the stunting problem to the desirable state, it is important to consider the multifaceted
- 19 and complex nature of the risk factors that influence stunting amongst the under-fives but more
- 20 importantly consider the different sex specific factors and their causal mechanism or paths through
- 21 which they influence stunting.

22 Introduction

23 Low height-for-age in children also known as child stunting is one of the most important indicators

of child's wellbeing and health. The broad belief is that stunting just like other forms of child

- 25 malnutrition is associated with household's poor socioeconomic status, poor maternal health and
- 26 nutrition during and after pregnancy, frequent illness of the child, inappropriate infants and young
- 27 child feeding and care practices, unpleasant environmental conditions and child inherent factors.
- At a point of inception, a child's life starts, as thus poor nutrition during pregnancy and early
- childhood may be a major cause for poor growth. Stunting may go a long way beyond the child's
- 30 height-for-age defects to cognitive impairments (1) and this situation puts them at a disadvantage
- 31 of performing well during their education career and also leads to poor performance at work (2).
- The potentially irreparable physical and neurocognitive damage that accompanies stunted growth is a major obstacle to human development in later years of life (2). Stunting increases the frequency
- is a major obstacle to human development in later years of life (2). Stunting increases the frequency
 of illness and is likely to increase the risk of death (3). Moreover stunting is a cyclical process
- because women who were themselves stunted in childhood tend to have stunted offspring, creating
- an intergenerational cycle of poverty and reduced human capital that is difficult to break (4).

By the year 2020, the estimates for stunted under-fives stood at 149.2 million which accounted for 37 22% of all the children under the age of five years worldwide (5). It is a global public health 38 concern and disparities in its distribution world over should be given attention. Continental, 39 40 regional and country level variations do exist and this calls for different strategies and efforts to deal with the problem. Out of the 149.2 million stunted under-fives world over, 41% live in Africa 41 while 53% live in Asia by the estimates of 2020 (5). Africa is a special case because as the number 42 of child stunting is reducing elsewhere, stunting in Africa has actually increased from 54.4 million 43 in 2000 to 61.4 million by 2020 (5). With estimates above 30%, East Africa is among the region 44 with the highest levels of stunting in Africa (5) and this is not different with Uganda whereby about 45 3 in every 10 children are stunted. 46 Globally, sex of the child has been found to be one of the factors influencing stunting among the 47

under-fives but the male children have had a higher risk of being stunted than the female children.

Studies done in Sub-Saharan African mostly report a higher prevalence amongst male children
 than female children (6). In the food surplus region of Ethiopia, the odds of being stunted were

- 51 1.5 more times for males than for females (7). Studies such as (8–11) done in Uganda mostly
- 52 indicate that the sex of the child is among other factors with significancy in influencing stunting
- 53 of the under-fives. Among the 6-59 months old's in South-Western Uganda, boys were found to
- 54 be 2.2 times more likely to be stunted than girls (9). Among the 6-59 months Karimojong children, 55 it was found that male children were 1.8 times more likely to experience concurrent stunting and
- 56 wasting compared with their females counterparts (12). There is little doubt that stunting is higher
- amongst the poor households than among the wealthier household but a closer look into the matter
- still reveals that boys were at a higher risk of being stunted than girls. More so, stunting was higher
- within the poorer households than their wealthier counterparts (13). Many other studies (6,14–16)
 support the fact that male children were more at the risk of being stunted than the female children.
- 51 Just a few studies found a non-significant influence of sex of the child to stunting though the fact
- that boys were at a risk of being malnourished than girls was still evident (17). Based on the above
- 63 literature, it appears that the risk of stunting amongst the male children while their female
- 64 counterparts are not is not by chance and thus an investigation of the matter is worthwhile.

65 Materials and methods

66 The conceptual framework

The conceptual framework for this study is founded on the modified United Nations Children's 67 Education Fund (UNICEF) framework on the determinants of child malnutrition (18) which shows 68 the structural system of possible path through which determinants operate to influence malnutrition 69 in general and stunting in particular. Moreover, information from previous studies (19-23) 70 identified the most influential factors of stunting amongst the under-fives was also used to shape 71 better the current conceptual framework. Stunting, an indicator of undernutrition, is one of the four 72 73 forms of malnutrition and one would not go wrong by using the malnutrition framework in the analysis of risk factors of stunting. The framework is clear on the fact that factors that influence 74 the stunting are better categorized in different levels as; distal, intermediate, immediate and the 75 child inherent factors. 76 77 Except for the child inherent factors that don't have background determinants, all other category

- of factors were interrelated and happen to feed into each other at various levels. The distal factors
- may influence stunting of the child either directly or indirectly through either the intermediate or
- 80 immediate factors. Just like the distal factors, the intermediate factors influence stunting either
- 81 directly or indirectly through the immediate factors. The current study will also analyse the

possibility of the interrelationship of factors within the same group because it possible for example

83 household wealth index may influence mother's education level and mother's education level may

84 be a factor in determining the current employment status.

85 According to the conceptual framework, the child inherent factor are the age and sex of the child. The distal factors include, those factors that determine the socioeconomic status of the household 86 and they include; the education levels of the child's parents or caregivers, mother's employment 87 status, household wealth index (a proxy of poverty or richness), region, place of residence and the 88 religion. The intermediate factors which are the determinants of the environment and maternal 89 health act as a medium to influence stunting and they include; mother's age, mother's weight 90 (BMI), mother's decision making (autonomy), parity in the household, antenatal timing and 91 92 frequency, place of delivery, household membership, toilet facilities, sources of clean drinking water and health insurance coverage. The immediate causes of child stunting are basically child 93 level and they include; breastfeeding initiation, dietary diversity, size and perceived weight at 94 birth, birth order of the child, fever, cough and diarrhoea episodes within the two weeks preceding 95 the interview. Accordingly, the conceptual framework shows the hierarchical nature of the risk 96 factors where factors at one level feed into factors at other level(s) up to the overall independent 97 98 variable. The conceptual framework also shows the fact that while stunting is the only purely endogenous variable, there are several other factors in the system that are either exogenous at one 99 point or endogenous at another point (Fig 1) 100

131 Data and its sources

Data for this study was purely secondary data extracted from the child record (KR dataset) of the 132 2016 Uganda Demographic and Health Survey (2016 UDHS) (24). Approval for the use of the 133 ICF 134 UDHS dataset was granted by international via the online portal https://www.dhsprogram.com/. Cases for children aged 0-59 months whose anthropometric 135 measures were successfully captured at the time of the survey were extracted from UDHS dataset 136 and used in this study. UDHS survey was designed and implemented by Uganda Bureau of 137 Statistics (UBOS) to provide estimates of the population and health indicators including fertility 138 and child health for the country as a whole, rural and urban and for each of the 15 regions in 139 140 Uganda (South Central, North Central, Busoga, Kampala, Lango, Acholi, Tooro, Bunyoro, Bukedi, Bugisu, Karamoja, Teso, Kigezi, Ankole, and West Nile). The survey employed a 141 multistage and multisampling techniques whereby 15 clusters (regions) were selected at the first 142 stage, households were selected at the second stage and finally interviews or appropriate 143 measurements were carried out on household members who met the selection criteria. Overall, the 144 survey used three types of questionnaires were used to capture information concerning household 145 characteristics, fertility, morbidity, and child health were considered. All women in the selected 146 households aged 15-49 were interviewed and anthropometric measurements as well as other 147 relevant information for the children aged 0-59 month within the selected households were 148 149 collected.

150 Variable description

The purely endogenous variable for this study was stunting, a proxy for height-for-age z-scores 151 152 that were less than -2standard deviations from the median of the reference population of children in the agegroup of 0-59 months old (25). These z-scores were calculated based on the 2006 child 153 growth standards of the World Health Organization (WHO) (25). Observations whose z-scores 154 values were outside the normal range of z-scores were flagged off. Accordingly, z-scores (Zi) were 155 calculated as $Zi = \frac{AIi - \mu}{\partial}$ where AIi refer to the anthropometric indicator of ith child, μ and ∂ 156 respectively refer to the median and the standard deviation of the reference population. A z-score 157 158 cutoff point (-2sd) was used to generate a dummy variable with binary outcomes for stunting 159 (equation 1)

Independent variables were categorized as; child inherent, child level, immediate, intermediate and 162 distal factors. Except the child inherent factors (sex and age) of the child that were purely 163 exogenous, other variables in the system were either endogenous or exogenous because it was 164 clear that some variables at one level were not only determinants of stunting but would also be 165 influence other variables at the higher level in the system (Fig 1). Sex of the child was used as 166 comparative variable since the study was following a comparative approach where analysis was 167 made with respect to the sex of the child. Age of the child was categorized "0-5", "6-11", "12-23", 168 "24-35", "36-47", "48-59" month of age. Size of the child at birth (m18) was categorized into 169 small and large while child wight at birth was categorized into underweight (<2.5kgs) normal 170

(2.5<=bw<4 kgs) and high birth weight (>4kgs) at birth (26). Fever, malaria and diarrhoea
 episodes, birth order, duration of breast feeding, and initiation of complementary feeding were
 analyzed for possibility in influencing stunting of under-fives.

Intermediate level factors were considered as the possible determinants of the environment in 175 which the child and the mother live. They included; mother's age which was categorised and used 176 as mother's age-group (15-24; 25-34; 35-49), mothers' weight (categorised as thin 177 (BMI<18.5kgs/m², normal (18.5<BMI<24.5kgs/m²) overweight (BMI>25kg/m²), place of 178 delivery, household size, toilet facility, source of safe water, parity, mother's autonomy and health 179 insurance coverage, the timing of the first antenatal care (ANC), number of ANC visits. Given the 180 181 fact that antenatal care services are free of charge in Ugandan government hospitals, the timing of ANC, the number of ANC visits during pregnancy and the place of delivery are major determinants 182 of expectant mother's health seeking behavior. In this study, distal factors were considered as 183 factors that determine the socioeconomic status as well as the cultural factors of the household. 184 They are considered very important in forming the basis of the welfare status of the household. 185 They include; the spatial factor (region), place of residence (rural or urban), mother's and father's 186 187 education level, mother's employment and working status, religion and the wealth index of the household. The household wealth index is a composite measure of a household's cumulative 188 standards of living. Its calculated using easy-to-collect data on a household's ownership of selected 189 190 assets, such as televisions and bicycles; materials used for housing construction; and types of water access and sanitation facilities of the household. UDHS categorised households into wealth 191 quintiles (lowest, second, middle, fourth and highest) as indicators of poorest to richest. 192

Data analysis

The complex and multi-faceted nature of the problem of stunting and its risk factor presents a challenge in estimation. The system according to the conceptual framework (Fig, 1) reveals that a model that accommodates all variables in their statistical nature (categorical, count, continuous or discrete) is paramount. It was observed that the overall dependent variable (stunting) is binary in nature while other variables in the system were either ordinal, count, discrete or continuous yet they were to be used in the same model.

200 A generalized structural equation model (GSEM) was estimated. Since the study was comparative

- 201 in nature, estimation of the model parameters involved sex of the child (b4) as a grouping variable.
- GSEM was chosen over other modeling techniques because of its ability to accommodate 202 203 structural equations in a system that allows variables to feed into each other despite their nature and also because of its ability to relax the assumption of normality of variables, it accommodates 204 both generalized linear responses as well as linear responses, it allows the use of factor variable 205 notation (specifically in Stata), it allows for multi-level models and it is able to use more 206 observations in the presence of missing values and it allows for group analysis. The distribution 207 as well the link function that depends on the nature of a variable were specified for each of the 208 209 endogenous variable in the system of simultaneous equations.
- GSEMs represents a generalization of SEMs by allowing the use of all the types of variables and
- considering their distributions (27) as well as its advantages over other modeling approaches such
- as; (i) relaxation the assumption of normality of variables, (ii) it accommodates both generalized
- 213 linear responses as well as linear responses, (iii) it allows the use of factor variable notation
- 214 (specifically in Stata), (iv) it allows for multi-level models (v) it is able to use more observations
- in the presence of missing values and it allows for group analysis, make it a more preferred
- 216 modeling approach in the current study.

217 **GSEM equation modelling**

218 GSEM modeling approach combines the power and flexibility of both structural equation models

219 (SEM) and generalized linear model (GLM) in a unified modeling framework (28). A combination

of the statistical distribution of the family (F) and the link function g (\cdot) for the response variable(s)

- 221 were clearly specified within the structural modeling framework. Generally, let ley yi be a vector
- of endogenous variable, let xi be a vector of exogenous variables, and let ley β' and ui be the

coefficient and error terms respectively, then $yi \ yi = \beta' xi + ui$, generalized to the linear model of the form $g\{E(yi)\} = \beta' xi$ with $yi \sim F$ (Fig. 2).

Let *Yi* be the overall response variable (stunting status), *X*1*j*, *X*2*j*, *X*3*j*, and *X*4*j* be matrices for

distal, immediate, intermediate and child inherent factors respectively. The direct effects of;

distal, immediate, intermediate and child inherent on *Yi* as in Fig 2 were estimated as; *B1K*,

B2K, B3K, and B7K respectively while the indirect effects were calculated as; B8K * B2K,

234 B4K * B3K, B4K * B6K * B2K, and B8K * B5K * B3K. Let BiK, i = 1, 2, 3, ..., 8, be the effect

of factors that feed into each other at different hierarchical levels, for example *B*4*K* is the

effect of distal factor onto the immediate factors in the model (Fig 2). At each stage, the

distribution and family of the response variable will be specified. An error term (ϵ) was generated of family Gaussian (quantitative and continuous) factors.

During the modelling process, it was considered important to avoid excessive number of parameters in the final output (appendix 1) and as such only important variables are reflected in

the final model. Subsequently only parameters whose p-value <0.1 were maintained in the

establishment and the analysis of the path model (Figs 3 and 4). Sex was specified as a grouping

variable in generating comparative parameters for both male and female under-fives and analysis

was possible with the use SEM/GSEM builder within STATA version 15.0

245 **Ethics statement**

This paper is based on secondary data that exists in the public domain and is readily accessible 246 upon request. Accordingly, the permission to access and use the dataset (UDHS 2016) was sought 247 and granted via the DHS website (https://dhsprogram.com/data/dataset/Uganda Standard-248 249 DHS 2016.cfm?flag=1). The DHS programme is a worldwide reputable organization for collecting and disseminating credible national representative data on health indicators especially 250 data on household demographics and child nutrition. For the case of the Ugandan country team, 251 the ICF institutional review board (IRB) reviewed and approved the UDHS 2016 tools for the 252 253 survey as well as the procedure of obtaining written informed consent. The ICF IRB complied with the United States Department of Health and Human Services regulations for human subjects. 254 Informed consent was obtained from participants in writing whereby a form was signed by the 255 respondent as well, data on minors were collected on children based on mothers' informed consent 256 obtained in writing. Participants were given full information about the survey and their 257 participation was purely voluntary. Confidentiality and keeping participants anonymous, elements 258 were observed by exclusion of identifiers from the final dataset obtained. Further information 259 regarding the conduct of the study that generated the data used can be found in the report of UDHS 260 2016 (24). 261

262 **Results**

After realising that male and female under-five are affected differently by stunting, the major task 263 in this study was to establish the likely reason why the status quo. The analysis was banked on 264 265 GSEM modeling approach whereby, the path, the link and family of response variables in the GSEM structure were specified and a GSEM model was constructed and estimated. The estimation 266 followed three levels; level one involved identification of significant risk factors, level two 267 268 involved identification significant factors with respect to their levels while level three involved identification of the path which was pursued by identifying the determinants of significant 269 determinants as identified in level 1 and 2. To avoid crowding of paths, the path diagram (Figs 3 270 and 4) only presented the path with respect to the significant risk factors of stunting. Parameters 271 in the Tables 1 and 2 were generated for variables in combination without factor level 272 specifications. The grouping variable was specified as sex of the child under-five years of age (b4) 273 274 or 0-59 months and as such estimates were generated in comparisons of male child (Table 1) and female child (Table 2). Later analysis of the same model considered the specification of factor 275 levels (Tables 3 and 4). Until this stage, the analysis targeted the identification of the most 276 significant direct determinants of stunting with reference to the sex of the child. Path analysis was 277 evoked by identifying the factors behind those determinants that were found to be significant at 278 level one. Risk factors were considered statistically significant in case their p-value (p(z) was less 279 or equal to 10%. 280

Table 1 presents a model for the estimation of the risk factors that influence stunting with respect 314 to the male child while Table 2 presents the risk factors that influence stunting with respect to the 315 316 female child. It is observed that there is a variation among the risk factors that influence stunting amongst male and female children. The factors that were statistically significant in influencing 317 stunting amongst the male children were not exactly the same factors influencing stunting amongst 318 the female children. Overall, the most significant factors in both cases were; birthweight 319 (BWcateg), number of children below 5 years of age in the household, duration of breastfeeding 320 and mother's level of education. Household wealth index (v190), mother's age, episodes of 321 322 diarrhoea (Depsode), locality by region (v101) and distance to the nearest health center (v467d) were statistically significant in influencing stunting amongst the male under-fives but not amongst 323 the female. Mother's weight (MBMI) and the perceived size of children at birth were statistically 324 325 significant in influencing stunting amongst the female under-fives but not amongst the male underfives. 326

Table 1 and 2 also discloses that the household wealth index, weight of the child at birth, mother's 360 age, number of children below five years, education level of the mother and perceived size of the 361 child at birth negatively influenced stunting while duration of breastfeeding, diarrhoea episodes 362 and distance to the nearest health center positively influenced stunting of under-fives. Stunting 363 being a serious health problem that affects both the physically and cognitively development of 364 children which later affects their performance both at school and in the world of work needs to be 365 tackled with respect to the gender or sex of the child. The strategies put in place to eliminated it 366 should consider the differences in the risk factors that influence it with respect to the male and 367 female differences in risk factors. It was necessary to make further analysis with respect to the 368 factor levels of the variables in the model. Factor level analysis was crucial in identifying which 369 categories within the factors were responsible for influencing stunting of under-fives in Uganda. 370 371 As shown in Tables 3 and 4, the assumption that all the factor levels are equal in influencing stunting of under-fives in Uganda is put in the limelight. The first factor level for each factor was 372 automatically selected as the base and consequently other factor levels were judged with reference 373 374 to the selected or base factor level. The difference was considered statistically significant the base 375 factor level if the p-value of a particular factor level was less than or equal to 0.1 that is, $(p(z) \le 10\%))$ 376

523 At factor levels some of the variables which were not statistically significant proved to have some levels within themselves that tuned out to be statistically significant in influencing stunting. Age 524 525 below 24 months of age for (agegroup) was significant from the base factor level for males and not for females in influencing stunting of under-fives. Birth weight and wealth index were still 526 527 significant at all levels. Partners who were educated up to the level of primary were significant in 528 influencing stunting for male while it was significant at all levels in influencing stunting for the 529 female under-fives. Normal weight of mothers was significant in influencing stunting while for the female, it's the overweight that was significant. For males, duration of breastfeeding was 530 531 significant above 24 n=months while for female duration of breastfeed was not significant at all. Third and fourth birth rank were significant in influencing stunting in males it was not significant 532 at all with respect to female under-fives. One to three antenatal visits were significant in 533 influencing stunting with respect to male sex while for female sex, it was not significant at all 534 levels. Mothers' education level of primary and higher excluding secondary was significant in 535 influencing stunting in male under-fives while it was significant at all factors with respect to 536 537 influencing female stunting. Long distances to health center were a problem in influencing stunting among the male under-fives but was not the case with female under-fives. As far as regions are 538

539 concerned, males are more a victim of stunting in Bukedi and Teso while female are more of a victim in Teso only. Being perceived to be large at birth was statistically significant in influencing 540 stunting amongst the female under-fives but not amongst the male under-fives. 541

After the identification of significant variables that influence stunting in either male or female 689 under-fives or both, it was prudent to identify the factors behind them in order to establish the 690 mechanism of effect. Considered for the male under-fives were; weight of the child at birth, the 691 household wealth index, presence of diarrhoea episodes, duration of breastfeeding and number of 692 693 children below five years in the household. Theoretically, mother's age group (mothers age), region and distance to the health center didn't have influencing variables behind them. For the 694 female group, weight at birth of the child, household wealth index, duration of breastfeeding, 695 number of children below five years and mother's and partners education level all having been 696 found statistically significant influencers of stunting, were considered for path analysis. Figure 3 697 and 4 present the results for the male and the female groups respectively. 698

Figure 3 portrays the possible paths for statistically significant variables at various hierarchical levels with respect to the male under-fives. As it can be seen, at distal level, mother's education level, household wealth index (v190), partner's level of education (v701), mother's working status and place of residence were outstanding influencers in the system. Tracking the roots of the paths in the system, made it possible to come up with various possible paths which would be key in dealing with the problem of stunting among the male under-fives in Uganda and elsewhere in the world. Among others, the most important possible paths identified were;

- i. Through mother's education level to influencing the number of under-fives in the households which influences the episodes of diarrhoea in an environment with poor toilet facilities and then stunting
- ii. Low education level of the mother's leads less employment opportunities which feeds
 into the household's low wealth status which influences stunting either directly or
 indirectly through moderation of the duration of breastfeeding.
- iii. Large household membership feeds into large number of children in the household that
 also influences the episodes of diarrhoea hence lowering the immunity system of the
 male under-fives leading to stunting.
- iv. The education level of the partners feed into employments opportunities, then wealth
 status of the household and finally influences stunting either directly or through
 moderating the duration of breastfeeding.

Figure 4 was generated with respect to the female under-fives. Complete information was available for 829 cases for this path analysis. A close look and comparison of Figures 3 and 4 indicates differences in the possible paths as well as possible influencers of stunting amongst the underfives (male and female). Among the distal factors that influence stunting for the female underfives in the system were; mothers' employment status, mother's education level, residence, region, father's education level and household wealth status. The most crucial paths identified in the system to be the possible channels through which stunting is influenced include;

- i. The level of the mother through the mother's weight, child's weight and size at birth and finally stunting
- 732 ii. Through the mother's education level to number of ante natal visits and timing to733 birthweight of the child and then stunting
- iii. Education level of the mother influences stunting through wealth status of the household

iv. Employment status of the mother influences stunting of under-five females through itsinfluence on the duration of breast-feeding.

738 **Discussions**

739 Sex differences in growth paths and immune functions of the body- prenatally place boys at greater risk of infection and undernutrition, but these biological differences are interpreted by parents and 740 741 within household contexts that are shaped by social and cultural norms which, in turn, influence care and feeding practices(29). Literature reviewed and cited in most sections of this study reveal 742 that stunting affects the male and the female under-fives differently both in Uganda (17) and 743 elsewhere in the world (30). It was thus worth to study and identify the risk factors and the causal 744 mechanism that could explain the difference. The study was based on the modified 1991 UNICEF 745 746 framework for child malnutrition which clearly categorizes and shows the interconnectivity of distal, intermediate, immediate and maternal level factors in a hierarchical order. The factors feed 747 into each other implying a causal mechanism (Figure 1). This study made use of the structural 748 749 equation modeling approach in its generalized form (GSEM) to identify not only the main risk factors responsible for stunting amongst the male and female groups but also the causal mechanism 750 of the influencing risk factors with respect to the male and female groups. 751

Accordingly, this study clearly reveals that the risk factors which statistically influenced underfive stunting in Uganda differ with respect to the sex of the child. Male as a sex outcome was positively associated with stunting while being female was negatively associated with stunting of under-fives. Socioeconomic status of the household such as the household wealth status, education level of mother, mother's employment status and residence turned out statistically significant

influencers of in both male and female under-fives. Elsewhere for example in India, it was also
observed that the risk factors that influenced stunting amongst male children differed from the risk
factors that influenced stunting amongst the female children (31).

In this study, it was established that mother's education level was a statistically significant risk 760 761 factors in influencing stunting for both male and female children in Uganda which slightly differs from the findings from the rural primary school going children in India where mother's education 762 level predicted stunting amongst the female children only(31). The difference in the outcome may 763 probably be because the school going children were somehow older than the children in our sample 764 and also because our advanced modelling that generalizes the response to accommodate all types 765 of variables. The current study also reveals the importance of education level in determining the 766 wealth status of the household which is an indicator of wellbeing. This highlights the role of 767 education in generating household wealth, information uptake and child care practices for maternal 768 education and wealth greatly influence child development and stunting (32). Improving the wealth 769

status of a household is key in reducing the problem of under-five stunting at household level butat a national level greater emphasis should be put on reducing the socioeconomic and particularly

wealth and income inequality amongst the households (33). Overall, literature reveals that there is an inverse relationship between wealth status and level of stunting. The odds of being stunted reduces greatly with an increase in wealth index of the household (34). Lower wealth status of the household may also imply that there is little on table, the mothers nutrition intake may not be sufficient and as such they struggle with their children for the little food the mother eats (35).

777 Duration of breastfeeding was a significant factor in influencing stunting in both male and females

amongst the under-fives in Uganda. This particular outcome echoes the recommendations of world

health organization that emphasizes breastfeeding in the first six months of life () and the fact that

infants who are exclusively breastfed for the first six months of their life have less morbidity andgrowth issues (36).

Age of the child was categorized into age groups of 0-5, 6-11, 12-23, 24-35, 36-47 and 48-59 782 783 months. The study reveals a statistically insignificant effect of agegroup in influencing stunting in both male and female children. Considering factor levels, the age group 12-23 was found 784 statistically significant and different from other age groups for the female group. Prevalence of 785 stunting increased with age whereby in most developing or low developed countries, the age-786 group 12–23-month was the most affected with more than 50% children being victims of stunting 787 (37). Methodological differences may account for this contrast whereby most studies cited in 788 literature used other methods that did not consider the generalized and hierarchical nature of 789 790 variables. Other studies in Uganda (17) considered age categorizations that are too heterogenous in nature for example the age group "0-23" months and "24-59". The attributes and nutrition 791 requirements of children in these age-groups considered are obviously different. The study also 792 shows that perceived size of the child at birth is statistically significant in influencing stunting 793 amongst female under-fives but not amongst the male counterparts. Further scrutiny also reveals 794 that there is no significant different among the factor levels with respect to the female under-five 795 796 while it was revealed that male children whose size at birth was perceived large were significantly 797 different from the rest of the groups (small and very large). Perceived size at birth was found to be 798 statistically significant in influencing stunting among children whose perceived size was small 799 and average size than their counterparts (38), however perceived size is relative and unclear and the results in this case are inconclusive. 800

The findings of this study reveal that mother's age was a significant influencer of stunting amongst male under-fives but not amongst the female under-fives. The role of mother's age in childcare cannot be taken lightly and this also is true with mother's health (BMI) as well. This could be because young mothers may not have acquired enough technical know-how in taking care of children as well.

806 **Conclusion**

The risk factors that influence stunting of under-fives with respect to the sex of the child was 807 deeply analyzed in this study. Using GSEM modeling approach, the study paid attention to the 808 family and link function for all the possible response factors in the model as well as establishing 809 the causal mechanism of risk factors. Keen interest was put in identifying whether there were any 810 differences in the set of factors that influence stunting amongst the male and female under-fives. 811 It was clearly found out that indeed the set of factors that influence stunting amongst the male and 812 female under-fives differ both in combination and in the chain or paths. The study recommends 813 that the strategies to reduce stunting amongst the under-fives should factor in the sex or gender 814 815 aspects of the under-fives. The findings of this study re-echo much of the key takes from the existing literature. Interventions to reduce stunting should consider the chain of influence and 816 policy makers should be aware that the interventions that work for the male under-fives should be 817

818 designed differently from the interventions to reduce stunting amongst the female under-fives.
