45 **Background:** Early relational health is a key determinant of childhood development, while
46 relational trauma in the parent-infant dyad can instigate a cascading pattern of infant risk.
47 Fortunately, early relational trauma is detectable and modifiable. In 2018, Australian
48 Maternal and Child Health (MCH) nurses participated in MERTIL (My Early Relational
49 Trauma-Informed Learning), a program to identify and prevent relational trauma. Program
50 evaluations revealed nurses felt competent and confident to identify and respond to relational
51 trauma; however, response capacity was inhibited by inadequate parent referral options. In
52 response, MERTIL *for Parents* (My Early Relational Trust-Informed Learning) was
53 developed, which is an online, evidence-based, self-paced parenting program that focuses on
54 enhancing parental knowledge of relational trust and its significance for infant development.
55 This low-cost, accessible prevention resource targets emerging relational concerns to reduce
56 later service system engagement. The potential for universal preventative online programs
57 that target parental and relational wellbeing remains under-explored. This paper reports on a
58 protocol for implementing a MERTIL *for Parents* pilot study describing nurses' and parents'
59 perspectives on program feasibility and efficacy. **Methods:** This study is a mixed-methods,
60 parallel-armed, uncontrolled, repeated measures design. We aim to recruit 48 Australian
61 MCH nurses from the states of Victoria and New South Wales. These nurses will in turn
62 recruit 480 parents with a child aged 0-5 years. All parents will receive MERTIL *for Parents*,
63 which entails a 40-minute video, tipsheets, worksheets, and support resources. Parent data
64 will be obtained at three periods: pre-program, program exit, and program follow-up. Nurse
65 data will be collected at two periods: parent recruitment completion and program follow-up.
66 Data collection will occur through surveys and focus groups. Primary parent outcomes will
67 be socioemotional assessments of program efficacy. Nurses and parents will each report on
68 study program feasibility. **Discussion:** This protocol describes the feasibility and efficacy of
69 a new online parenting program, MERTIL *for Parents*, with pilot field studies commencing

70 in August 2022. We anticipate that this resource will be a valuable addition to various child
71 and family services, for use in individual support and group work.

74 **Study Protocol Introduction**

75 Early relational health is a key determinant of childhood development, while relational
76 trauma in the parent-infant dyad can instigate a cascading pattern of infant risk. Fortunately,
77 early relational trauma is detectable and modifiable. In 2018, Australian Maternal and Child
78 Health (MCH) nurses based in the state of Victoria participated in MERTIL (My Early
79 Relational Trauma-Informed Learning), a program to identify and prevent relational trauma.
80 Program evaluations revealed nurses felt competent and confident to identify and respond to
81 relational trauma; however, response capacity was inhibited by inadequate parent referral
82 options for those with sub-clinical presentations. In response, *MERTIL for Parents* (My
83 Early Relational Trust-Informed Learning) was developed. *MERTIL for Parents* is an online,
84 evidence-based, self-paced parenting program that focuses on enhancing parental knowledge
85 of relational trust and its significance for infant development. This low cost, accessible
86 prevention resource targets emerging relational concerns to reduce later service system
87 engagement. The potential for universal preventative online programs that target parental and
88 relational wellbeing, as well as the development of early relational trust, remains under-
89 explored.

90 This protocol describes the feasibility and efficacy of a new online parenting program,
91 *MERTIL for Parents*, describing MCH nurses' and parents' perspectives on program
92 feasibility and efficacy, with pilot field studies soon to commence. This study is a mixed-
93 methods, parallel-armed (i.e., MCH nurses and parents), uncontrolled, repeated measures
94 design. We aim to recruit 48 MCH nurses who will in turn recruit 480 parents with a child
95 aged 0-5 years (inclusive) displaying early signs of relational trauma. All participants will
96 receive access to the *MERTIL for Parents* program, which entails a 40-minute video, tip
97 sheets, worksheets, and support resources. Parent and nurse data collection will occur through
98 surveys and focus groups. Primary parent outcomes will be socioemotional to examine

99 program efficacy; such outcomes will include child-parent relationship quality and parental
100 reflective functioning. Nurses and parents will each report on study program feasibility. It is
101 anticipated that this resource will be a valuable addition to a wide range of child and family
102 services, for use in individual support and group work.

103 **Background**

104 Children develop in a relational context with everyday parent-child interactional patterns
105 contributing to their *relational health* (1). Relational health in the infant-parent dyad is
106 construed as parental security, trust, responsiveness, and sensitivity, which together form the
107 cornerstone of socioemotional development. Alternatively, *relational trauma* presents
108 ongoing and accruing disruptions to the infant's context of early care. Unsurprisingly,
109 relational health and relational trauma impact upon an array of child developmental domains,
110 instigating a cascading pattern of child resiliency or risk. Importantly, relational health
111 elements, including attachment organisation and parental sensitivity (2-4) are modifiable, for
112 better or worse. With this knowledge, promoting positive caregiving via psychoeducation and
113 increased parenting capacity is important, enabling parents to promote child development,
114 thereby affording their child the best start in life. Early parenting programs have been
115 developed as a result.

116 **Preventative Parenting Programs**

117 Preventative parenting programs can be universal, selective, or indicated. Universal programs
118 are those available to all parents; selective programs target parents displaying above average
119 risk; and indicated programs target parents showing signs or symptoms of emerging disorder
120 (5). Research has shown universal programs are well suited to mental health promotion,
121 offering significant preventative public health benefit (6).

122 ***Universal face-to-face parenting programs***

123 Universal parenting skills-based programs have historically been presented through varied in-
124 person modes, including face-to-face lectures, workshops, and groups. Program examples
125 include CANparent (7) and *ACT Raising Safe Kids Program* (8). Such programs have been
126 shown to increase both child and parent mental health among an array of domains such as
127 parental self-efficacy, mental wellbeing, satisfaction, and child internalising and externalising
128 presentations (e.g., 7, 8, 9).

129 Despite the availability and evidence supporting these in-person parenting programs,
130 many families, particularly those experiencing numerous vulnerabilities, face multiple
131 barriers in accessing these programs (10, 11). For parents who live in regional centres and
132 rural or remote locations, attending in-person programs, typically city-based, is an
133 accessibility obstacle. Transportation access is also an issue for in-person parent service
134 participation (12, 13). Such programs are additionally cost prohibitive to many due to their
135 high in-person contact hours with professionals (14). The inflexible structure of such
136 programs and rigid delivery approaches can be perceived as stigmatising by the individuals
137 these programs are intended to reach. Capped attendance due to physical room size,
138 occupational health and safety concerns, and the limited number of facilitators running
139 sessions provide further shortcomings. Parent logistical barriers, such as managing various
140 daily work and lifestyle demands have resulted in low in-person parent program enrolment
141 and poor program attendance for enrollees (e.g., 5, 15-17). Compounding these limitations,
142 the COVID-19 pandemic saw an abrupt stop to most in-person treatment programs due to
143 lockdowns and quarantine, severing preventative program resources at a time of heightened
144 psychological vulnerability for parents and children alike (18).

145 ***Universal online parenting programs***

146 Online or app-based program delivery provides an avenue to address these limitations,
147 provided intended users have adequate technology access, reliable internet connection, and

148 are digitally literate. Online universal parenting programs can be either entirely or partially
149 self-guided. In partially self-guided programs, clinician support is provided at varying
150 frequencies via online, phone, or in-person modalities (19). Prior meta-analytic research on
151 the efficacy of self-guided and partially self-guided online parenting programs has reported
152 benefits at the parent, child, and dyadic level. Specifically, at the parent level, programs have
153 been shown to enhance elements such as positive parenting perceptions, behaviours,
154 satisfaction, efficacy, and confidence, while lowering parental mental health problems (e.g.,
155 anxiety, anger, depression, stress) and negative parenting practices (20-25). At the child level,
156 programs decrease emotional and behavioural problems (21-23, 25), while at the relational
157 level, they can reduce negative parent-child interactions (23), negative parental discipline
158 strategies, and parental conflict (24).

159 While both self-guided and partially self-guided online parenting programs are
160 efficacious, the formation and implementation of wholly self-guided, universal, digital
161 parenting programs has recently gained momentum (e.g., 15, 26). The rapid uptake of such
162 programs is particularly due to the ease of administration, scalability, sustainability, low-cost,
163 and program standardisation. Further rationale for the uptake of online program delivery is
164 due to the ubiquitous nature of internet access, allowing widescale dissemination. For
165 example, 99% of Australians and 91% of Australian households have internet access (27),
166 making this a delivery method that can reach most of the population, thus making these
167 programs highly accessible. The self-directed nature of online programs may further allow
168 parents to flexibly complete these programs in the security of their homes, thereby
169 overcoming possible judgement and stigma felt from participating in in-person programs.
170 Such benefits may in turn reduce costs and barriers to program engagement and enhance
171 program reach.

172 Due to their significant preventative potential, online parent resources may reduce the
173 need for later intervention. This may occur by supporting and motivating parents with new
174 knowledge and behavioural skills to independently enhance their parent-child relationship, in
175 turn reducing later burden on service systems. Public health initiatives such as these may
176 empower parents to alter relational trajectories early on, within a preventative approach that
177 is parent-led and strengths-based. This may assist to disrupt emerging disadvantage before
178 reaching pathological thresholds. Equitable access through online platforms has become more
179 important, particularly in the face of the COVID-19 global crisis. Further, evidence shows
180 that these programs promote help-seeking (28). Finally, from a research perspective, fully
181 online content allows for the collection and tracking of unique data on training progress,
182 completion times, and premature program cessation. Such data can be linked to outcomes and
183 inform program improvements.

184 **Knowledge Gaps**

185 While numerous clear benefits exist in relation to online, self-delivered, universal parenting
186 programs, gaps remain. Currently, there are few brief self-help, psychoeducational, program
187 options (in-person or online) suitable at the broad community level for parents where
188 enhanced awareness of their role in promoting early relational trust may assist with
189 prevention of relational trauma, especially in the face of challenge. Second, most parenting
190 resources in this domain exist in the context of in-depth indicated parenting interventions
191 (e.g., Parent-Child Psychotherapy; 1). While these indicated programs are essential for dyads
192 in need of targeted treatment, there is a clear need for preventative education resources for
193 parents in the wider community wishing to enhance their understanding of the parent-child
194 relationship. This could act as an initial independent healthcare measure and reduce the need
195 for later targeted measures. Further, outcomes of online parenting programs tend to focus on
196 parents and, to a lesser extent, child outcomes (21, 24). Few studies have reported dyadic

197 outcomes and even fewer have reported familial outcomes associated with online parent
198 program participation (e.g., 23). Finally, despite MCH nurses completing MERTIL and
199 providing parenting support, they do not have a recommended suite of online parenting
200 programs within their toolbox to assist clients (29). MCH service practice guidelines focus on
201 health promotion, child development and to a lesser extent parent mental health; however,
202 nurses need evidence-based interventions to enhance dyadic relationships. This study aims to
203 address these resource and knowledge gaps.

204 **Methods**

205 **Study aims**

206 This paper reports on a protocol for the pilot implementation of a new self-directed, online
207 parenting program (*MERTIL for Parents*) within the Maternal and Child Health (MCH) and
208 allied Early Childhood sector. The aims of this study are twofold:

- 209 1) Determine the feasibility of *MERTIL for Parents*:
 - 210 i. For MCH nurses and allied health professionals: Examine the programs
211 acceptability and utility for enhancing parent understanding of early relational
212 health; assess the practical dimension of implementing the program within a busy
213 service; and explore population reach.
 - 214 ii. For parents: Examine program acceptability, efficacy, and utility.
- 215 2) Evaluate the short-term efficacy of the *MERTIL for Parents* program for parents across
216 selected parental caregiver knowledge, perceptions (e.g., parenting confidence &
217 competence), and behavioural domains (e.g., professional help-seeking amenability).

218 **Intervention development**

219 *MERTIL for Parents* is a new universally available, self-directed, online psychoeducation
220 resource for Australian parents focused on promoting parental knowledge and understanding
221 of relational trust and its significance for infant development. This program is informed by

222 evidence from attachment theory, developmental neuroscience, and psychoanalysis. As a
223 preventative early mental health resource, MERTIL *for Parents* aims to enhance infant-parent
224 relational trust and relational awareness, in turn modifying parents' attachment security-
225 oriented beliefs, attitudes, and behaviours. MERTIL *for Parents* builds upon prior research
226 by the authors. In 2018, over 1700 Australian MCH nurses from the state of Victoria
227 participated in MERTIL (My Early Relational Trauma-Informed Learning), a 14-hour self-
228 directed, interactive, professional development program for MCH nurses to identify and
229 prevent relational trauma. The MERTIL program evaluation from the 2018 Victorian cohort
230 revealed that MERTIL enhanced competence and confidence in nurses' identification of
231 relational trauma (30). However, capacity to respond to such identified early relational
232 trauma was inhibited by inadequate referral options for parents, particularly in rural and
233 remote settings. More broadly, it was identified that the potential for universal online
234 programs that target the development of early relational trust remains under-explored (30). In
235 response, MERTIL *for Parents* was developed, replacing the *trauma* in MERTIL *for trust*.

240 **The Intervention**

241 ***Intervention Content***

242 MERTIL *for Parents* is accessed via the internet and can be viewed on any online platform
243 (i.e., phone, computer, or tablet). The primary component of MERTIL *for Parents* comprises
244 a 40-minute pre-recorded video. Video content consists of four 'chapters', with each chapter
245 approximately nine-minutes in duration. See Table 1 for a description of the MERTIL *for*
246 *Parents* video content. Secondary program components include downloadable parent tip

247 sheets, parent worksheets, and professional support contacts. All secondary program elements
248 will be developed by the study authors. See Table 2 for additional downloadable program
249 resources. Participants progress through the varied program aspects at their own pace.

256 ***Program engagement***

257 Numerous steps were taken to ensure MERTIL *for Parents* is highly engaging, in order to 1)
258 enhance program enrolment, 2) deliver memorable content, and 3) maximise successful
259 program completion. MERTIL *for Parents* was intentionally designed as a very-brief
260 parenting program, to counter the high dropout rates that have been observed in other online
261 parenting programs (31). The rationale for MERTIL *for Parents*' length was to introduce
262 parents to the pivotal elements of relational trust, in a manageable, user-friendly, and time-
263 efficient fashion that could be completed in one sitting or across several brief stints. A
264 production team and animator translated the content into an engaging, animated format. See
265 Fig 2 for screenshots of the MERTIL *for Parents* content.

270 *Program content & delivery*

271 To ensure the evidence-based narrative content was engaging and well received, content
272 included:

- 273 1. Occasional moments of humour to balance the program’s occasional heavy content.
- 274 2. Lay language to ensure the program’s content was successfully communicated to a varied
275 parent audience,
- 276 3. An emphasis on safety, relatability, and acceptance; to this end, the narrator’s voice is
277 warm, calm, non-blaming, and reassuring.

278 *Co-designed nature of MERTIL for Parents*

279 The MERTIL *for Parents* website (www.mertil.com.au) and all content within, was co-
280 designed and co-developed alongside consumers, child infant mental health clinicians, and
281 MCH nurses alike, from program commencement to completion. This collaborative process
282 enabled the voice of ‘would be’ end-user parents and professional referrers to be heard; prior
283 research has identified this co-design process as enhancing engagement, efficacy, and
284 research applicability (32, 33). Researchers and clinicians engaged in a multiphase feedback
285 process, culminating in the resultant MERTIL *for Parents* program.

286 **Design**

287 MERTIL *for Parents* will be examined via a parallel armed (i.e., nurses & parents),
288 uncontrolled, mixed-methods, repeated measures study design. Nurses will complete two
289 assessments (post-parent recruitment and three-month post-program) and parents will
290 complete three assessments (pre-program, program exit, and three-month post-program). All
291 nurse and parent data collection and completion will be conducted independently and in
292 parallel.

293 **Participants**

294 Eligible study participants will be twofold: 1) Australian MCH nurses, and 2) Australian
295 parents. See Fig 3 for an outline of all study participants.

296 **Eligibility criteria**

297 *Nurses*

298 Nurses will i) have completed MERTIL, and ii) work at a participating pilot MCH site, in
299 metropolitan and regional/rural Victorian and New South Wales Local Government Areas
300 (LGAs) and iii) be able to make a follow-up phone call to each of the parents they refer to the
301 program, to gather feedback. Three programs sit within the MCH umbrella: 1) Universal
302 service, 2) Enhanced service and 3) 24-hour MCH Telephone Line (29). Participants will be
303 comprised of Universal and Enhanced services MCH nurses. The Universal MCH service is
304 available to all families, while the Enhanced MCH service supports families who meet strict
305 ‘at-risk’ criteria, with limited places. Study participation invitations will be sent to MCH
306 nurses who work in both the Universal and Enhanced MCH services. For nurses who decide
307 to participate, free access to MERTIL (My Early Trauma-Informed Learning) will be
308 provided for the duration of the pilot study. This is the training program MCH nurses
309 completed in 2018 and will allow them to refresh their knowledge of and skills in identifying
310 early relational trauma, if necessary. Nurses will also have ongoing access to MERTIL *for*
311 *Parents*.

312 *Parents*

313 Consenting parent participants will: i) be the parent of a child 0-5 years (inclusive) or
314 currently pregnant, ii) be recommended to participate in the program by an MCH nurse from
315 a participating pilot site, iii) aged 18 years and over, iv) currently reside in Australia, and v)
316 feel comfortable to complete questionnaires and program materials in English.

317 **Sample size/power calculation**

318 Power analysis was conducted using the G*Power 3.1 software to determine the required
319 sample size for this study (34). A single group within study design would require 199
320 participants to identify a small to moderate statistically significant effect (.20) at $p < .05$, with

321 80% power. To account for parent participant attrition, we aim to recruit approximately 480
322 parents.

323 *Sample*

324 We aim to recruit 48 MCH nurses, consisting of 24 MCH nurses from the Universal MCH
325 service and 24 MCH nurses from the Enhanced service. These nurses will in turn recruit the
326 above-mentioned 480 parents.

330 **Recruitment of study populations**

331 *Nurse*

332 The authors will recruit through their existing MERTIL MCH nurse networks, ensuring a
333 representative sample of MCH nurses from differing Australian geographic locations.

334 Participating MCH nurse sites will include four Victorian and New South Wales metropolitan
335 LGAs and four Victorian and New South Wales regional/rural LGAs, based on pre-existing
336 nurse networks. To further ensure representativeness, recruitment will include MCH nurses
337 from the Universal and Enhanced MCH services. All participating MCH nurses will provide
338 written online consent to their study participation.

339 *Parents*

340 Parents who meet inclusion criteria will be informed about the study by their MCH nurse
341 during a visit to the Universal service (any of the scheduled visits from the initial post-birth
342 home visit, consultations at 2, 4, & 8 weeks; 4, 8, 12, & 18 months; 2 & 3.5 years), or a visit
343 from the Enhanced service. The MCH nurse will explain MERTIL *for Parents* and the
344 associated research project, and if the parent verbally expresses interest, nurses will direct
345 them to the MERTIL *for Parents* website to register for the study and to access the materials

346 (www.mertil.com.au). Nurses will provide parents with a printed flyer with MERTIL *for*
347 *Parents* details to aid this process. For parents who verbally agree to participate, MCH nurses
348 will follow-up with a phone call or email, to gauge parents' responses to the program.

349 During the study pilot phase, all individuals who arrive at the MERTIL *for Parents*
350 website landing page will be invited to join the research. Specifically, parents will be met
351 with a webpage popup with a brief research overview and the option to hear more about the
352 study. If they select to hear more about the research, they will be automatically prompted to
353 enter their first name and email address. This will trigger emailing of consent forms. Once the
354 completed forms are submitted, the pre-program parent survey will be automatically emailed
355 to the participant. Completing this survey will grant parents access to the MERTIL *for*
356 *Parents* program content.

357 **Procedure**

358 *Nurses*

359 Following informed consent, MCH nurses will attend a 120-minute web-based information
360 and training session on MERTIL *for Parents*. This session will provide a study overview to
361 promote program familiarisation, discuss parent program engagement, and explain the
362 implementation options for parents accessing both the Universal and Enhanced MCH
363 services. Immediately following this session, nurses will be emailed and asked to complete an
364 online survey to report their first impressions of MERTIL *for Parents* regarding factors such
365 as perceived program content, length, and suitability.

366 Nurses will be asked to make contact (phone call preferred) with parents they referred
367 to the program, within two weeks of recommending MERTIL *for Parents*. On completion of
368 all parent recommendations, a follow-up email survey will be conducted, assessing program
369 use, perceived parent impacts, program engagement, ideas for program refinement, and wider
370 implementation. Online focus group interviews will follow to elaborate on survey responses,

371 assess nurses' views and experiences of the program, potential barriers to implementation,
372 and to identify further uses and applications of MERTIL *for Parents*. These elements will
373 ensure MERTIL *for Parents*' co-designed nature endures. See Fig 4 for the MCH nurse data
374 collection flow diagram.

377 ***Parents***

378 During the study pilot phase, all individuals who arrive at the MERTIL *for Parents* website
379 landing page will be welcomed to the MERTIL *for Parents* pilot study and advised that the
380 program is open to parents who are willing to participate in the research (but will be open to
381 all following our test phase). They will be invited to read more about the study. If they
382 consent, parents will provide their contact details to be emailed the Participant Information
383 Statement and Participant Informed Consent Form. Once these forms are complete, the pre-
384 program parent survey will be automatically electronically emailed to the parent participant.

385 The brief 10-minute survey before, after, and at 3-months follow-up comprises two
386 sections: 1) close-ended questions, and 2) open-ended questions. Upon completion of Survey
387 1, participants will be able to access the MERTIL *for Parents* program. Participants have
388 program access for 2 months from consent completion. Immediately upon MERTIL *for*
389 *Parents* main video completion, Survey 2 will be sent. As needed, survey reminders will be
390 sent via email at 7- and 14-days after the initial survey. If participants do not complete
391 surveys after these communication bids, no further contact will be made. Three-months after
392 completion of MERTIL *for Parents*, a follow-up survey will be sent to explore sustained
393 change; consenting parents will participate in a qualitative interview, to further identify lived
394 experience, program strengths and weaknesses. See Fig 5 for an outline of parent data
395 collection points.

400 During this research and piloting phase, MERTIL *for Parents* will be free of charge to
401 parents and caregivers who choose to participate in the research. Following this piloting
402 phase and program refinement, MERTIL *for Parents* will be made broadly available.

403 **Measures**

404 Our primary outcome will be to determine the efficacy of MERTIL *for Parents* in enhancing
405 socioemotional development. Secondary outcomes include evaluating the feasibility of
406 implementing MERTIL *for Parents* within the Victorian and New South Wales MCH
407 services.

408 ***Parents***

409 *Baseline and three-month post-program questionnaires*

410 To evaluate program efficacy, participants will complete identical self-report measures pre-
411 program and three-month post-program (see Table 3); noting that demographic questions
412 would have been completed pre-program and will not be repeated. On both occasions parents
413 will receive surveys through a secure weblink sent to their email address. Program efficacy
414 questions will be both quantitative and qualitative in nature. Program efficacy will not be
415 assessed at program exit as not enough time would have elapsed for meaningful parent
416 change. All included measurement items were derived where possible from validated scales,
417 single items from validated scales, and/or items from established clinical cohort studies (i.e.,
418 Australian Temperament Project; Longitudinal Study of Australian Children). Table 3
419 displays outcomes and associated measures that will be used to evaluate MERTIL *for Parents*
420 pre- and post-program.

- 421 1. Parental distress (depression & anxiety): The *Patient Health Questionnaire-4* (PHQ4;
422 35) will measure parent distress, with the two subscales measuring depression and
423 anxiety.
- 424 2. Parenting practices: Parenting practices will be assessed by three parenting
425 dimensions: hostile parenting (4 items), parental warmth (4 items), and parental self-
426 efficacy (1 item; 36, 37).
- 427 3. Social support: the *Maternity Social Support Scale* (MSSS; 38) will determine
428 parents' perceptions of support. Item wording will be modified so items are applicable
429 to all caregivers.
- 430 4. Intimate partner safety: The *Family Law DOORS* (FL-DOORS; 39) will measure
431 partner safety via one item.
- 432 5. Parenting experiences: Select items from the *Perinatal Emotional Growth Index*
433 (PEGI; 40) will assess parenting experiences. Seven items will assess parental
434 confidence (2 items), parenting satisfaction (1 item), parental agitation (2 items), and
435 general reflective capacity (2 items).
- 436 6. Relational attunement: The Interest-Curiosity subscale from the *Parental Reflecting*
437 *Functioning Questionnaire* (PRFC; 41) will measure parents' interest and curiosity in
438 their child's mental states. Two further study-generated questions will assess a
439 parent's capacity to respond to their child's cues: 1) 'I have built trust with my child'
440 and 2) 'I know how to respond to my child's signals'. Response ranges from 1
441 (completely true) - 5 (completely untrue).
- 442 7. Parent-child attachment: The Quality of Attachment subscale from the *Maternal*
443 *Postnatal Attachment Scale* (MPAS; 42) will measure the quality of parent-child
444 attachment. Item wording will be modified so items are applicable to all caregivers.

445 8. Professional help-seeking amenability: A study-specific item was developed by the
446 authors (JM & JO) to assess parent’s help-seeking capacity: ‘I feel able to find and
447 use support from other services in the community?’ with ratings from 1 (not at all) -10
448 (definitely).

453 Parents’ online program usage data will further be automatically collected via the MERTIL
454 *for Parents* website. This will record program engagement and completion elements such as
455 1) program completion rates, 2) number of access occasions, 3) program components
456 most/least accessed.

457 In addition to the above items, in the pre-program and three-months post-program
458 questionnaires, parents will be asked open-ended free-text response questions relating to the
459 program. Pre-program questions will cover hopes for learning, and three-month post-program
460 feedback questions will include items on program components that parents found most
461 useful.

462 Embedded within this study is an internal program evaluation consisting of multiple-
463 choice questions and open-ended text-response questions. Specifically, upon program exit
464 (data collection time two) parents will be asked to complete a five-minute survey relating to
465 program usability and program satisfaction. Example questions asked include: 1) *How useful*
466 *was the program for you, as a parent of a young child?* and 2) *What was most helpful about*
467 *MERTIL for Parents?* This will be sent to parents via email with an attached secure link.

468 *Nurses*

469 After hearing from their parent participants, nurses will be asked to complete a brief mixed-
470 method online survey, allowing insight into nurse perceptions of the program. Questions will
471 include: 1) *Would you recommend MERTIL for Parents to future clients/patients?* 2) *Would*
472 *you recommend colleagues encourage suitable clients/patients to participant in MERTIL for*
473 *Parents?* 3) *From your perspective, does MERTIL for Parents fill a current preventative*
474 *health gap?* 4) *Are there any existing gaps in the MERTIL for Parents program?* For each
475 question response options will be ‘yes’ or ‘no’, and then participants will be asked to expand
476 upon their answer with free text.

477 **Focus groups**

478 To further examine the feasibility and efficacy of MERTIL *for Parents*, focus groups will be
479 held upon program completion. Each group will consist of 4-6 parents or nurses. A semi-
480 structured interview schedule will guide focus group discussions. All focus groups will be
481 audio recorded to allow for later transcription and analysis.

482 **Nurse**

483 Example focus group questions will include: 1) *Could you tell us about your MERTIL for*
484 *Parents experience?* 2) *What was most relevant to you?* 3) *Can you see yourself in the future*
485 *encouraging suitable parents to participate in MERTIL for Parents as a first intervention*
486 *step?* (3) *What are the long-term and short-term implications of programs such as MERTIL*
487 *for Parents?*

488 **Parent**

489 Example focus group questions will include: 1) *Could you tell us what it was like to*
490 *participate in MERTIL for Parents?* 2) *Since completing MERTIL for Parents, what, if*
491 *anything, has changed in your thinking, or feeling, or in your behaviour as a parent?* 3) *In*
492 *MERTIL for Parents, what was most relevant to you?* 4) *Would you recommend MERTIL for*
493 *Parents to other parents?*

494 **Program data management**

495 All MCH nurse and parent survey data will be disseminated through Moodle, an online
496 learning management system stored on a secure server, with data transferred securely for
497 analyses. All study data and participant information will be stored securely as per the criteria
498 required by the La Trobe University Human Ethics Committee.

499 **Data analysis strategy**

500 *Quantitative*

501 All statistical analyses will be conducted using the software IBM SPSS Statistics (43).
502 Descriptive statistics will be generated to identify nurse and parent population characteristics
503 and to evaluate parent and nurse program perceptions. To determine parenting change in dyad
504 attachment, relational function, maternal mental health, from pre-program to three-months
505 post-program, inferential statistics will be used (i.e., univariate, bivariate, and multivariate
506 analyses) such as t-tests, chi-squared analyses, ANOVA, and regression analyses.

507 *Qualitative*

508 *Focus groups*

509 All parent and nurse focus group interview data will be audio-recorded, transcribed verbatim,
510 and deidentified. Thematic and content analysis will be used to identify themes and sub-
511 themes from MCH nurse and parent transcript responses (44).

512 *Free-text surveys responses*

513 For any nurse or parent free-text survey responses, thematic analysis will also be used to
514 identify response themes and sub-themes.

515 **Data collection commencement**

516 Pilot field studies, including recruitment and data collection, will commence in August 2022
517 with data collection concluding in November 2022.

518 **Discussion**

519 **Limitations and challenges**

520 While this study is innovative, we foresee several program content and delivery method
521 limitations: Firstly, it is possible that the brief self-guided content of *MERTIL for Parents*
522 may not provide parents with adequate content information and support (i.e., program dose
523 too low). Second, as a frontline service, MCH nurses may lack the time in session to explain
524 and recommend suitable parents to participate in *MERTIL for Parents*, due to competing
525 demands and scheduling pressures. Third, as the study population pertains only to nurses and
526 parents located in Victoria and New South Wales, Australia, generalisability concerns will be
527 present for inter-state Australian and international populations. Fourth, as all *MERTIL for*
528 *Parents* content is housed online, this may exclude those who lack the technology or skills to
529 participate, especially as on-demand technical support will not be available for live
530 participant trouble shooting. Further, because of this study's non-randomised sampling
531 strategy, cause-effect relationships cannot be drawn. That is, parents' socioemotional
532 outcome changes cannot be causally inferred by their *MERTIL for Parents* participation.
533 Finally, as with all research, there is a risk that attrition rates may be high. All parent data
534 will be self-report in nature, and interpretation of findings will therefore be subject to these
535 limitations.

536 **Strengths and opportunities**

537 There are multiple strengths to the present study: First, the mixed-methods design of this
538 study allows for greater understanding of the program's impact compared with either
539 qualitative- or quantitative-only designs. Second, diversity of parent demographics and needs
540 will be ensured through recruitment of participants from both the Universal and Enhanced
541 MCH services in both metropolitan and regional locations. Third, socioemotional-specific
542 content may fill an important gap in the available online parenting program market. Fourth,
543 the program's reach is expected to be wide due to the online delivery method. Finally, strong

544 completion is expected due to 1) the program’s brief nature, 2) the engaging, non-
545 judgemental, and supportive program content; and 3) the contribution of MCH nurses, infant
546 mental health experts, and parents in co-designing the program.

547 **Conclusion**

548 This study will examine implementation feasibility and efficacy of an evidence-based, online,
549 universal, self-directed parenting program, MERTIL *for Parents*. Multi-informant data from
550 parents and nurses will inform future iterations of MERTIL *for Parents* and universal online
551 relational programs.

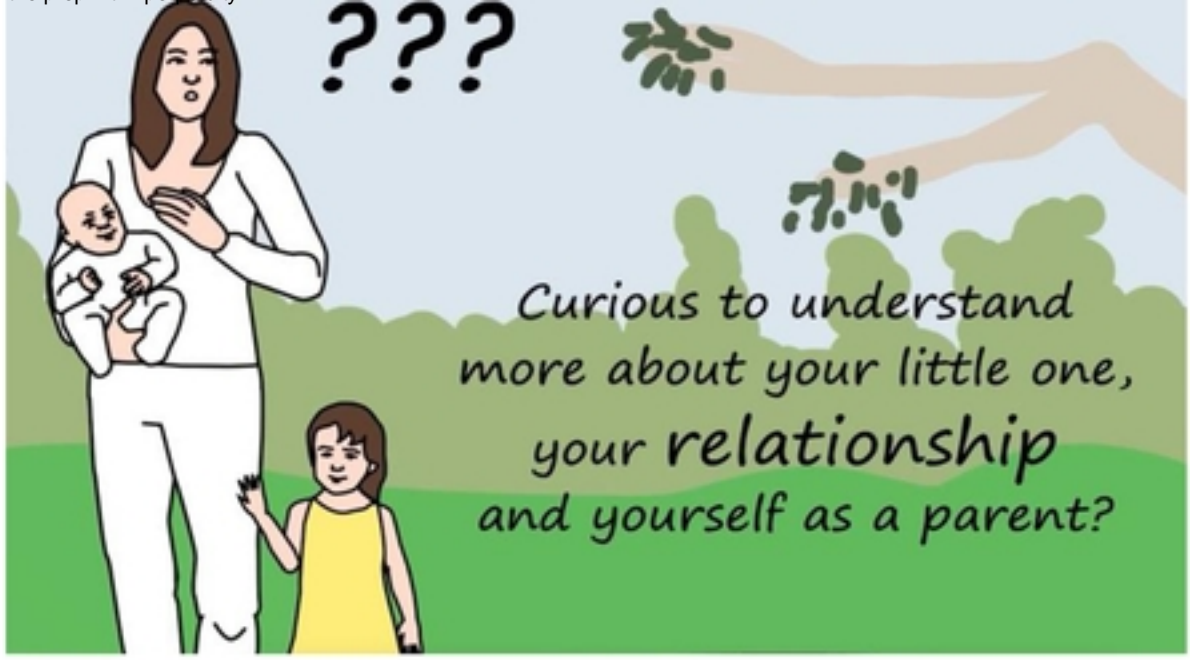

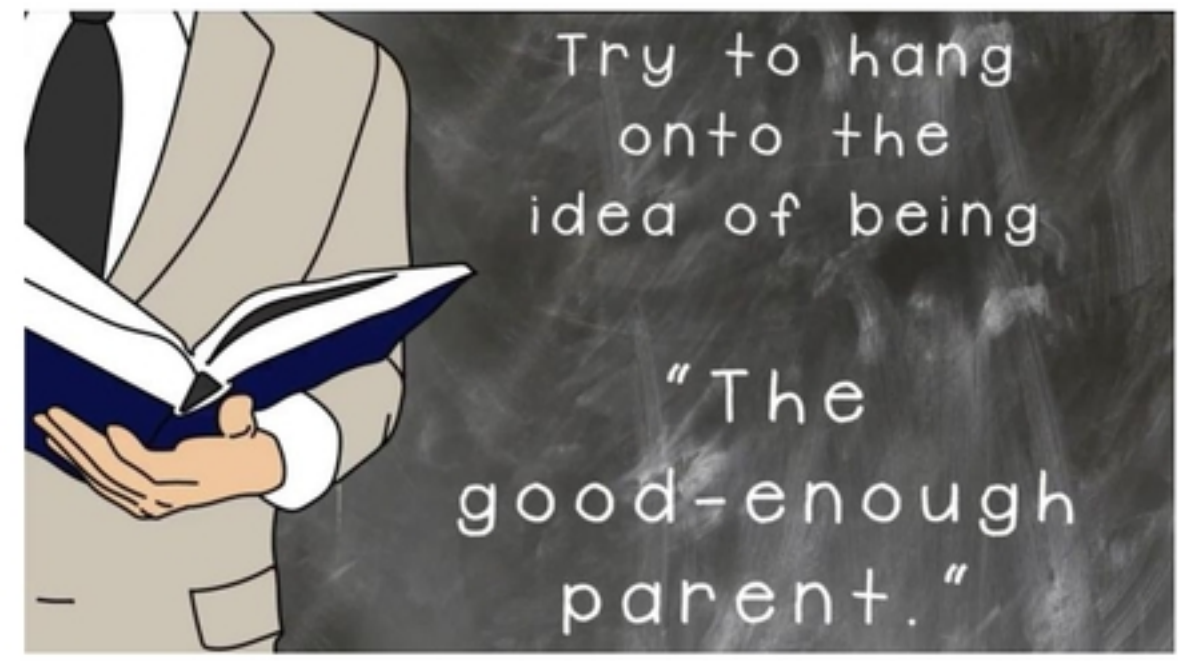
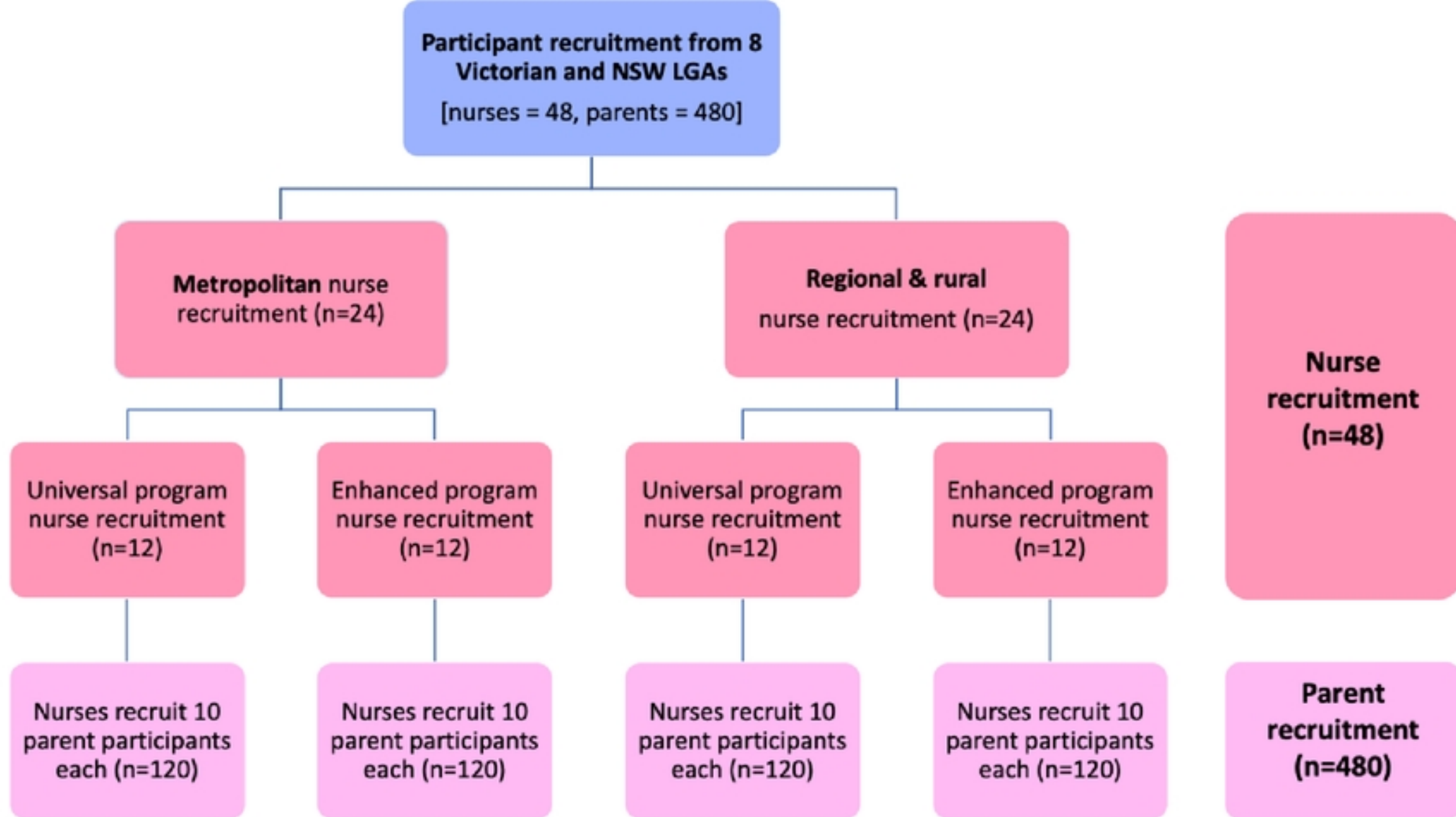
