1	A Mixed Methods Approach Incorporating Text Analytics to Examine Persistence of
2	Depression

27 ABSTRACT

28 **Background:** Some patients' depression persists despite evidence-based interventions; 29 understanding factors associated with depression persistence could inform screening and 30 treatment. We used a novel mixed-methods approach to examine demographic, clinical, and 31 social factors affecting depression persistence among older, low-income women; we also 32 assessed the utility of this approach for evaluating intervention fidelity. 33 Methods: Data used for this study were generated from a comparative effectiveness study 34 comparing the impact of prevention care management (PCM) versus a collaborative care 35 intervention (CCI) on depression among women overdue for cancer screening: We reviewed 700 36 care manager logs to identify themes among patients' experiences and analyzed language use using NVivo[®]'s natural language processing (NLP) functionality. 757 women age 50-64 who 37 screened positive for depression at baseline using the Patient Health Questionnaire (PHQ)-9 and 38 39 were overdue for ≥ 1 cancer screening test (breast, cervical, and/or colorectal) participated. All 40 received primary care in XXX Federally Qualified Health Centers. We used NLP to quantify 41 differences in language use across intervention groups and explored how often themes appeared 42 in logs of participants whose depression did not meaningfully improve based on PHQ-9 scores. 43 Differences in demographic, clinical, and social factors were examined. 44 **Results:** Participants with persistent depression were more likely to discuss pain, fear, and 45 transportation. Asthma and anxiety were associated with lower likelihood of depression 46 remission, while no differences were observed in depression remission rates among those with 47 diabetes or hypertension. Patient-centered words, including "needs" and "feelings", were more 48 common in the CCI group, while procedure-related words, like "screening" and 49 "mammography", appeared more frequently in the PCM group.

50	Conclusions: Patient-related factors and social barriers contributed to depression persistence.	
51	NLP identified patterns of language use in case logs, suggesting unmet needs among depressed	
52	patients. NLP is an efficient, effective method for identifying themes in unstructured text and	
53	monitoring intervention fidelity.

59 1. BACKGROUND AND SIGNIFICANCE

Depression is a common condition with serious implications for individual and 60 population health.¹⁻³ Depression disproportionately affects women and older adults.¹ Individuals 61 with depression are more likely to experience poorer health outcomes.^{4,5} engage in health-risk 62 behaviors,⁶ and incur higher healthcare costs.⁷ Depression is also associated with significant 63 societal costs due to decreased worker productivity and absenteeism.^{8,9} The World Health 64 65 Organization estimates depression and anxiety disorders account for over one trillion dollars in expenditures from productivity losses alone.¹⁰ Depression among older patients is associated 66 with functional decline,¹¹ disability,¹² increased use of primary care, and reduced health-related 67 quality of life.^{7,13} While effective treatments are available, many patients do not receive them.¹⁴ 68 69 Moreover, research suggests that some patients' depression persists despite evidence-based interventions.^{8,15,16} Improving our understanding of factors associated with depression 70 71 persistence could inform targeted screening and treatment.

72 Research suggests factors associated with depression include: personal or family history, 73 exposure to physical or psychological trauma, and chronic medical and psychological conditions such as hypertension, diabetes, asthma, and anxiety.^{2,17-19} Particularly among older adults, social 74 75 and environmental factors, including isolation, loneliness, and lack of community engagement also play a crucial role in psychological well-being.^{17,20,21} Formal examinations of associations 76 77 between social determinants of health and psychological well-being are challenging. Social 78 determinants are often not assessed in clinical encounters. When they are, they are rarely 79 captured in structured data fields in electronic health records (EHRs) which limits the utility of traditional quantitative analytic techniques in studying these associations.²² 80

81 Natural language processing (NLP) is an advanced form of qualitative analysis that 82 employs algorithms to interpret and manipulate language. Text analytics is a type of NLP which translates patterns in text into data suitable for thematic and quantitative analysis.²³ These 83 84 techniques demonstrate promise in analyzing unstructured clinical data. Orescovik et al. (2017) 85 highlighted the effectiveness of NLP in predicting need for additional services among patients with "high-risk social determinants of health." ²⁴ Edgcomb et al (2021) used NLP to differentiate 86 risk of suicide attempts and self-harm among women with mental illness.²⁵ 87 88 Previously, we completed a randomized controlled comparative effectiveness study 89 among depressed women overdue for at least one cancer screening test (breast, cervical or 90 colorectal) We randomized 757 English or Spanish speaking women to two different 91 interventions. We observed that change in depressive symptoms acted as an effect modifier in 92 the relationship between the intervention and receipt of age-appropriate cancer screening. Those 93 whose depression did not improve or only improved modestly were less likely to be up to date 94 with cancer screening tests at the end of the study. 95 To better understand why some patients' depression persisted despite evidence-based 96 interventions, and to ensure that our observations were not the result of contamination between 97 study arms, we used a mixed-methods approach to examine differences in the content of case 98 logs maintained by care managers who delivered the interventions in this study. Our approach 99 incorporated quantitative analysis as well as text analytics. We compared language use between 100 participants in each study arm as well as between participants whose depression had and had not 101 improved significantly at 12-month follow-up. We also explored the impact of selected baseline 102 covariates, including anxiety, chronic medical conditions, and highest attained education level on 103 depression outcomes.

104 **2. OBJECTIVES**

105 Our study objectives were to:

106 1) Identify factors associated with depression persistence by examining differences in the content

- 107 of case logs maintained by care managers in each intervention arm;
- 108 2) Assess fidelity of interventions.
- 109 **3. METHODS**

110 **3.1 Participant population**

111 Sampling strategy and practice sites are described in detail elsewhere.^{27,28} Our study 112 included 757 women ages 50-64 who screened positive for depression at baseline (PHQ-9 \ge 8) 113 and were overdue for at least one cancer screening test (breast, cervical, and/or colorectal). All

114 participants received primary care at one of six Federally Qualified Health Centers (FQHCs) in

115 Bronx NY. A total of 379 women were randomized to PCM and 378 to CCI. For this secondary

analysis (i.e., focus of this paper), we excluded participants with no PHQ-9 recorded at 12-month

117 follow-up (n=126), and participants without case logs (n=25). There was some overlap between

118 these cases, resulting in 128 excluded participants.

119 **3.2 Interventions**

Both study arms involved monthly participant intervention calls performed by separate, project-supported care managers who were study staff working on-site at the health centers. The CCI care managers provided support and patient navigation regarding cancer screening needs and mental health, including past and present participation in mental health treatment, including whether the participant was currently taking antidepressant medications and/or participating in therapy. PCM care managers addressed only barriers to cancer screening.

126 Appendix A contains additional detail about each intervention. To ensure fidelity in the 127 PCM and CCI intervention protocols, separate weekly supervisory meetings were conducted 128 with both PCM and CCI care managers to review the number of calls completed, content of calls, 129 and barriers to implementation. 130 Care managers for both groups kept electronic narrative records or case logs of each 131 discussion they had with study participants. Data were maintained in secure, password-protected 132 files using REDCAP and included: date, duration, and type of encounter (telephone, in person); 133 screening tests received since last call; upcoming primary care and cancer screening 134 appointments; barriers to cancer screening; and readiness to obtain overdue cancer screening 135 tests. 136 **3.3 Data collected** 137 Unstructured data were found in the form of case logs. Structured data were obtained 138 from self-report surveys or the participant's electronic health record (EHR) and included: PHQ-9,³² Generalized Anxiety Disorder (GAD)-7,³³ age, race/ethnicity, language, education level 139 140 attained, and diagnoses of asthma, hypertension, diabetes, and hyperlipidemia. 141 PHQ-9 scores were obtained by study staff at baseline and twelve-month follow-up. Due 142 to variation in participants' baseline depression status, we sought to detect all clinically 143 meaningful improvements in depression rather than only complete remission of depressive 144 symptoms. Our approach allowed us to capture both modest reductions in depressive symptoms 145 among those with less severe depression at baseline, as well as clinically significant reductions 146 among those with more severe depression at baseline, who in some cases still met criteria for 147 depression according to the PHQ-9. We created two variables corresponding to change in 148 depression symptoms: clinically meaningful improvement (CI) (yes=PHQ-9 < 8 at twelve-month

follow-up or a 50% reduction from baseline)³⁴ and depression remission (OR) (yes=PHQ-9 <5 at twelve-month follow-up).³⁵ Anxiety was defined as a GAD-7 \ge 10 at baseline.³⁵

151 **3.4 Unstructured qualitative data analysis**

152 We first conducted a manual review of 700 case logs to identify recurrent themes. Once 153 we reached theme saturation, we created a list of terms mapping to those themes displayed in Table 1. We then conducted textual analysis using NVivo[®] software for Mac[®] version 12. We 154 155 generated word frequencies for the entire sample and examined PCM and CCI groups 156 individually, using targeted queries to compare word frequencies between the two intervention arms to assess fidelity. We used the NVivo[®] word "stem functionality," which allows the 157 158 investigator to search for a group of similar terms with a common stem (i.e., "sick*" which 159 includes: sick, sickness, sickly, sicker, sickest, sickening) and generated word clouds and tables 160 summarizing frequency of word use to examine data within groups. We then used matrices to 161 examine differences in frequency of word use across groups. Word trees were used to facilitate 162 an understanding of how terms were being used and inform our interpretations. We also used NVivo[®] to create datasets pertaining to the frequency with which themes were mentioned and 163 164 compared those proportions between participants who experienced/did not experience (a) 165 clinically meaningful improvement; or (b) depression remission.

166 **3.5 Quantitative analysis**

For quantitative analyses, we used the datasets generated from NVivo[®] to compute chi squares and compare the frequencies with which specific themes appeared in case logs of those whose depression did versus did not significantly improve and did versus did not remit. We used logistic regressions with depression significantly improved (0=depression not significantly improved, 1=depression significantly improved) and depression remitted (0=depression not

172	remitted, 1=depression remitted) as the outcome variables to examine the impact of age and		
173	comorbid chronic conditions, including asthma, anxiety, and hypertension on depression		
174	outcomes. We conducted both univariate and multivariate analyses using SAS [®] version 9.4 for		
175	PC.		
176	4. RESULTS		
177	4.1 Participant characteristics		
178	After excluding participants missing case logs or a PHQ-9 score at 12-month follow-up,		
179	there were 629 participants (81%) included in this analysis. The PCM and CCI groups were		
180	comparable with respect to age, race/ethnicity, language, and highest level of education attained.		
181	Table 2 contains basic descriptive information for these participants. The mean ages were 55.9		
182	years (Standard Deviation (SD)=4.2) and 56.2 years (SD=4.25) in the PCM and CCI groups,		
183	respectively. In both groups, for approximately 25% of participants, the highest level of		
184	education attained was less than 8 years. 81% of participants in the PCM group and 78% of		
185	participants in the CCI group identified as being Hispanic. Spanish was the preferred language		
186	for more than half of participants in both groups.		
187	4.2 Manual review of case logs		
188	A manual review of case logs revealed a number of different themes. Case-log texts		
189	corresponding to each theme are displayed in Table 3.		
190	4.3 Differences between study arms and assessment of intervention fidelity		
191	Notable differences were observed between the text from case logs for PCM and CCI		
192	arms. The most commonly used terms were: "patient," "screens," "cancer," "up to date,"		
193	"barriers," and "assessment." For the CCI group, "patient" was the most common term, used		
194	over 3,000 times throughout case logs (weighted percentage = 5.6%). In the PCM group,		

195 "patient" was the fifth most common term used with a weighted frequency of 2.0%. In the PCM 196 group, "screening" was the most common term with a weighted percentage of 3.7%, whereas 197 "screens" was the second most commonly used term in the CCI group with a weighted 198 percentage of 2.9%. Other notable differences between these groups included higher frequency 199 use of the words, "feelings," "hospital," and "needs" among the CCI group, and a higher 200 frequency of the procedure-related words including, "colonoscopy" "mammogram," "scheduled" 201 among the PCM group. Figure 1 displays word clouds for the case logs of participants in the 202 PCM vs. CCI intervention groups, respectively. The size and position of the word correspond to 203 the frequencies with which each word appears (larger words that are more central are the most frequently used).¹ 204

205 **4.4 Differences by baseline PHQ-9 score**

The range of PHQ-9 scores at baseline was 8-24 compared to 0-24 at the 12-month follow-up. Nearly 40% of participants (292/763) experienced clinically significant improvements in their depressive symptoms, and nearly 50% (355/763) of participants' depression remitted; these rates did not differ between intervention groups.

Patients with higher baseline PHQ-9 scores were less likely to experience clinically significant improvements and/or remission of depression symptoms during the study period. The percentage of participants whose depression significantly improved with a baseline PHQ-9 of 9 was 25% lower than that among participants with a baseline PHQ-9 of 8. Similarly, only 4% of participants with a baseline PHQ-9 score of 15 experienced a clinically significant improvement in their depressive symptoms, compared to 16% with a baseline PHQ-9 of 8.

4.5 Differences by clinically significant improvement in depression versus not

Figure 2 compares the word clouds for case logs of participants whose depression did and did not significantly improve (because we did not observe a significant difference in depression outcomes between the two intervention arms, we combined both groups for this analysis). On visual inspection, the frequency of word use does not differ between the two groups, with words such as "barriers" appearing with equal frequency.

Mention of fear was slightly less common among those whose depression improved (OR = 0.83, 95% CI: 0.4, 1.7, chi-square=0.26, p=0.61). However, with respect to social determinants of health, those whose depression significantly improved were about a third as likely to report issues related to transportation as those whose depression did not significantly improve (OR=0.3, 95% CI: 0.085, 1.02, chi-square=4.2, p=0.04). Those whose depression had improved were nearly twice as likely (OR = 1.7; 95% CI: 1.1, 2.7, chi-square=5.5, p=0.02) to discuss financial hardships with their care manager as those whose depression did not.

229 Table 4 displays differences in the frequency of references to specific themes and number 230 of unique participants referencing those themes among those who did and did not experience a 231 clinically meaningful improvement in their depressive symptoms. At the case-log level, there 232 were differences in the percentages of case logs referencing death, illness, housing, pain, or 233 substance use across these two groups. We observed 176 references to pain among 51 unique 234 patients whose depression had not improve compared to 74 references among 24 unique patients 235 whose depression had improved. There were 459 references to sickness or illness among 123 236 unique patients whose depression had not improve compared to 358 references among 81 unique 237 patients whose depression had improved.

4.6 Differences between those whose depression remitted vs. not remitted

Participants whose depression had not remitted by the end of study were almost three times more likely to discuss pain (OR = 2.75; 95% CI: 1.4, 5.2) as well as fear (OR = 2.5; 95% CI: 1.0, 6.2). These participants were also more likely to discuss issues related to transportation (OR = 1.6, 95%: CI: 0.61, 4.2). The word "barriers" appeared almost twice as frequently among participants whose depression remitted (3.05% vs 1.87%). References to substance use problems were comparable between groups.

246 **4.7 Differences according to comorbidities**

247 Univariate analysis using structured data revealed that participants with comorbid anxiety 248 at baseline were significantly less likely to experience clinically significant improvements in 249 their depressive symptoms at the twelve-month follow-up (OR = 0.34, 95% CI: 0.244, 0.483). 250 Participants with asthma were about half as likely (OR = 0.58, 95% CI: 0.41, 0.80) as those 251 without asthma to report a clinically significant improvement. Participants with diabetes and 252 hypertension were slightly less likely to experience improvements in their depression symptoms 253 (OR = 0.83 and 0.85, respectively), but neither association was statistically significant. 254 Multivariate analysis revealed that both asthma and anxiety were associated with a significantly 255 lower likelihood of experiencing improvements in depressive symptoms. Participants with 256 as the asthma were about two thirds as likely (OR = 0.65, 95% CI: 0.458, 0.933) as those without 257 asthma to report remission of depressive symptoms. Neither hypertension nor diabetes appeared 258 to be significantly associated with remission of depression. Multivariate analysis revealed that 259 anxiety was the only factor significantly associated with a decreased likelihood of remission of 260 depression (OR = 0.35, 95% CI: 0.25, 0.50), while asthma approached statistical significance 261 (OR = 0.74, 95% CI: 0.513, 1.076).

262 **5. DISCUSSION**

263 In this study of low-income women residing in Bronx NY, multiple patient-related and 264 social factors were associated with improvements and remission of depression over the twelve-265 month study follow-up period. These included chronic pain, fear, financial issues, and 266 transportation difficulties. Additionally, participants with comorbid anxiety or asthma were 267 significantly less likely to report clinically significant improvements in depressive symptoms or 268 remission of depression at the end of the study. Results from NLP indicated that more frequent 269 use of procedure-focused terms in the PCM arm and patient-centered terms in the CCI arm. This 270 difference provided evidence of the maintenance of intervention fidelity for the two intervention 271 arms. These findings also suggest that NLP can be a valuable tool in analyzing unstructured, 272 qualitative data to assess patient factors as well as intervention fidelity in health services 273 research.

Notably, some differences in language use observed at the case-log level were not
statistically significant at the patient level. This suggests certain issues recurred among a small
subset of participants whose depression persisted, despite the evidence-based interventions. This
finding has important implications for future efforts to leverage the use of NLP-type approaches
for analyzing unstructured, qualitative data for identification of high-risk groups and for
monitoring treatment outcomes.

The fact that case logs of participants whose depression did not remit were nearly three times more likely to contain mention of pain supports previous work demonstrating a higher prevalence of chronic pain among those with more severe depression.³⁶ Tsuji et al (2016) also observed greater functional limitations among participants with comorbid depression and chronic pain, as opposed to those with either condition alone.³⁷⁻³⁹ Similarly, more frequent use of terms

285 related to transportation among those whose depression did not improve or remit adds to 286 previous research which suggests that transportation difficulties can present a major but 287 modifiable barrier to accessing appropriate healthcare services that has a significant impact on clinical, social and emotional well-being, particularly among the older adults.^{40,41} A recent study 288 289 conducted in the United Kingdom revealed that providing older adults with free bus passes was associated with significant reductions in depressive symptoms and feelings of loneliness.⁴² Manv 290 291 FQHCs provide transportation allowances (subway or bus passes) to enhance access to care and 292 related services⁴³; future research should build in coverage for these types of benefits in order to reduce or eliminate access barriers.⁴⁴ This finding also underscores the value of using a 293 294 community-based approach when designing interventions to address depression, particularly 295 among older patients for whom loneliness and social isolation appear to play a larger role in 296 emotional well-being.44

The case logs of those whose depression improved were nearly twice as likely as those whose depression did not improve to mention financial issues. This finding is inconsistent with previous research that found a positive association between financial hardship and depression.⁴⁵ However, this finding within the context of our study may reflect that participants shared information about past financial issues or articulated how they became connected with resources and services that improved their financial situation.

303 Co-occurrence of both asthma and anxiety was associated with a lower likelihood of both 304 clinically significant improvements in depression and remission of depression. Previous 305 literature supports a higher prevalence of depression among patients with asthma,^{46,47} as well as a 306 higher likelihood of poor asthma control among those with comorbid depression.^{48,49} We are 307 unaware of previous studies, however, reporting that patients with comorbid asthma may also

308 suffer from depression that persists despite intervention. Higher rates of persistence of

309 depression among those with comorbid anxiety could explain high rates of co-occurrence

310 between these conditions throughout the lifespan and argues for the need for better integration of

311 mental and behavioral health services into primary care.^{50,51}

312 We observed clear differences in language use between the CCI and PCM study arms.

313 More frequent use of patient-centered terms such as "patient," "feelings," and "needs" in the CCI 314 arm suggest that, as intended, care managers in this study arm were more likely to address issues 315 related to participants' mental health. In contrast, more frequent use of procedural terms, such as 316 "screening" and "mammogram" indicate that care managers in the PCM arm were more focused 317 on addressing needs related to cancer screening. These findings suggest that efforts to prevent 318 and/or minimize contamination between study arms were successful and lend further support to 319 value offered by NLP, and text analytics in particular, when analyzing unstructured clinical 320 notes. We believe this approach offers an efficient automated approach to demonstrating both 321 clinical process quality and treatment fidelity. Moreover, in the current healthcare climate with 322 increased use of telemedicine, we believe this methodology may be a useful tool in assessing 323 consistency and quality of remote clinical consultations.

This study had several limitations. First, the case logs were manually recorded by the care managers and not by the participants themselves. Due to privacy concerns, calls were not audio recorded. Direct audio recording with automated transcription of the care management calls would have reduced documentation errors. Furthermore, documentation practices may differ between care managers despite their extensive training which might have contributed to selection bias by focusing on known barriers that the intervention was designed to address. Improvements observed in depression over the study period may be due to the natural history of depression or

331 due to regression to the mean, or some combination of both, rather than resulting from the 332 putative mechanisms of either intervention; alternatively, the focus of both interventions on 333 overcoming barriers to accessing care may have had similar non-differential effects on both 334 cancer screening and depression outcomes. Lastly, there may be limitations of using more 335 traditional quantitative analytic approaches when interpreting patterns in language use. More 336 work is needed to examine the utility of these methods in analyzing unstructured, qualitative 337 data. In developing our coding scheme for textual analysis, we relied on our judgment to develop 338 a group of search terms associated with each theme, which may have compromised the 339 sensitivity of our results. Future work could incorporate weighting in order to capture and fully 340 assess the salience of certain themes between groups.

341 6. CONCLUSIONS

342 This study highlights the importance of certain patient-related and social factors such as 343 chronic pain, comorbid chronic conditions (e.g., anxiety and asthma), and access barriers such as 344 transportation in predicting depression improvement among older, low-income women. 345 Moreover, using text analytics, we identified different patterns of language use between 346 intervention arms, as well as between those whose depression improved or remitted versus those 347 whose depression did not change. This suggests these emerging computerized qualitative 348 methods, when combined with quantitative data in a mixed methods study, can provide novel 349 insights into a variety of methodologic and quality of care issues, including automated 350 monitoring of intervention fidelity and prediction of response to treatment. 351 **CLINICAL RELEVANCE STATEMENT** This study demonstrates the utility of natural language

352 processing in understanding factors underlying depression persistence in a sample of women

ages 50-65. Whereas the use of quantitative analysis only did not offer insight into why some

- 354 patients' depression persisted one year after study initiation, using NLP to analyze unstructured
- 355 clinical data allowed us to identify a number of factors, including social determinants of health,
- that predicted persistence of depressive symptoms.

357 MULTIPLE CHOICE QUESTIONS

- 358 1) In this study, natural language processing was used to do all of the following, except
- a. Assess fidelity of intervention arms
- 360 b. Assess depression severity
- 361 c. Identify factors associated with depression persistence
- 362 d. Explore differences in language use between study groups

363 The correct answer is **B**. We did not use natural language processing to assess depression

364 severity. The PHQ-9 was used to assess depression severity at both the outset of the study as well

as at the conclusion of the study, 12 months later. Changes in depression severity as measured by

the PHQ-9 were the primary outcome of this study. We used natural language processing to

367 understand factors associated with differences in our study outcome. NLP was used to assess

368 fidelity of treatment arms. This was done by comparing language use in the case logs of

369 participants in both study arms, wherein we did observe notable differences. NLP was also used

to identify factors associated with depression persistence by exploring differences in language

- 379 participants' case logs was associated with an increased likelihood of persistence of depressive

- 381 Our analyses did not reveal any associations between age and likelihood of depression
- 382 persistence, nor did they reveal any differences in the likelihood of depression persistence based
- 383 on where primary care was received. All study participants were women.
