28 Abstract

Background: Obesity (body mass index greater than or equal to 30kg/m^2) is a major global public

30 health problem. It is spreading very fast in low- and middle-income countries and has reached world

31 record levels in some of them. In Ghana, it has increased by over 65% among urban women in the 32 past three decades. This study investigated the effects of social determinants of health on obesity

33 among women in urban Ghana.

34 **Methods:** The study analysed the Ghana demographic and health survey data. These are nationally 35 representative data collective every five years across low- and middle-income countries. A total of

36 1,204 urban women were included in the analysis. The outcome variable of interest was body mass

37 index. We used logistic regression to model the effects of the various social determinants of health on

38 obesity.

39 **Results:** The results showed that 40% (95% confidence interval (CI)=25.4, 57.0) and 36.7% (95%

40 CI=25.6, 49.3) of women who had higher education and those whose partners had higher education 41 suffered from obesity, respectively. Women living in rich households had a five times higher

42 prevalence of obesity than those in poor households (28.8% vs 5.7%). Further, 33.4% (95% CI=18.5,

43 19.3) of women who occupied managerial positions were obese. The results from the multivariable

44 logistic regression analysis suggested that compared to women in poor households, those in rich

45 households were 3.4 times (95% CI=1.31, 8.97) more likely to suffer from obesity. Women whose

46 main occupation was agriculture were 81% (aOR=0.19; 95% CI=0.034, 0.99) less likely to suffer

47 from obesity than those with no occupation.

48 Conclusions: The results suggest that the various SDHs significantly influence women's obesity.
 49 Women and partner education levels, occupying a managerial position, and living in rich households
 50 increase the risk of obesity. Interventions to address the rising obesity in urban Ghana should have

51 specific packages targeted at these sub-groups.

63 Introduction

64 Obesity (body mass index greater than or equal to 30kg/m2), an indicator of excessive fat accumulation in the body tissues, is a growing global problem of public health concern (1, 2). 65 Obesity is an illness that requires deliberate policies and interventions to address it to prevent 66 67 premature deaths among the world's population (2). The available data suggest that since 1975, the global burden of obesity has more than tripled (3). The data also suggested that no country has 68 experienced a decline in obesity prevalence over this period. Therefore, it is unsurprising that in 69 70 2000, the World Health Organisation (WHO) declared obesity a pandemic, which informed the 71 development of a global action plan to combat it (4). Further evidence suggests that obesity is more 72 severe among women of reproductive age than men and in urban settings than rural (3).

73

74 Obesity is spreading very fast in developing countries and has reached world record levels in some of them (5). In Africa, the obesity prevalence among women of reproductive age ranged from 6.5 to 75 76 50.7% (6). The problem is most severe among urban women relative to rural women (7). Similarly, a 77 recent analysis (2) using urban data from 24 African countries, spanning almost three decades, 78 showed that all the countries included in the study experienced a substantial increase in obesity 79 among women of reproductive age. Indeed, a country such as Ghana recorded as high as 65% 80 increase in obesity during the study period [2]. Other studies also observed alarming trends in obesity among women of reproductive age in the African region (8-9). There is a need for deliberate policies 81 82 by governments to address the problem. However, it is not the case because many policymakers are 83 yet to appreciate that the African continent is sitting on an obesity time bomb waiting to explode. 84 Therefore, it is critical to provide policymakers and other stakeholders with evidence of the 85 seriousness of the problem and its potential drivers. The current analysis intends to provide such evidence to policymakers and program planers. 86

The consequences of obesity on population health are enormous. It is associated with an increased 88 89 risk of cardiovascular diseases (mainly heart disease and stroke), diabetes, musculoskeletal disorders, 90 and some cancers, including but not limited to endometrial, breast, ovarian, prostate, liver, 91 gallbladder, kidney, and colon (10). An analysis of recent data suggests that obesity is linked to 13 92 different cancers (11). Further, the effect of obesity on the incidence of gestational diabetes, pre-93 eclampsia, high risk of miscarriage/stillbirth, and congenital anomalies is well documented (12-14). 94 Pregnant women who are obese have higher chances of heart disease, hypertension, and type 2 95 diabetes (15). The link between women obesity and future obesity in their children has also been 96 observed (16).

97

98 Similarly, the extant literature suggests a strong link between obesity and high mortality rate. An 99 analysis of global data shows that 2.8 million people die annually due to obesity (17), while 35.8 100 million disability-adjusted life years (DALYs) are attributed to elevated body mass index (BMI) (18).

101 The adverse effects of obesity on population health, as outlined above, calls for a more detailed

analysis to understand the determinants of obesity among women of reproductive age.

- 104 Previous research suggests that social determinants of health are key drivers of the rising obesity in
- 105 urban Africa (19, 20). According to the WHO commission, "Social determinants of health (SDH) are 106 the conditions in which people are born, grow, live, work and age, and the wider set of forces and
- 107 systems shaping the conditions of daily life" (3). The SDH includes socioeconomic status, education,
- 108 literacy, neighborhood and physical environment, employment, food consumption, place of residence
- and social support networks, and access to health care. The literature on the effects of socioeconomic
- 110 status, education, and employment status, among others, abound (21). However, the impact varies
- 111 between low- and high-income countries. While obesity is a significant issue among the rich in low-
- 112 income countries, it is high among the poor in high-income countries (22).
- 113

114 Similarly, obesity was more prevalent among highly educated women than those without formal 115 education in low-income countries (23). Women who are formally employed have increased odds of 116 obesity compared to those who are not employed, which vary by educational attainment (24). This 117 could be attributed to increased income and behavioral changes related to the time allocated to 118 physical activity. Further, evidence suggests a link between urbanization, nutritional transition, and 119 the high prevalence of obesity among women (25). There have been increasing changes in food 120 consumption, whereby urban dwellers now consume more processed and fast foods and sugary 121 beverages, with consequential adverse effects on obesity outcomes (25, 26).

Although our recent analysis suggests that obesity among women of reproductive age has been rising rapidly in urban Ghana in the past decades (2), there is limited knowledge on the key SDH driving the surge. The present study intends to fill this gap by undertaking a comprehensive analysis of obesity prevalence by various SDH, and the effects of the SDH on the rising obesity in urban Ghana, drawing on existing data sources. This type of analysis is needed to provide detailed and nuanced findings for better decision-making to inform policy and program interventions to address the obesity

- 129 challenges in urban Ghana.

131 Materials and Methods

132 Data sources and study design

The study is a secondary analysis of the Ghana Demographic and Health Surveys (DHS) data (27). These are nationally representative data collected every five years in low and middle-income countries (LMICs) (27). The analysis in the current study is restricted to the urban sub-sample. We downloaded the data from the DHS program website and assessed their completeness regarding the women's anthropometry data. We excluded cases that were missing anthropometry data.

The DHS utilizes a complex sampling design, whereby the sample selection involves multiple stages.
In the first stage, clusters are selected from a master sampling frame constructed from the Ghana
National Population and Housing Census data. The clusters are selected using systematic sampling
with probability proportional to size. After selecting the clusters, a household listing operation is
undertaken in the selected clusters to get a sampling frame to select households to take part in the

study. It is followed by systematic sampling of households. This stage of selection is aimed to ensure an adequate sample size to estimate the indicators of interest with acceptable precision. Our analyses are restricted to adult non-pregnant women aged 15–49 years. We focus on non-pregnant women because pregnancy is usually associated with weight gain. Therefore, including them in the analysis may present a misleading picture of the obesity situation. The eligible sample size used in the present analysis was 1,204 urban women of reproductive age.

151 Ethics statement

152 The DHS study was undertaken based on high ethical standards, whereby data collectors were trained to respect the rights of study participants. The participants were made to understand that they have 153 the right to decide whether they wanted to participate in the study or not, as well as to abstain or 154 155 withdraw their participation at any time without reprisal. The potential risks and benefits associated with the study and steps taken to mitigate potential risks were adequately explained to study 156 157 participants. A government-recognized institutional review committee granted ethical approval for 158 the conduct of the study. Further ethical clearance was granted by the Institutional Review Board of 159 ICF International, USA before the surveys were conducted. The authors obtained permission from 160 DHS Program for the use of the data. The authors did not seek further ethical clearance as the DHS 161 data are highly anonymized.

163 Measures

164 *Outcome variable*

The women's body mass index (BMI) was the outcome variable of interest in this analysis. Well-165 trained field technicians collected women's anthropometry data (Height and weight) using 166 167 recommended techniques (28). The weight of study participants was measured using electronic Seca scales, while their height was measured using boards produced by Shorr Productions. These 168 169 anthropometric data (weight and height) were used to estimate the BMI of study participants. The 170 BMI was calculated by dividing weight in kilograms by the square of height in meters. Based on the WHO guidelines (28), obesity was classified as BMI≥30.0 kg/m2. The prevalence of obesity and its 171 172 associated factors were estimated. In the DHS dataset, place of residence is classified into rural and 173 urban. However, this study focuses only on urban settings. Our previous analysis (2), which suggests 174 that obesity is rising very fast in urban Ghana informed the choice of the study setting.

175 Explanatory variables

176 The SDH factors used in this analysis included women's education level, employment status, fruit 177 and vegetable consumption, partner occupation, partner education level, household wealth index, number of trips in the last 12 months, frequency of listening to radio, and sex of household head. 178 179 Potential control variables included women's age, height, and breastfeeding status. The household wealth index, a composite measure of the household cumulative living standard, was constructed 180 181 using principal component analysis (PCA) (30). The variables used in the PCA included household 182 ownership of televisions and bicycles, materials used for housing construction, and types of water 183 access and sanitation facilities. The constructed wealth index is then divided into quintiles (poorest, 184 poor, middle, rich & richest). To preserve the sample size for the analysis, we recoded the wealth

185 index into poor (poorest+poor), middle, and rich (rich+richest). The potential SDHs outlined above 186 were identified based on the SDH literature. These variables were subjected to bivariate analysis to 187 establish those associated significantly with women's obesity. Statistical significant variables were 188 included in the multivariable analysis. In addition, we included variables that were not statistically

189 significant but considered critical as far as obesity was concerned.

191 Analytical strategy

192 The data analysis was performed using STATA V.14. The analyses involved three stages. In the first 193 analysis, we assessed the characteristics of the sample using frequencies and means. A data file was constructed using a place of residence, country, survey year, and sample size. In the second stage, we 194 195 estimated the prevalence of obesity and their associated 95% confidence intervals (CIs) by various 196 SDH. In the third analysis, we examined the effects of SDH on maternal obesity using multivariable 197 logistic regression. We entered SDH variables in the first model (model 1), and adjusted for women's 198 age, height, and breastfeeding status in the second model (model 2). Adjusted odds ratio (aOR) and 199 CI are reported for this analysis. We accounted for the complex survey design (CSD) effect in all

- analyses using the *svyset* and *svy* procedures in STATA.

202 Results

203 Background characteristics of the study sample

Table 1 (Annex A) presents the characteristics of the study sample. The average age of study participants was 31 years (30.85 ± 6.29), while the average height was 1.59m (1.59 ± 0.06). Majority (59%) of the women had secondary school education, while only 6% had tertiary/higher education. This was similar to the partner education level where 59% had secondary education. Similarly, 52%of the women had clerical/sales/services as their main occupation. However, the dominant occupation of their partners was manual work (45%). The results also suggested that over 40% indicated they consumed fruits (42%) and vegetables (45%) for 4 or more days in the past 7 days.

214 **Prevalence of obesity among women by the SDH**

215 Table 2 (Annex B) shows the prevalence of obesity by various SDH. The results showed that 40% 216 (95% confidence interval (CI)=25.4, 57.0) of women who had higher education were obese, while 217 only 14.4% (95% CI=8.6, 23.0) of those with no formal education suffered from obesity. Also, 218 36.7% (95% CI=25.6, 49.3) women whose partners had higher education were obese. The prevalence 219 of obesity was 28.8% (95% CI=24.1, 34.0) among women living in rich households compared to 220 5.7% (95% CI=2.4, 13.0) of those in poor households. Further, 33.4% (95% CI=18.5, 19.3) of 221 women who occupied managerial positions were obese. Conversely, only 1.8% (95% CI=0.4, 7.8) of 222 those whose occupation was agriculture were obese. Women whose partners held managerial

positions suffered more from obesity than those whose partners were agricultural workers (33.6 vs.
 7.2%). All the above results were statistically significant.

227 Association between social determinants of health and women's obesity

228 Table 3 (Annex C) presents the effects of SDH on obesity among women. The results showed that 229 compared to women in the poor wealth quintile, those in the rich quintile were 3.4 times (95% 230 CI=1.31, 8.97) more likely to be obese. Women whose main occupation was agriculture were 81% 231 (aOR=0.19; 95% CI=0.034, 0.99) less likely to suffer from obesity than those with no occupation. 232 Similarly, women whose partners' occupation was agriculture worker had 71% (aOR=0.39; 95% 233 CI=0.15, 0.99) reduced odds of suffering from obesity compared to those whose partners were 234 manual workers. Partners attaining primary education had a moderate protective effect on obesity 235 among women (aOR=0.34; 95%CI=0.11, 1.08). Compared to women who did not listen to radio at 236 all, those who listened to radio less than once a week or at least once a week had increased odds of 237 obesity (aOR=2.64, 95% CI=1.26, 5.54). Biological variable such as women's age was associated 238 with increased odds of obesity (aOR=1.09; 95% CI=1.06, 1.13).

241 **Discussion**

242 The study presents a comprehensive analysis of obesity prevalence by various social determinants of health (SDH), and their effects on the rising obesity in urban Ghana, using existing data sources. The 243 244 extant literature show that SDH play a critical role in determining obesity and health outcomes 245 among diverse populations (21-24). Our analysis illuminated the effects of the various SDHs on 246 women's obesity outcomes. The prevalence of obesity was three times higher among women with high education relative to those without education (40% vs. 14.4%). This is also the case with partner 247 248 education, where women whose partners were highly educated tend to suffer from obesity. It goes to 249 suggest that education places women at an elevated risk of obesity, irrespective of whether it is the 250 woman who attained it or the partner. The plausible explanation of this finding is that women with 251 high education are likely to have high incomes, which may impact their lifestyle and eating 252 behaviors, especially in urban settings. This explanation is consonance with the literature, which 253 concluded that high-income earners live sedentary lifestyles and consume a high-caloric diet (25, 254 31). Besides, previous studies have demonstrated that women in the higher education category have a 255 higher prevalence of obesity compared to the non-educated (23, 24, 32).

256

The analysis of the women's occupation data reveals that women holding managerial positions had a substantially higher prevalence of obesity than those whose occupation is agriculture (33.4% vs. 1.8%). The high prevalence may be because of prolonged sitting hours, means of transportation, and possibly high intake of energy-dense diets (31, 33). For example, long hours at the office can make it challenging to squeeze in time for exercise (34). On the contrary, the low prevalence of obesity among women who work in agriculture could be attributed to the high physical activity associated

with this occupation. Also, agricultural workers are likely to consume their produce rather than rely on high-energy food such as fast food and sugar-sweetened beverages (33). The finding in the present study is consistent with the extant literature. A study undertaken among Korean women showed that obesity prevalence was significantly higher among managers than non-managers (33). The low prevalence of obesity among women in the agricultural sector is consistent with the multivariable logistic regression results, which revealed that women engaged in agriculture have an 81% reduced risk of becoming obese than those in other occupations.

271 Similarly, our analysis show that prevalence of obesity among women living in rich households is 272 more than 5 times those in poor households (28.8% vs. 5.7%). This suggests that wealth is a risk 273 factor for women's obesity. This finding has been corroborated by the multivariable analysis, where 274 women in rich households were over three times more likely to suffer from obesity than those in poor 275 households. The endemicity of obesity in rich households may be due to access to high-energy food 276 and a lack of physical activity. This finding is consistent with the existing literature. Several studies 277 have shown that women in rich households suffer more from obesity compared to those in poor 278 households (35-38). However, comparative analysis shows differences between low-and high 279 incomes countries. Indeed, while obesity is a major issue among the rich in low-income countries, it 280 is high among the poor in high-income countries (22). This may mean that the rich in the high-281 income countries are more concerned about their weight and therefore live healthy lifestyles. The 282 reverse is the case among the rich in low-income countries, as the results suggest.

284 Strength and limitations of the study

285 The study used robust nationally representative data, making it p[possible to generalize the findings to all women of reproductive age living in urban settings in Ghana. The large sample size enhances 286 287 the precision of the estimates and the robustness of the associations observed in the analysis. Further, 288 the outcome variable was objectively measured, reducing the chances of misclassification. A 289 significant limitation is the cross-sectional nature of the data, which does not make it possible to 290 establish any causal relationship between the various SDH and obesity. Therefore, the results are 291 interpreted in the context of associations between the independent and dependent variables. The data 292 did not allow the inclusion of all the broader social determinants of health as defined by the WHO 293 commission's framework. However, the SDH framework did not envision that a single study would 294 be able to address all the factors captured in the framework.

296 Conclusions

297 The study examined the effects of the various social determinants of health on obesity among women 298 of reproductive age in urban Ghana. The results suggest that the various SDH substantially influence 299 women's obesity. Higher education increases the risk of obesity among women. Women occupying managerial positions are also likely to suffer from obesity. Similarly, living in rich households 300 301 substantially increases the risk of obesity among women. Interventions to address the rising obesity 302 in urban Ghana should have packages targeted at these sub-groups. This may include promoting 303 physical activity and healthy eating behaviors, which the extant evidence suggests are hardly practice 304 by these sub-groups.
