REASSURED diagnostics at point-of-care in sub-Saharan Africa: A scoping review

19 Abstract

20 Point-of-care (POC) diagnostics that meet the REASSURED criteria are essential in 21 combating the rapid increase and severity of global health emergencies caused by infectious 22 diseases. However, little is known about whether the REASSURED criteria are implemented 23 in regions known to have a high burden of infectious diseases such as sub-Saharan Africa 24 (SSA). This scoping review maps evidence of the use of REASSURED POC diagnostic tests 25 in SSA. The scoping review was guided by the advanced methodological framework of 26 Arksey and O'Malley, and Levac et al. We searched the following electronic databases for 27 relevant literature: Scopus, Dimensions, ProQuest Central, Google Scholar, and EBSCOhost 28 (MEDLINE, CINAHL, as well as AFRICA-WIDE). Two reviewers independently screened 29 abstracts and full-text articles using the inclusion criteria as reference. We appraised the 30 quality of the included studies using the mixed-method appraisal tool (MMAT) version 2018. 31 We retrieved 138 publications, comprising 134 articles and four grey literature articles. Of 32 these, only five articles were included following abstract and full-text screening. The five 33 included studies were all conducted in SSA. The following themes emerged from the eligible 34 articles: quality assurance on accuracy of REASSURED POC diagnostic tests, sustainability 35 of REASSURED POC diagnostic tests, and local infrastructure capability for delivering 36 REASSURED POC diagnostic tests to end users. All five articles had MMAT scores between 37 90% and 100%. In conclusion, our scoping review revealed limited published research on 38 REASSURED diagnostics at POC in SSA. We recommend primary studies aimed at 39 investigating the implementation of REASSURED POC diagnostic tests in SSA.

41 Introduction

42 Major scientific developments to strengthen health systems, improve sustainability, and 43 promote human health have been made over the years. Yet many countries, including those in sub-Saharan Africa (SSA), are still confronted by long standing emerging and re-emerging 44 45 infectious disease threats [1, 2]. This may be due to the region having low capacity for risk 46 management of disease epidemics which is mainly caused by lack of adequate resources for 47 early detection, identification, as well as timeous response [1]. Early diagnosis of infectious 48 diseases such as Human Immunodeficiency Virus (HIV), chlamydia, and tuberculosis (TB) 49 reduces transmission caused by untreated cases [3]. Thus, high-quality diagnostic tests are 50 needed for surveillance and to control the rapid spread of infectious diseases, as well as to 51 monitor communicable disease risk factors such as blood glucose and cholesterol levels [3, 52 4]. Point-of-care (POC) diagnostic tests are medical tests conducted outside a clinical 53 laboratory, in the proximity of the patient and are often performed by non-laboratory 54 personnel such as nurses, physicians, and patients. POC tests are commonly used where the turnaround time for patient results is short or in areas where central laboratory testing is 55 56 unavailable [5]. The lack of high-quality diagnostics in resource limited healthcare systems 57 causes significant delays in surveillance, detection, control, and prompt treatment of 58 infectious diseases. To address this challenge, the World Health Organization Special Program for Research and Training in Tropical Diseases (WHO/TDR) introduced the 59 60 ASSURED (Affordable, Sensitive, Specific, User-friendly, Rapid, Equipment-free, 61 Delivered) criteria for ideal tests to improve access to diagnostic tests for all levels of 62 healthcare systems [6].

63 The rapid increase and severity of global health emergencies caused by infectious diseases 64 have exposed the need for next-generation devices. This phenomenon has also led to a review 65 of the ASSURED criteria [7]. Considering advances in digital technology, the ASSURED

66 criteria were upgraded to include real-time connectivity and ease of sample collection, 67 subsequently becoming the REASSURED criteria as an improved benchmark for ideal 68 diagnostic tests [6, 8] The WHO further published a model essential diagnostics list to keep 69 diagnostics on the agenda for global health. Despite the availability of this list, a survey 70 revealed limited availability of these diagnostic tests at primary-care level in low-and middle-71 income countries [9]. Lack of access to POC diagnostic tests has negatively affected the 72 diagnostics field in the influx of care for many common infectious diseases [9]. Diagnostics 73 that meet the REASSURED criteria have been shown to incorporate new technological tools [6], which provide real-time quality control testing and treatment. Real-time diagnostics tests 74 75 allow for the timely electronic distribution of information to widely dispersed healthcare 76 professionals, who can use this information to collaborate and provide the best medical 77 advice and treatment to patients.

REASSURED POC diagnostic tests simplify the collection and processing of samples, which would otherwise be processed by a professional pathologist [6, 8]. This scoping review maps the evidence of the implementation of REASSURED POC diagnostic tests in SSA. We anticipate that our results will help guide future research to improve the implementation of REASSURED POC diagnostic tests in SSA.

Methods

84 Study design

The protocol for this scoping review was developed a priori and registered with the Open Science Framework (OSF) under the title: "REASSURED diagnostics for public health outcomes in sub-Saharan Africa: A scoping review protocol." The protocol is accessible via this link: https://archive.org/details/osf-registrations-zs3pb-v1.

89 This scoping review was guided by the methodological framework of Arksey and O'Malley 90 [10], which was further advanced by Levac et al. [10] to include quality assessment of findings. Based on this framework, we conducted the scoping review according to the 91 92 following five stages: identifying the research question, identifying relevant studies, study 93 selection, charting the data, collating, summarizing, and reporting the results. The quality of 94 included studies was appraised as recommended by Levac et al. [10]. The results of the 95 scoping review are presented according to the Preferred Reporting Items for Systematic and 96 Meta-analysis Extension for Scoping Reviews (PRISMA-ScR) [11].

97 Eligibility of research question

98 The study research question was: What is the sustainability of REASSURED POC diagnostic99 tests in SSA?

100 To determine the eligibility of our research question for a scoping review, we used the

101 population, concept, and context (PCC) nomenclature (Table 1).

105 Identification of relevant studies

106 We conducted a comprehensive search for relevant published literature in the following 107 databases: Scopus, Dimensions, ProQuest Central, Google Scholar, and EBSCOhost 108 (MEDLINE, CINAHL, as well as AFRICA-WIDE). We also searched for grey literature 109 including reports from government and international organizations such as WHO, FIND, and 110 the FDA. We manually searched the reference lists of included articles to identify articles not 111 included in the electronic databases. Language restrictions were not applied to prevent the 112 exclusion of relevant articles. The search strategy was co-developed by the principal 113 investigator (PI), a subject specialist, and faculty librarian to ensure the correct use of 114 keywords and Medical Subject Headings (MeSH) separated with Boolean operators [AND] 115 and [OR]. The following keywords were used: point-of-care diagnostics, point-of-care 116 testing, acceptability, SSA, and REASSURED. Keywords were refined to suit each database. 117 Each search was documented in detail showing the keywords and MeSH terms, date of 118 search, electronic database, as well as the number of publications retrieved (S1 Table).

119 Study selection

120 Relevant studies were selected using the following inclusion and exclusion criteria:

121 Inclusion criteria

122 Articles were included in the scoping review if they met the following criteria:

- Articles reporting on all POC diagnostic tests used at all levels of healthcare systems
- Articles lacking comparative evidence between all levels of healthcare systems
- Articles reporting on REASSURED diagnostics
- Articles published since the inception of REASSURED POC diagnostic tests

127 Exclusion criteria

128 Articles were excluded if they met the following criteria:

- Articles on laboratory-based POC diagnostics
- 130 Review articles
- 131

132 All retrieved articles were screened in three stages. First stage: The titles of retrieved articles 133 were all screened by BM. Eligible studies were exported to an Endnote 20 library and 134 duplicates were removed. Second stage: Two reviewers (BM and BL) screened the article 135 abstracts in parallel. The reviewers discussed discrepancies in selected articles until they 136 agreed on the inclusion of articles. Third and last stage: All relevant full articles were 137 screened by the two reviewers. Discrepancies in reviewers' responses following full article 138 screening were resolved by a third reviewer (SRN). The level of agreement between the 139 reviewers' feedback from abstract and full article screening was determined by calculating 140 Cohen's kappa statistic. A kappa statistic value < 0.10 was considered as no agreement. 141 Kappa statistic values between 0.10-0.20 indicated no to slight agreement, 0.21-0.40 142 indicated fair agreement, 0.41-0.60 indicated moderate agreement, 0.61-0.80 indicated 143 substantial agreement, and 0.81–1.00 indicated almost perfect agreement.

144 Charting the data

Data were captured from the included articles using a data charting form. Two independent reviewers (BM and TMT) piloted the data charting form and recommended modifications which were implemented. The following data were extracted from the included articles: author and publication year, title of study, aim of the study, study population, study setting, type of REASSURED POC criteria investigated, study findings, and conclusions.

150 Collating, summarizing, and reporting results

151 We thematically analyzed data extracted from all included studies. The themes were

152 narratively summarized.

Quality appraisal

We used the mixed method appraisal tool (MMAT) version 2018 to assess the quality of the included articles [12]. BM and KM carried out the quality assessment process and calculated the overall percentage quality score. The scores were graded ranging from \leq 50% to 100%. Percentage quality scores \leq 50% represented low quality evidence; 51–75% represented average quality evidence, and 76–100% represented high-quality evidence.

159 **Ethical consideration**

This scoping review did not include human or animal participants and was not completed for
degree purposes, thus ethical approval was not required. All included and excluded studies
following full article screening were cited.

163 **Results**

164 Screening

165 We screened the titles of 138 articles comprising 134 research articles and four articles from 166 grey literature (S1 Table). We identified and removed 47 duplicates and subsequently 167 screened the abstracts of 91 articles. During abstract screening, 25 articles met the inclusion 168 criteria for full-article screening, and 66 articles were excluded. Full-article screening led to 169 the inclusion of five articles and exclusion of 20 articles which did not meet the inclusion 170 criteria (Fig 1). Articles were excluded due to the following reasons: reported on laboratory-171 based POC diagnostic services [13-23], were not conducted in SSA [13, 20, 22, 24-26], 172 commentary article [27], and focused on the wrong population [24, 25].

173 Data was extracted from the remaining five articles. The level of agreement was calculated 174 after full-article screening (S3 Table). A moderate agreement of 76% from the expected 175 56.16% was obtained (Kappa statistics = 0.4526, p-value < 0.05). Furthermore, the 176 McNemar's chi-square statistics suggested that there was no statistically significant 177 difference in the proportions of yes/no answers by the reviewers (p-value > 0.05).

178 Characteristics of included studies

Geographic distribution of included studies showed South Africa to have most of the
evidence on REASSURED POC diagnostic tests among SSA countries (Fig 2). Two POC
test field evaluation studies [6, 29] and one cohort study were conducted in South Africa [30].
One survey study was conducted in Kenya [28]. A multi country cross sectional study was
conducted in Ghana, Mali, Tanzania, and Togo [31].

Our scoping review showed evidence on the following POC diagnostic tests: HIV rapid diagnostic tests (RDTs) [6, 28, 30]; dual HIV and syphilis RDTs [6]; glucose monitoring home test [29]; lateral flow test strips [29]; malaria RDT [6, 28]; pregnancy RDT [28]; syphilis RDT [6, 28]; sickle cell disease (SCD) lateral flow immunoassay POC test [31]; TB lipoarabinomannan (LAM) antigen test [6]; and typhoid RDT [28]. Fig 3 indicates the various POC tests in the included studies.

The identified studies provided evidence on at least one criterion of a REASSURED POC diagnostic test. The REASSURED criteria assessed were real-time connectivity [6, 29-31], ease of sample collection [6, 29, 31], affordability [6, 28, 29, 31], sensitivity [6, 29-31], specificity [6, 29-31], user-friendliness [6, 29-31], rapid and robust [6, 29, 31], equipmentfree [6, 29, 31], and delivered [6, 31]. Fig 4 indicates the REASSURED criteria assessed from the eligible studies.

201 **Quality of evidence**

The five eligible studies that were appraised for methodological quality scored between 90% and 100%, which indicated high methodological quality. Two studies had quality scores of 100% [6, 28], two studies scored 95% [29, 31] and the remaining study scored 90% [30] (S2 Table).

206 Main findings

All the articles presented evidence on the acceptability of at least one REASSURED POC test criteria in SSA. The following themes emerged from the included articles: quality assurance on accuracy of REASSURED POC diagnostic tests, sustainability of REASSURED POC tests, and local infrastructure capability for delivering REASSURED POC tests to end users.

211 Quality assurance on accuracy of POC diagnostic tests

212 Three studies reported on the quality assurance of POC diagnostic tests [6, 28, 30]. These 213 studies highlighted the role of quality assurance on the reliability (false positives/or false 214 negatives) of POC diagnostic tests in SSA [28]. Kimani, Mwangi [28] indicated that 50% of 215 respondents felt that the reliability of POC diagnostic tests was a major obstacle for clinicians 216 and that unreliable tests may lead to the incorrect prescription of medication. Land, Boeras 217 [6] highlighted the importance of regular quality assurance updates to improve the 218 implementation of POC tests. These quality assurance efforts include developing key policies 219 and quality documents which healthcare workers need to be familiar with to ensure proper 220 handling and interpretation of tests [6]. Turbé, Herbst [30] demonstrated the potential of deep 221 learning for accurate classification of RDT images with an overall performance of 98.9% 222 accuracy which was higher than the accuracy of traditional visual interpretation of 92.1%. 223 The number of false positives recorded in the mobile-Health (mHealth) system were lower 224 than the false positives reported for traditional visual interpretation. Though the accuracy 225 increase was not significant even a slight increase in quality assurance could impact the lives 226 of millions of people. Their study further laid a foundation for deep learning-enabled 227 REASSURED diagnostics, demonstrating that RDTs linked to a mobile device could 228 standardize the capture and interpretation of results for decision makers thus reducing errors 229 [30]. Their findings presented evidence on the quality assurance of REASSURED POC

230 diagnostic tests with the focus on accuracy but they did not assess the impact of healthcare

231 workers' competency on the accuracy of REASSURED POC diagnostic tests in SSA.

232 Sustainability of REASSURED POC tests

233 Four studies reported on the sustainability of REASSURED POC diagnostic tests. Land, 234 Boeras [6] evaluated how diagnostics can be improved by incorporating new technological 235 elements which provide real-time quality control for testing and treatment. They highlighted 236 how smart devices could be used to automatically add data to central databases allowing for 237 diagnosis assessment and prediction of disease outbreaks [6, 32]. Similarly, high levels of 238 sustainability were shown for a smart device sending HIV RDT results to online databases in 239 real-time [30]. Nurses and newly trained community health workers agreed that the devices 240 were easy to use [30]. Kimani, Mwangi [28] surveyed clinicians and indicated that patients 241 were satisfied with the results derived from RDTs (97%) and would recommend RDTs for 242 use in the future (96%). They further recommended that devices should be convenient to user 243 in order to ensure reliability, standardization, and ease of use [28]. The respondents also 244 proposed the integration of technology developments and new knowledge into new 245 diagnostic tests which are user-inspired [28]. Dexter and McGann [31] evaluated the 246 performance of SCD POC tests and their importance in LMICs. Hemo Type SC test 247 performed well in a Nigerian pilot study at immunization centers. Approximately 70% of 248 screen-positive infants were enrolled in specialist care programs [31]. Field studies suggest 249 that POC tests are important in improving healthcare delivery and outcomes. We could not 250 find any evidence on the cost-effectiveness of implementing POC diagnostic tests in SSA 251 healthcare systems.

252 Local infrastructure capability for delivery to end user

253 One study reported on the lack of local infrastructure for production and distribution of 254 REASSURED POC diagnostic tests. Smith, Land [29] presented research conducted on the 255 development of printed wireless connectivity with low-cost sensing capabilities as part of a 256 health diagnostic solution. The developed solution demonstrated vast low-cost substrates for 257 paper-based diagnostic tests [29]. The study further reported the need to establish 258 infrastructure and equipment for developing point-of-need solutions in South Africa for 259 improved quality of life [29]. The findings presented evidence on the small-scale 260 development of POC diagnostic tests which adhere to the REASSURED criteria, but we 261 could not find any evidence on the competency of SSA manufacturers, researchers, and 262 distributors to achieve this intervention.

263 **Discussion**

264 This scoping review mapped the evidence on REASSURED POC diagnostics with the goal 265 of optimizing their acceptability in SSA. Our findings indicated that there is limited published 266 research conducted on REASSURED POC diagnostics and their sustainability in SSA. New 267 developments in digital diagnostic technology have set the platform for the next generation of 268 POC tests, which could catalyze transformation in healthcare delivery [33]. SSA countries 269 may benefit from early adoption of these POC tests and accelerate progress towards 270 Universal Health Coverage as well as the United Nations Sustainable Development Goal 3 271 (SDG) 3 [33]. There is a need for relevant stakeholders to work together in achieving these 272 goals. There is also a need for quality assurance interventions such as training to manage the 273 accuracy and subsequent availability of REASSURED POC diagnostic tests. To ensure the 274 quality of POC tests, both skilled and non-skilled test handlers should be trained to use POC

tests competently [5]. Accurate diagnosis will ensures that patients are treated correctly andthat disease surveillance is trustworthy [34].

277 POC diagnostic tests have been demonstrated to be a time-effective intervention during 278 healthcare emergencies. However, when cost analyses are done, these tests are observed to be 279 cost-prohibitive [35]. In this scoping review, we revealed evidence evaluating the 280 sustainability of REASSURED POC diagnostic tests in SSA [6, 29, 30], with most evidence 281 coming from South Africa [6, 29, 30]. Few studies have assessed the costs of using 282 REASSURED POC diagnostics in SSA healthcare systems, particularly in remote areas. 283 Primary studies assessing cost effectiveness could potentially assist in evaluating generated 284 data and developing future studies that assess the sustainability of REASSURED POC 285 devices in SSA. Our study further revealed the vast contrast in the amount of knowledge 286 generated through primary studies from lab-based REASSURED diagnostics compared to 287 studies generated for POC tests which are user-friendly for patients [13, 15-20, 26, 36]. We 288 could not retrieve any evidence on the SARS-CoV-2 virus REASSURED POC tests despite 289 the scale of the pandemic. This suggests a gap in interventions to prioritize REASSURED 290 POC tests in primary healthcare to accommodate under privileged patients who cannot afford 291 lab-based diagnostic testing.

A study in South Africa demonstrated developments towards REASSURED POC diagnostics using paper-based and printed electronic technologies [21]. We did not include this study in our scoping review because the evidence generated was for lab-based POC tests [21]. A similar study summarizing paper-based strip tests for blood glucose evaluated the ease of sample collection, specificity, as well as the sensitivity of the REASSURED criteria [22]. Optimization of the POC test strips for the semi-quantitative detection of glucose in whole saliva was demonstrated. However, this study was conducted outside SSA [22]. A previous

299 study conducted in similar settings reported on the development of high performance POC 300 tests. The study evaluated a low-cost, highly sensitive, automated, and robust paper/soluble 301 polymer hybrid-based lateral flow platform paired with a smartphone reader for application in 302 resource-limited settings [15]. With the movement of POC test development and 303 manufacturing to smart technology guided by the REASSURED criteria, their sustainability 304 in SSA remains to be proven. Therefore, more SSA countries need to generate data on 305 REASSURED POC diagnostic tests and address their sustainability with evidence-based 306 interventions.

307 Strengths and limitations

308 To the best of our knowledge, this is the first scoping review to provide a comprehensive 309 overview of evidence on REASSURED POC diagnostic tests in SSA. Our scoping review 310 employed a comprehensive database search which included empirical evidence with no 311 language limitations. The retrieved articles were rigorously screened by two independent 312 screeners. The screening tools were piloted and following full article screening, the kappa 313 statistics calculation yielded a moderate agreement of 76% from the expected 56.16%. To 314 ensure transparency, the included studies were subjected to quality appraisal using MMAT 315 2018 version. High methodological quality of between 90-100% was obtained for the eligible 316 studies. Despite the above strengths, this study has some limitations. This study was not 317 limited to studies that were conducted in SSA. Forty percent of the included studies presented 318 evidence from SSA and other countries outside Africa [6, 31]. However, majority of 319 countries presented in these included studies were from SSA.

320 Suggestions for future practice

All the studies in this scoping review were conducted in SSA where access to high quality health systems is limited. From these studies, three [6, 28, 29] evaluated REASSURED POC

diagnostic tests in SSA whilst two [30, 31] were field work studies. This demonstrates the lack of evidence generated from local primary studies on POC diagnostic tests. Secondly, quality assurance, training as well as infrastructure were observed as barriers towards the sustainability of REASSURED POC diagnostics in SSA. Our findings indicate a need for local prioritization of research conducted to reflect the true acceptability of REASSURED POC diagnostic tests in SSA.

329 Suggestions for future research

330 Our study revealed limitations in research conducted on REASSURED POC diagnostic tests 331 in SSA. Our scoping review revealed a lack of primary studies on the training regime of field 332 workers on quality assurance of REASSURED POC diagnostic tests during upscaling and 333 implementation processes in SSA. Furthermore, the study revealed a lack of primary studies 334 on the sustainability of REASSURED POC diagnostics by end users in remote regions of 335 SSA. In addition to these gaps, the study revealed a lack of interventions have been 336 developed in SSA to assess research competency, infrastructure readiness for manufacturing, 337 and delivery of REASSURED POC diagnostic tests to end users. The gaps identified from 338 the scoping review proposes future research in discovering training regimes for non-339 professional users of REASSURED POC diagnostic tests in order to maintain the quality in 340 terms of accuracy of these tests. This will ensure proper patient treatment and enhance 341 primary healthcare quality in resource-limited settings such as SSA. Considering challenges 342 encountered with electricity supply and subsequent network failures, we further recommend 343 future research to investigate the cost effectivity of REASSURED POC diagnostics on 344 healthcare systems in remote regions of SSA. Future research can also evaluate the 345 competency and readiness of SSA infrastructure for manufacturing, packaging and delivery 346 of REASSURED POC diagnostic devices to end users.

347 Conclusions

348 There is limited research on REASSURED POC diagnostics and their sustainability in SSA. 349 Quality assurance of POC tests is essential in ensuring patients get accurate results and are prescribed proper treatment. The global movement of POC tests to digital technology makes 350 351 these REASSURED devices important at all levels of healthcare for proper surveillance and 352 treatment of communicable and non-communicable diseases. The acceptability of 353 REASSURED POC diagnostics in resource-limited regions such as SSA is thus required to 354 enhance the quality of primary healthcare. The lack of local research studies towards the 355 acceptability of REASSURED POC diagnostic tests in SSA delays the move towards 356 improved quality primary healthcare delivery.




Fig 1. PRISMA-ScR flowchart showing literature screening and selection of eligible articles.




Fig 2. Map of Africa showing a geographic distribution of research evidence on included REASSURED point-of-care diagnostic tests in sub-Saharan Africa.





Fig 3. List of point-of-care diagnostic tests sub-Saharan Africa.
