

The Impact of Transcutaneous Spinal Cord Stimulation on Autonomic Regulation after Spinal Cord Injury: A randomized crossover trial

Key Points:

- Does electrical spinal cord stimulation, at any previously advocated stimulation frequency, improve regulation of the autonomic nervous system for individuals with spinal cord injuries?
- In this randomized crossover trial, transcutaneous spinal cord stimulation generated tonic, frequency-dependent sympathetic activation below the level of injury, without improved dynamic autonomic regulation.
- Tonic sympathetic activation below the level of injury could lower the threshold for potentially dangerous autonomic dysreflexia in individuals with spinal cord injury and future work should employ appropriate monitoring.

Abstract

Importance: Individuals with spinal cord injury (SCI) have significant autonomic nervous system dysfunction. However, despite recent findings postulated to support that spinal cord stimulation improves dynamic autonomic regulation, limited scope of previous testing means the true effects remain unknown.

Objective: To determine whether transcutaneous spinal cord stimulation improves dynamic autonomic regulation after SCI.

Design: Single-blinded, randomized crossover trial with matched cohorts.

Setting: Academic autonomic physiology laboratory.

Participants: Two pairs of well-matched individuals with and without high-thoracic, complete SCI.

Interventions: Sub-motor threshold transcutaneous spinal cord stimulation delivered at T10-T11 using 120Hz, 30Hz, and 30Hz with 5kHz carrier frequency at separate autonomic testing sessions.

Main Outcomes and Measures: Baseline autonomic regulation was characterized with tests of above injury level sympathoexcitation (Valsalva's maneuver), sympathoinhibition (progressive doses of bolus intravenous phenylephrine), and below level sympathoexcitation (foot cold pressor test). At three subsequent visits, this testing battery was repeated with the addition of spinal cord stimulation at each frequency. Changes in autonomic regulation for each frequency were then analyzed relative to baseline testing for each individual and within matched cohorts.

Results: Uninjured controls demonstrated no autonomic deficits at baseline and had no changes with any frequency of stimulation. Contrasting this, and as expected, individuals with SCI had baseline autonomic dysfunction. In a frequency-dependent manner, spinal cord stimulation enhanced sympathoexcitatory responses, normalizing previously impaired Valsalva's maneuvers. However, stimulation exacerbated already impaired sympathoinhibitory responses, resulting in significantly greater mean arterial pressure increases with the same phenylephrine doses compared to baseline. Impaired sympathoexcitatory response below the level of injury were also further exacerbated with spinal cord stimulation. At baseline, neither individual with SCI

demonstrated autonomic dysreflexia with the noxious foot cold pressor test; the addition of stimulation led to a dysreflexic response in every trial, with greater relative hypertension and bradycardia indicating no improvement in autonomic regulation.

Conclusions and Relevance: Transcutaneous spinal cord stimulation does not improve autonomic regulation after SCI, and instead likely generates tonic, frequency-dependent sympathoexcitation which may lower the threshold for autonomic dysreflexia.

Introduction:

Individuals with spinal cord injury (SCI) commonly have blood pressure instability, manifesting as orthostatic hypotension (insufficient sympathetic activation through the injured cord to maintain adequate blood pressure)¹ and/or autonomic dysreflexia (AD, potentially dangerous hypertension triggered by noxious stimuli below the level of injury, causing regional sympathoexcitation that cannot be counter-regulated).² After SCI, descending regulatory brainstem signals are interrupted, decoupling important spinal cord sympathetic circuitry and compromising blood pressure regulation.³ To address this, multiple recent small, high-impact studies have utilized spinal neuromodulation to stabilize blood pressure during orthostatic challenge.⁴⁻⁷ Though demonstrating proof of principle, differing stimulation frequencies and limited physiologic monitoring/challenges provide a narrow view of autonomic nervous system responses. If regulation is improved, both sympathoexcitatory and sympathoinhibitory responses should be enhanced. Orthostatic challenge requires sympathoexcitation alone; hence, stimulation may simply induce a hypertensive response via local, unperceived noxious stimuli (AD).⁸ Given ongoing industry-sponsored clinical trials and the current limited understanding, a more comprehensive characterization of the autonomic regulatory effects of spinal cord stimulation is critically needed.

Methods:

Individuals 18-30 years of age with chronic high thoracic motor/sensory complete SCI (E-ISCNCSCI exam⁹) and matched uninjured controls were enrolled from February to November 2022 (Figure 1A). Beat-to-beat blood pressure, heart rate, respiration, and leg blood flow were recorded in our academic physiology laboratory. Data during 5-minutes of resting baseline were obtained, followed by Valsalva's maneuvers, bolus intravenous phenylephrine, and cold pressor test. Valsalva's maneuver, a sustained forced exhalation against resistance generates characteristic responses across four phases. Phase II, the initial fall in pressure due to intrathoracic pressure restricting venous return to the heart requires sympathetic activation to maintain pressure.¹⁰ Bolus intravenous phenylephrine (three progressive doses¹¹ with a goal of >15mmHg increase in systolic pressure (SBP))¹¹ is normally buffered by bradycardia and sympathetic inhibition. The cold pressor test (three minutes of the foot immersed in 0°C ice water) results in increased blood pressure from tachycardia and

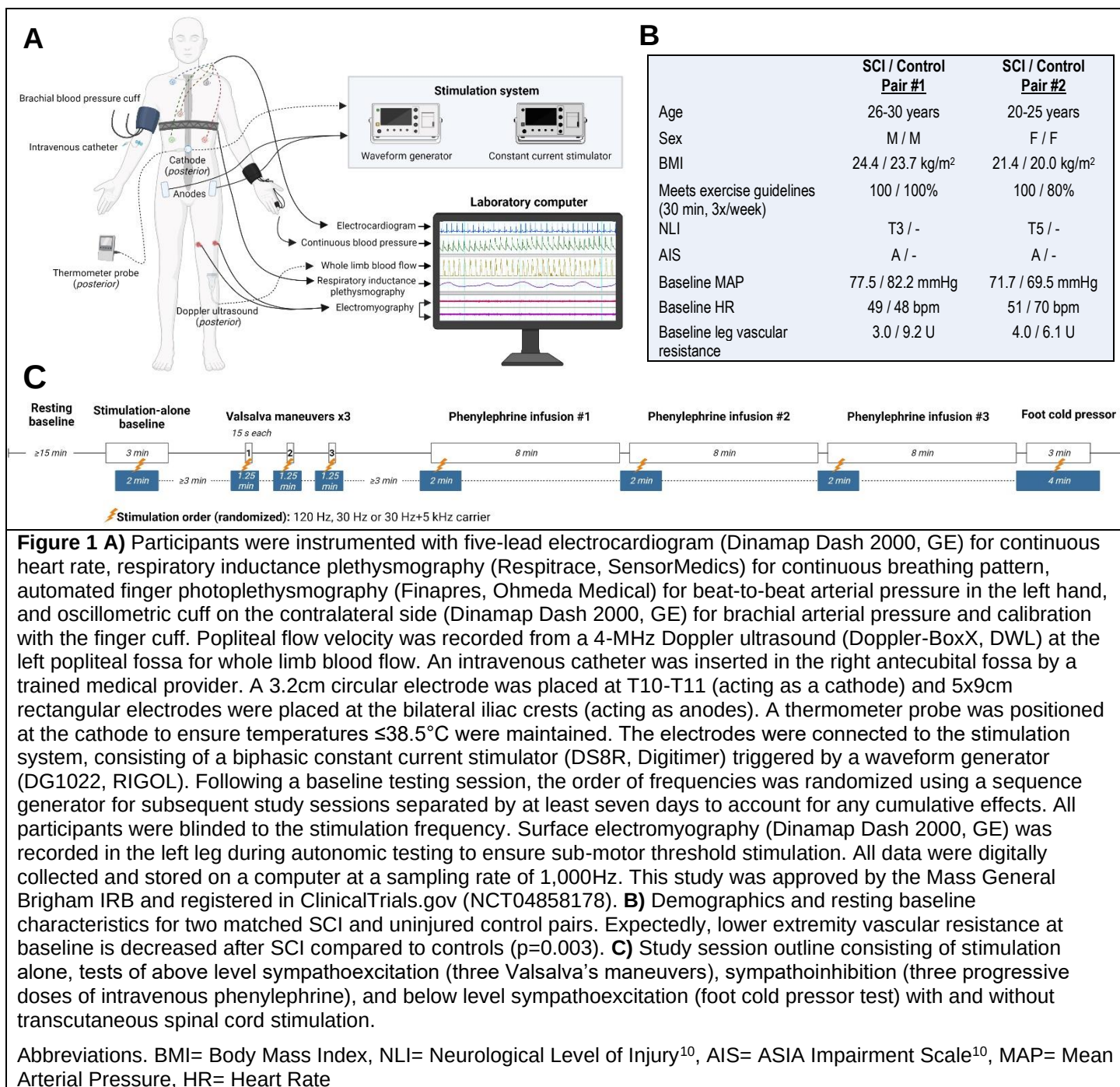
sympathoexcitation.¹³ These three tests characterize both sympathoexcitatory and sympathoinhibitory responses through different reflex pathways. For the last, a noxious stimulus below the injury level in SCI further may increase blood pressure due to AD, resulting in reflexive baroreflex-mediated bradycardia rather than tachycardia.

Testing was repeated across four sessions with and without the addition of transcutaneous spinal cord stimulation at 120Hz,⁴ 30Hz,⁵ or 30Hz with 5kHz carrier frequency^{6,7} over T10-T11 (Figure 1). Amplitude was set at 80% of motor activation thresholds to prevent contraction-related hemodynamic contributions. One frequency was tested per session in a randomized order set by a sequence generator with participants blinded. Over four testing sessions for each individual, a rich dataset of 92 autonomic tests was generated to evaluate autonomic regulatory effects of stimulation.

For Valsalva's maneuver, absolute decrease in mean arterial pressure (MAP) during Phase II, Valsalva's ratio, and pressure recovery time¹⁴ were calculated. For bolus phenylephrine, absolute changes in MAP, heart rate (HR), and lower extremity vascular resistance were averaged across the three progressive doses of phenylephrine. As an equal comparator, the 75µg dose for those with SCI and matched controls were also similarly compared. For foot cold pressor, peak Δ MAP and Δ HR were calculated. Paired t-tests were completed between matched pairs, with stimulation at all frequencies grouped when data trends were homogenous. Results are reported as mean $\pm$ SE, with $P < 0.05$ treated as significant.

Results:

Four individuals (Figure 1) completed all study sessions. With stimulation alone, MAP, HR, and leg vascular resistance were unchanged (both in aggregate and per frequency, eFigure 1).

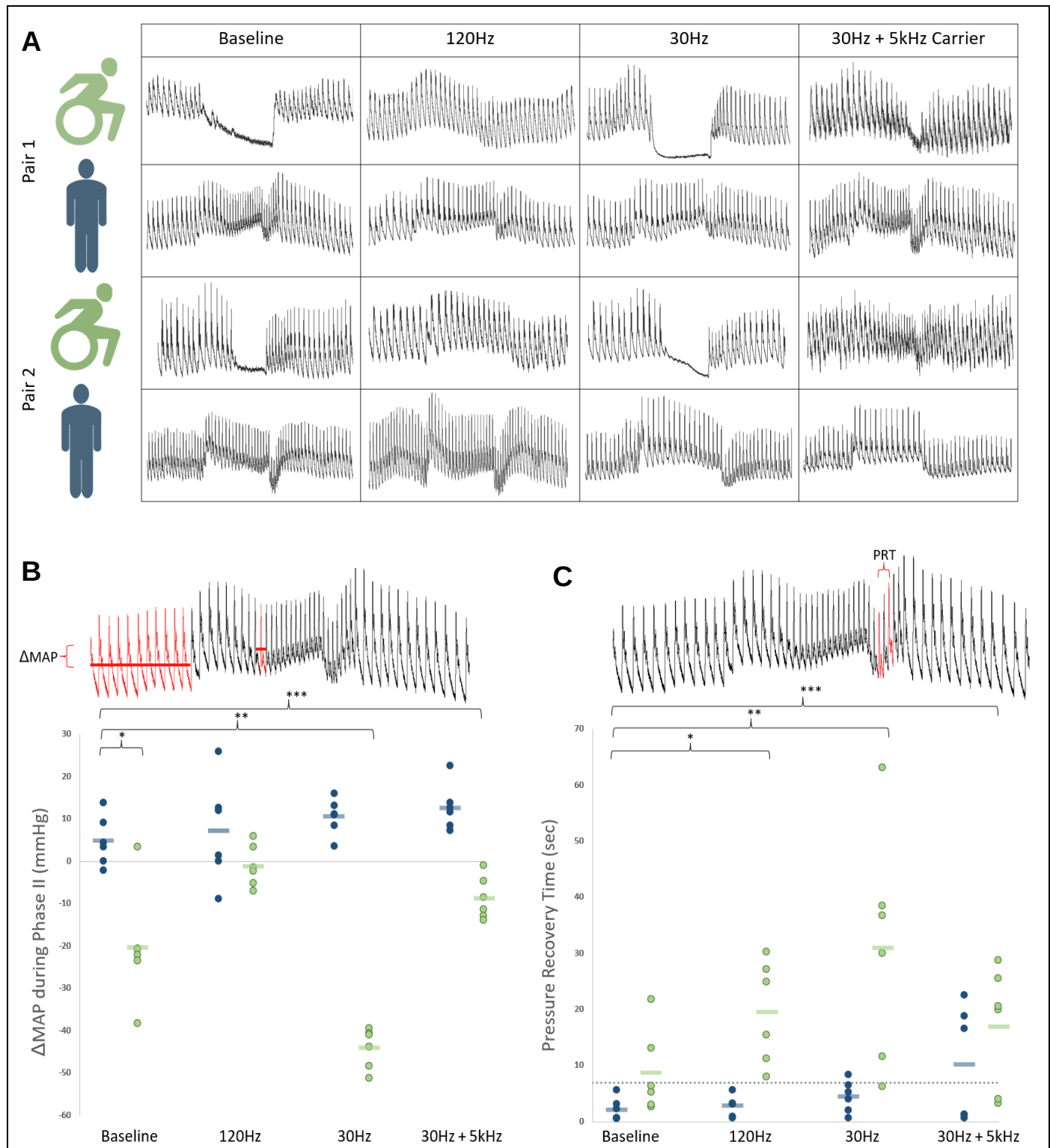


Figure 2: A) Valsalva's maneuver at a goal sustained pressure of 30mmHg for 15 seconds. Representational traces of beat-to-beat blood pressure at baseline and with each stimulation frequency for all individuals. Of note, both individuals with SCI at baseline lack phase II stabilization of blood pressure which was subsequently restored with 120Hz. **B)** MAP changes from baseline to nadir of phase II of Valsalva's maneuver. Group means represented as blue / green **C)** Pressure recovery time from nadir MAP in phase III to return to baseline MAP in phase IV. Dashed line represents upper limits of normal. In SCI, this time is significantly lengthened at baseline – an effect which is accentuated with transcutaneous spinal cord stimulation at all frequencies (120Hz, $p=0.005$; 30Hz, $p=0.02$; 30Hz+5kHz, $p=0.03$).

At baseline, phase II pressure stabilization of Valsalva's maneuver was present in controls and reliably absent in both individuals with SCI across all trials. MAP decrease during phase II was significantly greater at baseline for individuals with SCI than controls (-20.3 ± 5.5 vs $+4.9 \pm 2.4$ mmHg, $p=0.01$). Stimulation variably restored phase II pressure stabilization in a frequency dependent manner (Figure 2), with no such changes for matched controls. 120Hz stimulation normalized blood pressure in those with SCI compared to controls (mean decrease of 1.1 ± 2.0 mmHg, $p=0.20$) whereas 30Hz and 30Hz+5kHz stimulation were ineffective or less

effective. Although pressure recovery time was not significantly different at baseline between those with SCI and controls (8.7±3.1sec for SCI vs 2.2±0.8sec for controls, p=0.09), stimulation at all frequencies lengthened pressure recovery time for individuals with SCI. Valsalva's ratios were not different at baseline and stimulation had no effect.

Bolus phenylephrine tended to produce greater Δ MAP and relative resistance in SCI than control, though this did not reach significance ($p=0.21$ and $p=0.16$ respectively). Across all settings ($n=18$ trials) compared to baseline ($n=6$ trials), stimulation significantly phenylephrine-induced Δ MAP in SCI (27.0 ± 2.4 mmHg vs 6.8 ± 1.1 mmHg, $p<0.001$) but not in control (4.5 ± 1.2 mmHg vs 6.3 ± 0.6 mmHg, $p=0.36$). Similarly, vascular resistance was significantly increased with stimulation in SCI ($+0.68 \pm 0.03$ U vs $+1.6 \pm 0.19$ U, $p=0.001$), but not in controls ($+0.12 \pm 0.31$ U vs $+0.01 \pm 0.22$ U, $p=0.79$).

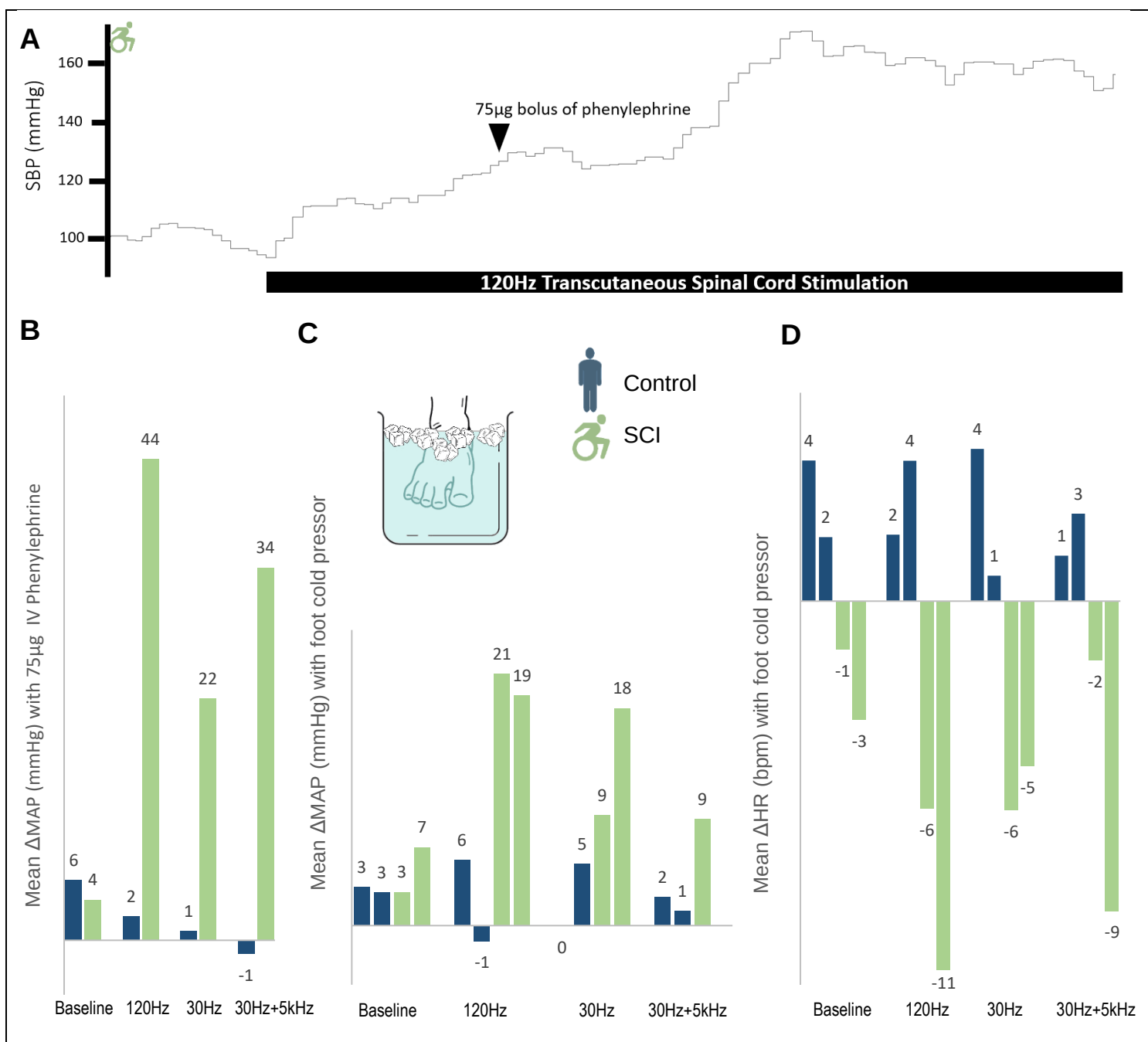


Figure 3: A) Representational trace of SBP with bolus phenylephrine and transcutaneous spinal cord stimulation. **B)** MAP change with 75µg dose of intravenous phenylephrine per frequency for matched pair 1 (uninjured control and individual with SCI). Change was calculated as 30 seconds of stable baseline recordings immediately prior to each successive dose compared to a 20 second window centered at initial nadir in HR, when maximal effect was identified. The addition of stimulation caused significantly greater Δ MAP in SCI compared to control (33.5 ± 6.4 mmHg vs 0.6 ± 1.0 mmHg, $p=0.03$). **C, D)** MAP and HR changes with foot cold pressor test. *Of note, missing 30Hz+5kHz MAP due to equipment malfunction for second individual with SCI.* While controls exhibit the expected tachycardic response with foot cold pressor, individuals with SCI conversely have bradycardia, indicating a disengaged baroreflex pathway attempting to compensate for sympathetic tone generated below the level of injury. Analyses compared 3 minutes of stable baseline with 20 second window around the peak MAP.

The foot cold pressor resulted in small MAP increases and a slight tachycardia that were unaltered by stimulation in controls (Figures 3C/D). In contrast, foot cold pressor resulted in small MAP increases and a modest bradycardia that were enhanced by stimulation in those with SCI. Across all stimulation frequencies, SBP increased on average by 27.7 ± 4.5 mmHg accompanied by a bradycardia of 6.3 ± 1.3 beats. The greatest effect was seen at 120Hz (Figure 3). Hence, without stimulation in those with SCI, the foot cold pressor evidenced a modest noxious response that did reach threshold for AD, but stimulation augmented this such that every trial of the cold pressor test resulted in AD.

Discussion:

Transcutaneous spinal cord stimulation consistently caused tonic sympathetic activation in a frequency-dependent manner after SCI and had no effect in matched, uninjured controls. Tonic sympathetic activation from stimulation agrees with previous results demonstrating restored blood pressure maintenance during head-up-tilt when sympathoexcitation is needed. Our results demonstrate that this tonic sympathetic activation can further restore phase II of Valsalva's maneuver. However, stimulation has no beneficial effect on sympathoinhibitory responses and may promote AD responses to noxious stimuli below the level of lesion. This last effect is of significant clinical importance. For example, during 120Hz stimulation with foot cold pressor, one individual with SCI demonstrated an almost 20mmHg rise in MAP despite an 11-beat bradycardia; this indicates that there was massive vasoconstriction below the level of lesion in response to the cold noxious stimulus and an ongoing decoupled HR response – opposite of what would be expected with improved autonomic regulation.

Taken together, these tests demonstrate that spinal cord stimulation did not improve dynamic autonomic regulation. Further, AD is a potentially dangerous condition and future studies should adequately monitor for AD with stimulation, since individuals are often asymptomatic.⁸ This is the first head-to-head study comparing previously advocated frequencies of spinal cord stimulation in a comprehensive manner. Stimulation at 120Hz had the greatest degree of sympathetic activation, followed by 30Hz+5kHz, and then 30Hz. This effect was mirrored in all study tests.

Limitations

While this sample size is typical of the growing field⁴⁻⁷, generalizability may be limited with a small cohort. Despite this, across 92 independent autonomic tests to systematically characterize autonomic deficits and stimulation at different frequencies, results were remarkably consistent. Most especially, the previously undocumented risk of AD warrants notice.

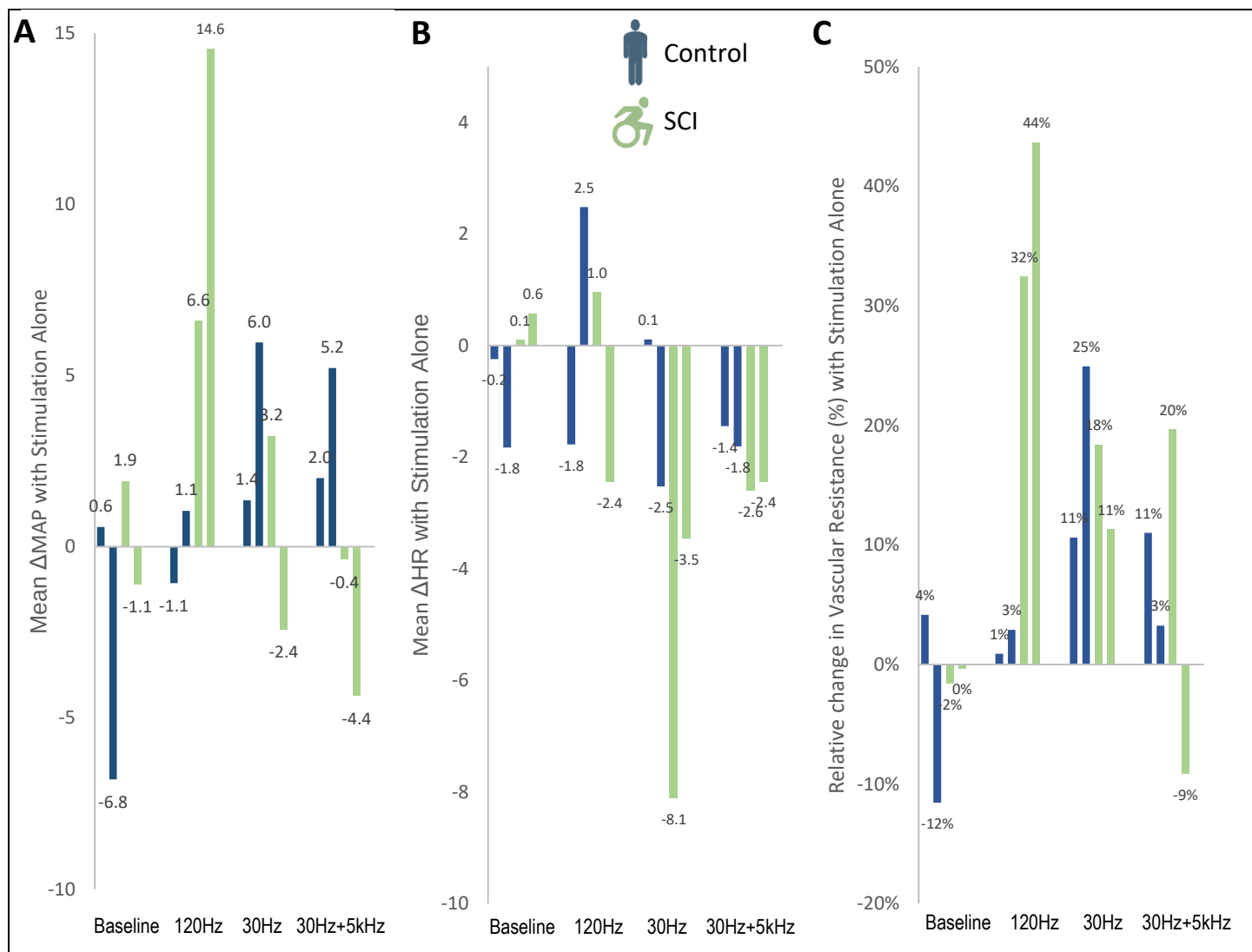
Conclusions:

Transcutaneous spinal cord stimulation causes tonic sympathetic activation in a frequency-dependent manner, without evidence of improvements in autonomic regulation after SCI. This may lower the threshold for autonomic dysreflexia.

eFigure 1: Physiologic response to transcutaneous spinal cord stimulation alone in a resting state **A)** Mean change in MAP with stimulation alone. **B)** Mean changes in HR with stimulation alone. **C)** Relative changes in lower extremity vascular resistance with stimulation alone. Grouping stimulation frequencies, vascular resistance increased an average of $19.0 \pm 7.7\%$ for individuals with SCI, vs $8.9 \pm 3.6\%$ for controls ($p=0.32$). The greatest effect was seen at 120Hz for those with SCI, with resting vascular resistance increasing 32.4% and 43.7% respectively. At this same stimulation frequency in matched controls, vascular resistance increased 0.9% and 2.9%. All other stimulation frequencies had minimal impact in this unchallenged state.
