- Neonatal health is a critical global concern that reflects the national and global progress and challenges of
- health systems. Neonatal morbidity and mortality are major global public health problems.
- 12 Methods
- We conducted a hospital-based cross-sectional descriptive study of all neonates admitted to the NICU of
- the pediatric ward of Mirwais Regional Hospital between March 2023 and February 2024.
- 15 The objective of this study was to determine the pattern of neonatal morbidity and mortality as well as to
- 16 compute case fatality rates in Mirwais Regional Hospital in Kandahar City, Afghanistan.
- 17 Results
- In our study, there were 3387 newborns admitted to the neonatal ward of Mirwais Regional Hospital over
- a one-year period (from March 2023 to February 2024). Prematurity was the most common reason for
- admission to the neonatal ward (1048/3387, 30.9 %). Other common conditions included neonatal sepsis
- 21 (909/3387, 26.8%), birth asphyxia (785/3387, 23.1%), jaundice (466/3387, 13.7%), and tetanus (9/3387,
- 22 0.3%). Surgical causes contributed to (170/3387, 5.0%) morbidities.
- 23 The overall mortality rate was 13.0% (442/3387). The major causes of mortality were premature birth
- 24 (39.8%, 176/442), birth asphyxia (25.6%, 113/442), and neonatal sepsis (22.1%, 98/442). Other causes of
- 25 mortality were neonatal jaundice (7.9%, 35/442), neonatal tetanus (0.9%, 4/442), and surgical disease
- 26 (3.6%, 16/442). Neonatal tetanus had the highest mortality rate (44.4%).

27 Conclusion Prematurity was the most common reason for admission, followed by birth asphyxia, neonatal sepsis, and 28 jaundice. The overall mortality rate was 13%. Prematurity is a leading cause of neonatal mortality. 29 Neonatal tetanus has a high mortality rate. 30 31 Author summary Neonates were defined as those the in first 28 days of life. In humans, they are more vulnerable to 32 diseases than any other age group. Neonatal morbidity and mortality are major public health problems 33 with approximately 3.1 million babies worldwide dying each year in the first month of life. The main goal 34 35 of this study was to estimate the types of neonatal morbidity and mortality in Merwais Regional Hospital, located in Kandahar City, Afghanistan. This study found that premature birth (birth before 37 weeks of 36 37 gestation) was the most common reason for admission to the neonatal ward. Other common conditions 38 include neonatal sepsis, birth asphyxia, neonatal jaundice, and neonatal tetanus. The overall mortality rate 39 was high in the present study. The main cause of mortality was prematurity, followed by birth asphyxia and neonatal sepsis. Interventions should be planned and implemented at different levels in the 40 community to prevent and reduce the incidence of neonatal diseases and deaths. 41 42 INTRODUCTION 43 Neonatal health is a critical global concern, reflecting the national and global progress and challenges of health systems (1). Neonatal morbidity and mortality are major global public health challenges with 44 approximately 3.1 million babies worldwide dying each year in the first month of life (2). In 2022, nearly 45 half (47%) of all deaths in children under five years of age occurred in the newborn period (the first 28 46 47 days of life), which is among the most vulnerable periods of life and requires intensified quality intrapartum and newborn care (3). Most neonatal deaths occur in the first week of life and are 48 preventable with equitable access to adequate, evidence-based maternal and newborn healthcare (4). 49 50 Africa had the highest neonatal mortality rate in 2018, at 28 deaths per 1,000 live births, followed by 51 Central and Southern Asia, with 25 deaths per 1,000 live births (3). Similar to other developing countries, approximately three-fourths of under-five deaths occur in the early neonatal period in Afghanistan; this 52

53 proportion is about one-third of the total under-five deaths, and it is estimated that NMR was 22 per 1000 54 live births in Afghanistan in 2015 (5). While birth asphyxia, prematurity, and infections are the leading causes of adverse neonatal outcomes, 55 congenital anomalies contribute significantly to neonatal morbidity and mortality an estimated 7.9 million 56 57 children are born with major congenital anomalies every year, and the proportion of global neonatal mortality due to these defects increased from 3% in 2008 to 4.4% in 2013 (6). 58 59 A study conducted in Karachi, Pakistan, reported that the highest number of study participants had preterm birth, low birth weight, sepsis, respiratory distress syndrome, birth asphyxia, meconium 60 61 aspiration syndrome, neonatal jaundice, pneumonia, hyaline membrane disease, and congenital malformations. Of the 1069 patients, 148 died (13.8%) and one-third died due to sepsis (7). 62 Another retrospective study conducted on neonatal case management and outcomes in rural Rwanda 63 reported that premature birth, neonatal infection, and asphyxia were the three most common primary 64 65 diagnoses. The overall mortality rate was 13.3%, and neonates with prematurity and LBW had higher mortality rates than the others (8). 66 A study conducted in Kenya found that the clinical diagnoses of neonatal sepsis, prematurity, neonatal 67 jaundice, neonatal encephalopathy, tetanus, and neonatal meningitis accounted for over 75% of inpatient 68 69 neonatal admissions. The study also reported that, Tetanus 256/390 (67%), prematurity 554/1,280 (43%) 70 and neonatal encephalopathy 253/778(33%) had the highest case fatality (9) A study was conducted in India has reported that, Hyperbilirubinemia (7%) was the leading cause of 71 neonatal morbidity, followed by sepsis (3.99%) and respiratory distress (3.9%). 72 Congenital 73 malformations were observed in 1.75% of cases. In this study, birth asphyxia (29.85%) and respiratory distress (22.38%) were the leading causes of death, 74 followed by extreme prematurity (22.3%), and sepsis (14.9%) (7). 75 76 A study conducted in a tertiary hospital in Nigeria reported that the common morbidities were neonatal

sepsis (39.3%), prematurity (16.9%), birth asphyxia (18.2), and neonatal jaundice (12.0%). Neonatal

tetanus and congenital anomalies were responsible for 4.0% and 2.3% of the patients, respectively.

79 In this study, the highest mortality was observed in premature birth (26.1), neonatal sepsis (24.6%), and 80 severe birth asphyxia (23.2%). Neonatal tetanus and neonatal jaundice were responsible for (13.0%) and (7.2%) respectively (10). MATERIALS AND METHODS 82 83 Study design and study area We conducted a hospital-based cross-sectional descriptive study of all neonates admitted to the NICU of 84 the Pediatrics Ward of Mirwais Regional Hospital between March 2023 and February 2024 (Hamal 1, 85 1402 and Hoot29, 1402). Mirwais Regional Hospital was constructed by China in 1979 to provide health 86 87 services for people from five provinces in the southwest region of Afghanistan, which is in Kandahar 88 City, Afghanistan. The inclusion criteria were all neonates admitted to the NICU of the pediatric ward 89 from birth to 28 days of age. 90 The objective of the study was to determine the pattern of neonatal morbidity and mortality as well as compute case fatality rates in Mirwais regional hospital in Kandahar city, Afghanistan. 92 Ethical considerations This study was approved by the Kandahar University Ethics Committee (code number KDRU-EC-93 94 2023.15). Only patient initials and medical registration numbers were used for data collection. Prior to 95 entering the computer for the analysis, the collected data were coded and de-identified. Informed consent 96 was not obtained from any patient (not applicable). 97 Samples Collection 98 Medical records of all neonates admitted to the NICU of the pediatric ward from March 2023 to February 99 2024 (Hamal 1, 1402 to Hoot29, 1402) were retrieved and analyzed. A pro forma record form was designed and used to extract information from the medical records. 100 101 Statistical Analysis 102 The data were analyzed using IBM SPSS version 26. In this study, we used descriptive statistics such as 103 frequency and percentage. Instead of the names of participants by using codes and numbers, the

Results

Morbidity: In our study, there were 3387 newborns admitted to the neonatal ward of Mirwais Regional Hospital over a one-year period (from March 2023 to February 2024). Prematurity was the most common reason (1048/3387, 30.9%) for admission in the neonatal ward. Other common conditions included neonatal sepsis (909/3387, 26.8%), birth asphyxia (785/3387, 23.1%), neonatal jaundice (466/3387, 13.7%), and neonatal tetanus (9/3387, 0.3%). Surgical causes contributed to (170/3387, 5.0%) morbidities, as shown in Table 1.

Mortality: The overall mortality rate was 13.0% (442/ 3387). Major causes of mortality were prematurity (39.8%, 176/442), birth asphyxia (25.6%, 113/442) and neonatal sepsis (22.1%, 98/442). Other causes of mortality were neonatal jaundice (7.9%, 35/442), neonatal tetanus (0.9%, 4/442), and surgical diseases (3.6%, 16/442) (Table 1).




Figure 1: case fatality rates

Case fatality rates: Figure 1 shows the case fatality rates in our study. Neonatal tetanus had the highest case fatality rate (44.4%), followed by premature birth (16.8%), birth asphyxia (14.4%), and neonatal sepsis (10.8%). The fatalities for neonatal jaundice and surgical diseases were 7.5% and 9.4%, respectively.

## Discussion

This study revealed the morbidity and mortality of neonatal diseases and computed the case fatality of neonatal diseases admitted to Mirwais Regional Hospital in Kandahar City, Afghanistan. In this study, the common causes of neonatal morbidities were prematurity (30.9%), neonatal sepsis (26.8%), birth asphyxia (23.1%), neonatal jaundice (13.7%), neonatal tetanus (0.3%), and surgery (5.0%). Similar patterns have been reported in several previous studies. Shahani et al. reported that the main causes of neonatal admission in Pakistan wards were sepsis (17.0%), prematurity (14.01%), birth asphyxia (10%), and neonatal jaundice (5.25%). The patterns of neonatal admissions were similar to those observed in our study (19). Another study from Pakistan reported that the main patterns of neonatal admission were prematurity (32.30%), sepsis (28.91%), birth asphyxia (11%), and neonatal jaundice (5%) (16) A study conducted in Nigeria by also et al. reported that the common causes of neonatal admission in the neonatal ward were neonatal sepsis (39.3%), prematurity (16.9%), birth asphyxia (18.2%), neonatal jaundice

(12.2%), and neonatal tetanus (4%) (10). The reported patterns seems same as in our study, but the frequency of prematurity in our study was higher ( 30.9% vs 16.9%) and lower frequency of neonatal tetanus in this study (0.3% vs 4.0%) (10), the same result was also reported from another study from Nigeria (11) A study conducted in India by Saini et al. showed similar results. They reported that the most common causes of neonatal morbidity were neonatal jaundice (7.0%), prematurity (4.3%), and birth asphyxia (4.0%). This result is similar to that of the present study (7). A study from South Africa reported more admissions due to sepsis, jaundice, and asphyxia (12). The patterns are different in developed countries. A study from Canada revealed that the main causes of neonatal admission were extreme prematurity, asphyxia, and congenital anomalies (13). The overall mortality rate was 13.0% (per 100 morbidities). Several studies from different parts of the world have reported similar results. A study done by Kumar et al. reported a mortality rate of 13.6% (14). A study by Saini et al. in India reported a mortality rate of 11.3% (7). A study conducted in Nigeria by U et al. reported a similar result (13.2%) (10). A study by Ekwochi et al. reported a mortality rate of 14.2 %, which is similar to that in our study (15). A study conducted in Pakistan reported a mortality rate of 17.15% (16). A study from Bangladesh reported a slightly higher mortality rate than our study (20.6% vs. 13.0%) (17). This variation may be due to other factors and facilities available in neonatal intensive care units because neonatal survival is dependent on these factors. In our study, prematurity was found to be a leading cause of neonatal mortality (39.8%), followed by birth asphyxia (25.6%), and neonatal sepsis (22.1%). Neonatal jaundice and tetanus were responsible for 7.9% and 0.9% of patients, respectively. Surgical causes accounted for 5% of neonatal mortality. A study by Saini et al. reported that the leading causes of neonatal mortality were birth asphyxia (29.85%), prematurity (22.38), and neonatal sepsis (15%) (7). Another study from India reported that premature birth (25.68%) was a common cause of neonatal mortality. (18). Another study done by Also U reported that premature birth, neonatal sepsis, severe birth asphyxia, and neonatal tetanus are major causes of neonatal mortality (10). A study conducted by Hussain in Pakistan reported that prematurity (26.78%)

was the leading cause of neonatal mortality, followed by birth asphyxia (21.81%) and neonatal sepsis (15.22%) (16). Neonatal tetanus was associated with a high mortality rate (44.4%). This result was the same as that of a study by U (42.8%) (10). Again, these variations are due to the availability of modern facilities and trained health professionals in the neonatal wards. Conclusion In this study, premature birth was the most common reason for admission, followed by birth asphyxia, neonatal sepsis, and neonatal jaundice. Overall mortality rate was 13%. In our study, we found prematurity to be the leading cause of neonatal mortality, followed by birth asphyxia and neonatal sepsis. Neonatal tetanus had high fatality rate. Limitations A major limitation of this study is incomplete data, which is common in retrospective data collection. We were unable to retrieve all demographic and clinical information regarding the neonates in this study... Furthermore, this was a hospital-based cross-sectional descriptive study, and may not be generalizable to the general population.
