Identification and characterization of collagen XXIII alpha 1 as a novel risk factor for eczema herpeticum

Abstract

Eczema herpeticum (EH) is a potentially life-threatening disseminated skin infection caused by herpes simplex virus (HSV) in a subset of patients with atopic dermatitis (AD). Genetic factors play a pivotal role in EH development. Herein, we identify a single nucleotide polymorphism (SNP) rs2973744 in the gene encoding collagen XXIII alpha 1 chain (Col23a1) as a novel genetic risk factor for EH using whole exome sequencing. EH-patient-derived primary keratinocytes carrying the SNP rs2973744 show elevated *COL23A1* mRNA and total protein levels as well as increased susceptibility to HSV-1. We discover that increasing Col23a1 levels enhances HSV-1 infection in human keratinocytes. The transcriptomic analysis unveils that *COL23A1* overexpression dampens keratinocyte immune responses, thereby elucidating the molecular mechanism underlying exacerbated HSV-1 susceptibility. Our findings report a novel potential screening marker and therapeutic target for EH and reveal Col23a1's unexplored role in HSV-1 pathogenesis.

Introduction

Atopic dermatitis (AD) is a common chronic inflammatory skin disease that affects 20% of children and 2-5% of adults worldwide ^{1, 2, 3}. It is a multi-factorial disease influenced by genetic, immunological and environmental factors. Patients suffering from AD have an impaired skin barrier with type 2-dominated immune responses and heightened allergen sensitization. This presumably renders them more susceptible to bacterial and viral infections, including infections with herpes simplex virus (HSV) ^{4, 5, 6, 7}. Around 67% and 13% of humans worldwide have been

exposed to HSV-1 and HSV-2 respectively, however, most of them develop no or only minor symptoms ⁸.

HSV-1 is an enveloped double-stranded DNA virus that infects stratified epithelial cells of skin, mucosa or cornea, where the predominant cell type is keratinocytes. HSV-1 enters keratinocytes either by fusion at the cell membrane or through the endocytic pathway ^{9, 10}. After fusion of the viral envelope with a cellular membrane, incoming capsids are transported to the nucleus where viral transcription takes place in a regulated cascade-like manner, starting with the immediate-early genes, followed by early and finally late genes ^{11, 12, 13, 14}. After primary infection of stratified epithelial cells, HSV-1 spreads to neurons and establishes a lifelong latency in trigeminal or dorsal root ganglia. Upon reactivation, it can be transported back to the original dermatome in the skin or mucosa ^{11, 13, 15, 16, 17}.

In a subgroup of AD patients, HSV can cause severe disseminated infections, referred to as eczema herpeticum (EH)^{7, 18}. EH can lead to life-threatening encephalitis or even death if left untreated or misdiagnosed, therefore, EH is considered as a dermatological emergency¹⁹. Approximately 22% of moderately to severely affected AD patients report at least one episode of EH ^{7, 18, 20}. Notably, over 50% of these individuals have had recurrent episodes. These findings suggest genetic predispositions as contributing factors in EH development.

Previous studies identified several genetic factors associated with EH ²¹. Particularly, the R501X mutation in filaggrin, an important structural protein involved in skin barrier function, increased the risk of developing EH threefold in AD patients ^{22, 23}. SNPs in CLDN1 and CLDN16 encoding the tight junction proteins claudin-1 and claudin-16, and in SIDT2 and RBBP8NL encoding SID1 transmembrane family member 2 and RBBP8 N-terminal like, are also associated with an increased risk of EH in AD patients, and silencing CLDN1, SIDT2 or RBBP8NL increases HSV-1 infection ^{24, 25, 26}.

Here, we performed whole exome sequencing in AD patients without (ADEH-) or with a history of EH (ADEH+) to discover further genetic variants associated with EH. Our study identified a novel heterozygous SNP in *COL23A1*, rs2973744, to be significantly associated with EH development (χ^2 -test: p=0.034). This SNP rs2973744 in *COL23A1* causes a thymine to cytosine substitution at a splice donor site of the transcript allele between exons 10 and 11 leading to enhanced protein expression in keratinocytes. Moreover, we report that increased expression of Col23a1 enhances HSV-1 infection in keratinocytes by downregulating genes involved in immune responses.

Results

Whole exome sequencing revealed a novel single nucleotide polymorphism (SNP) in *COL23A1* rs2973744 associated with eczema herpeticum. To identify novel genetic risk factors for EH, we performed next-generation whole exome sequencing (WES) of nine ADEH+ patients and their respective first-degree relatives and identified the single-nucleotide polymorphism (SNP) rs2973744 in the gene *COL23A1* located on chromosome 5q35. Three out of the nine ADEH+ patients and one out of the unaffected healthy relatives were carriers of the heterozygous SNP rs2973744. This genetic variant was further validated in a larger cohort comprising 117 ADEH+ and 117 ADEH- patients ²⁷ (GENEVA cohort and RESIST HSV/AD cohort), and 118 healthy controls ²⁸ (POPGEN cohort). DNA was obtained from each group and Taqman PCR was used to investigate the occurrence of this variant. As shown in Table 1, the occurrence of the SNP rs2973744 was observed in 5% of ADEH+ patients, 1.6% of healthy donors and 0% of ADEH- patients, thus making rs2973744 significantly associated with EH in this group of AD patients (χ^2 test: p=0.034).

Primary human keratinocytes from an ADEH+ patient with SNP rs2973744 expressed higher Col23a1 levels and were more susceptible to HSV-1 than keratinocytes from ADEH- patients. Since epidermal keratinocytes are the major entry portal for HSV-1 infections of the skin ¹⁴, we investigated the role of Col23a1 in HSV-1 infections of keratinocytes. Therefore, we first analyzed the susceptibility of primary keratinocytes isolated from hair follicles of ADEH- or ADEH+ patients to a recombinant HSV-1 strain expressing green fluorescent protein (GFP) as a reporter [HSV1-GFP, multiplicity of infection (MOI) of 0.75 plaque-forming units (PFU)/cell]. To avoid the effect of differentiation stages on HSV-1 susceptibility between primary hair keratinocytes derived from different patients, cells were pre-stimulated with 1.4 mM CaCl₂ for 24 h before each experimental set-up. HSV1-GFP expression was higher in keratinocytes from an ADEH+ patient with the COL23A1 SNP than in keratinocytes derived from a healthy donor, or ADEH- patients without or with the SNP (Figure 1a). To investigate whether COL23A1 expression differed between the groups and could possibly be a factor affecting HSV-1 susceptibility, we measured their relative COL23A1 transcript and total protein levels. Primary keratinocytes isolated from the ADEH+ patient carrying the SNP rs2973744 had the highest COL23A1 mRNA and protein levels as confirmed by RT-qPCR and Western blotting respectively. (Figure 1b-d). In keratinocytes carrying the SNP the 75 kDa band was stronger than the 60 kDa band, while in healthy keratinocytes the 60 kDa band was more prominent than the 75 kDa band. Moreover, keratinocytes harbouring the SNP had an additional band between 60 and 75 kDa, which was not observed in the keratinocytes without the SNP. These data suggest that the SNP at the splice donor site results in differentially processed *COL23A1* mRNA forms, possibly due to alternative splicing.

In summary, increased total Col23a1 levels in keratinocytes from an ADEH+ donor with the SNP rs2973744 correlated with more efficient HSV-1 infection suggesting that this SNP together with other genetic factors associated with EH increases *COL23A1* expression and susceptibility to HSV-1.

Inhibiting furin enhanced Col23a1 levels on the surface of primary keratinocytes and their susceptibility to HSV-1. Collagen XXIII alpha 1 chain exists in a full-length membranebound form and a short soluble ectodomain. The cleavage of Col23a1 in the Golgi/*trans*-Golgi network is catalyzed by proteases, primarily by the enzyme furin ²⁹. Since most of the Col23a1 is shed in cultured cells ³⁰, we blocked its shedding and analyzed by flow cytometry how enhanced cell surface levels of Col23a1 affect HSV-1 infection. We first treated keratinocytes with 75 μ M furin inhibitor I (FI) for 20 h and then infected them with 0.75 pfu/cell of HSV1-GFP for 20 h in the absence of this inhibitor. FI significantly increased cell surface levels of Col23a1 (Figure 2a) and HSV1-GFP expression in primary keratinocytes (Figure 2b) by 2 and 2.5-fold, respectively, indicating that elevated Col23a1 levels on the cell surface might promote HSV-1 infection.

Stable overexpression of *COL23A1* **in HaCaT cells enhanced susceptibility to HSV-1.** To confirm the effect of higher Col23a1 expression on enhanced susceptibility to HSV infection we developed a cell culture model of stable *COL23A1* overexpression in the human immortal keratinocyte cell line HaCaT. After transduction with control (ctrl) or *COL23A1* encoding lentiviral vectors, HaCaT cells overexpressed *COL23A1* at the mRNA (Figure 3a) and protein level (Figure 3b, 3c) as revealed by RT-qPCR, flow cytometry and Western blot, respectively. To discern the effect of Col23a1 on HSV-1 infection, we infected ctrl or *COL23A1* overexpressing HaCaT cells with 1 pfu/cell of a recombinant HSV-1 strain expressing mCherry (Che) as a reporter (HSV1-Che). The susceptibility to HSV-1 was measured by quantifying mCherry expression at 20 hpi with flow cytometry. *COL23A1* overexpression significantly increased HSV1-Che expression by about 1.6-fold (Figure 3d), which is consistent with our FI data.

HSV-1 cell-to-cell spread increased upon *COL23A1* **overexpression in HaCaT cells.** After 20 h of infection with an MOI of 1 pfu/cell, the virus released from the primarily infected cells has presumably spread to neighboring cells resulting in a second, if not a third, infection cycle. To investigate whether the higher susceptibility of *COL23A1* overexpressing cells was due to increased cell-to-cell spread we infected the cells at very low MOIs of HSV1-Che and quantified the number, size, and intensity of plaques. Interestingly, plaque numbers were increased approximately 2-fold by trend and plaque size and mCherry intensity were slightly but significantly increased in *COL23A1* overexpressing HaCaT cells (Figure 4a-d) thereby indicating that Col23a1 enhanced both initial HSV-1 infection of HaCaT cells as well as cell-to-cell spread.

COL23A1 overexpression enhanced HSV-1 gene expression in HaCaT cells. After injection of the HSV-1 genome into the nucleus of an infected cell, it is transcribed in a cascade-like manner starting with immediate-early genes (IE), followed by early (E) and late genes (L) ¹². Products of IE genes are required for the transcription of E genes, which then encode proteins required for viral DNA synthesis. The products encoded by IE and E genes are further employed for efficient L gene transcription. To better understand which stage of HSV-1 gene expression is affected upon *COL23A1* overexpression, we infected control and *COL23A1* overexpressing HaCaT cells with MOI 5 of HSV-1 and harvested at different time points (2 hpi, 4 hpi, 6 hpi and 8 hpi). We then quantified mRNA expression of two late (*UL19, UL27*), early (*UL23, UL42*) and immediate-early (*UL54, US12*) genes by RT-qPCR (Supplementary Figure S1). We selected 6 hpi and 8 hpi time-points to analyze HSV-1 gene expression in three independent experiments (Figure 5a-f). Interestingly, HSV-1 genes of all the three kinetic classes were upregulated upon *COL23A1* overexpression, thus indicating that *COL23A1* overexpression increases HSV-1 infection at or upstream of immediate-early gene transcription.

COL23A1 overexpression in HaCaT cells dampened the expression of genes involved in immune responses. To understand the underlying mechanism by which *COL23A1* overexpression increases HSV-1 susceptibility, cell-to-cell spread and viral gene expression, we analyzed the global transcriptomics of these cells using bulk RNA-seq analysis. We infected control and *COL23A1* overexpressing HaCaT cells with MOI 5 of HSV-1 and isolated their RNA after 2 hpi and 6 hpi. After generating and sequencing cDNA libraries we detected 225 differentially regulated genes in pooled HSV-1 infected and uninfected *COL23A1* overexpressing HaCaT cells $(p-adj \le 0.05)$. Out of those 225 genes,

we shortlisted 189 genes with log 2-fold change [log2(FC)] value of >0.5 or <-0.5 as shown in the volcano plot (Figure 6a). As expected, the highest change was observed in *COL23A1* expression with a value of 8.04 log2(FC) upon *COL23A1* overexpression (not shown). Interestingly, several genes involved in innate or adaptive immune responses like *IL1R1, IL32*, *TLR4, CFH, C3, S100A9, IRF1, ADAM23* were significantly downregulated and *TNC* and *SPINK5*, two genes associated with AD ^{31, 32, 33, 34}, were significantly upregulated (Figure 6b). Kyoto Encyclopedia of Genes and Genomes (KEGG) and Gene ontology (GO) pathway analyses reflected a significant suppression of immune responses, inflammatory responses and their regulation, cytokine production as well as regulation of cell adhesion upon *COL23A1* upregulation (Figure 6c-d).

RT-qPCR confirmed the downregulation of several host genes involved in an effective immune response and upregulation of those associated with AD in uninfected *COL23A1* overexpressing cells as compared to control cells (Figure 7), suggesting that *COL23A1* overexpression enhances the susceptibility of keratinocytes to HSV-1 by dampening immune responses.

Discussion

Previous studies identified various genetic risk factors involved in EH using GeneChip profiling, genotyping, targeted resequencing approaches and WGS ^{22, 24, 35, 36, 37, 38, 39}. In our study, we observed a significant novel association of SNP rs2973744, affecting *COL23A1* in 5% of ADEH+ patients. The SNP rs2973744 results in the presence of C instead of T at the splice donor site of an exon-intron boundary between exons 10 and 11 of the *COL23A1* transcript allele. SNPs at splice donor sites of several genes generally lead to exons skipping or generation of differentially spliced transcripts (Yamaguchi et al. 2002; Anna and Monika 2018). Interestingly, a SNP which leads to C instead of G at the splice donor site in thrombopoietin gene (*THRO*), resulted in elevated thrombopoietin protein (TPO) serum levels in patients with hereditary thrombocythaemia. This was an effect of more efficient translation of the resulting mutated transcripts than the wild type transcripts ⁴⁰. Here we show that the heterozygous SNP in *COL23A1* results in a novel, differentially processed form of Col23a1 and, in the presence of other risk factors for EH, leads to higher transcript and total protein levels.

AD is a complicated multifactorial disease, resulting from genetic aberrations, abnormalities in the immunological response as well as environmental factors ^{5, 6, 41}. A sub-group of patients suffering from AD is more prone to severe HSV-1 infections resulting in EH development ^{7, 18, 20}. In line with that, we show here that primary keratinocytes isolated from an ADEH+ patient carrying the SNP rs2973744 were more susceptible to HSV-1 than those from ADEH- patients.

Moreover, the *COL23A1* expression was increased in these patient-derived keratinocytes implying that higher levels of Col23a1 correspond to higher susceptibility to HSV-1.

Collagen type XXIII alpha 1 chain (Col23a1), encoded by *COL23A1*, is a type II transmembrane protein, with an N-terminal cytoplasmic domain, one hydrophobic transmembrane domain and three extracellular collagenous domains, flanked by short non-collagenous domains ⁴². It shares structural homology with collagen XIII and XXV. Col23a1 is a ligand for integrin $\alpha 2\beta 1$ and is expressed in skin, brain, lung, cornea, tendon and kidney ^{30, 43}. Alternative splicing results in three Col23a1 isoforms ^{44, 45} (Human Protein Atlas proteinatlas.org).

Col23a1 belongs to the class of non-fibrillar collagens and is located in its full-length form (75 kDa) in the lipid rafts of the cell membrane, or is cleaved by proteases, principally furin, in the Golgi/trans-Golgi network. The resulting ectodomain (60 kDa) is secreted from the cells into the extracellular matrix ^{29,42}. The shedding of Col23a1 depends on the tissue and the cholesterol content in the plasma membrane ²⁹. Interestingly, the full-length Col23a1 is predominantly present in skin, whereas, in brain, the shed form of Col23a1 takes precedence, thus hinting at potentially divergent roles for the two forms ⁴³.

Previous work showed that in cultured primary keratinocytes, Col23a1 was undetectable on the cell surface due to cleavage of the full-length protein by furin ³⁰. Here, we also detected only low amounts of Col23a1 on the cell surface of primary foreskin keratinocytes. To study the effect of increased membrane levels of Col23a1 on HSV-1 infection, we reduced the shedding of Col23a1 by treating keratinocytes with FI and then infected them with HSV-1 in the absence of FI. Furin is a protease involved in the maturation and activation of envelope proteins of many viruses such as SARS-CoV-2, HIV, influenza, and Ebola. The proteolytic activation of viral proteins by furin can either occur during virus maturation, or viral entry into newly infected cells ⁴⁶. Therefore, furin inhibitors are considered for their potential use as anti-viral drugs ⁴⁷.

In our study furin inhibition increased the susceptibility of keratinocytes to HSV-1, possibly by enhancing Col23a1 levels on the cell surface. Even though HSV-1 proteins do not contain furin cleavage sites, we cannot exclude that furin inhibition increased the susceptibility to HSV-1 by interfering with the proteolytic maturation of additional host factors ^{46, 48}. As a second and more specific approach to study the effect of Col23a1 in HSV-1 infection, we overexpressed *COL23A1* in primary foreskin keratinocytes. Unfortunately, the cells stopped growing after transduction; therefore, we repeated the *COL23A1* overexpression in HaCaT cells with better success. Consistent with the FI experiment, we show here, that *COL23A1* overexpression significantly increased the susceptibility of HaCaT cells to HSV-1.

The clinical relevance for Col23a1 as a potential biomarker has been explored in several cancers ^{49, 50, 51}. Knockdown of *COL23A1 in vitro* reduces cell adhesion and impairs anchorageindependent growth. Moreover, overexpression of *COL23A1* enhances cell adhesion in cancer cell lines, suggesting that Col23a1 promotes metastasis by aiding cell-cell and cell-matrix interactions and assisting anchorage-independent cell growth ⁵².

Interestingly, the class A macrophage scavenger receptor (MARCO), a protein distantly related to Col23a1, is reported to increase HSV-1 susceptibility in keratinocytes by enhancing virus binding to host cells ⁵³. Moreover, MARCO-/- mice are protected against HSV-1 infections. Surprisingly, another study reported that epidermal sheets and primary dermal fibroblasts from MARCO-/- mice are as efficiently infected by HSV-1 as those isolated from control mice, suggesting that MARCO is not required for HSV-1 entry into the epidermis and dermal fibroblasts ⁵⁴. However, to date, no studies have investigated the role of Col23a1 in viral infections. Therefore, our study is the first to report that elevated Col23a1 levels increase the susceptibility of keratinocytes to HSV-1.

To better understand the exact mechanism(s) behind increased HSV-1 gene expression in *COL23A1* overexpressing cells, we subjected the HaCaT cells to RNA sequencing. The transcriptome data revealed that *COL23A1* overexpression led to the downregulation of several genes, such as *IL1R1*, *IL32*, *TLR4*, *CFH*, *C3*, *S100A9*, *IRF1*, and *ADAM23* which are involved in the immune response of keratinocytes. Interestingly, upregulation of *TNC* (tenascin C) and *SPINK5* (serine peptidase inhibitor Kazal type 5), which are associated with AD ^{33, 55}, was also observed in these cells. The mRNA levels of the above-mentioned genes were further validated using RT-qPCR.

In conclusion, our data show that elevated Col23a1 levels promote more efficient HSV-1 infection of keratinocytes presumably by attenuating their immune response. Consistently, AD patients carrying the heterozygous SNP rs2973744 are predisposed to develop severe HSV-1 infections. Early screening for the SNP rs2973744 in AD patients with recurrent HSV-1 infections might help to prevent disseminated HSV-1 infections through awareness and early therapeutic intervention.

Methods

Study subjects. The recruitment of patients suffering from AD with or without a history of EH was carried out at the Department of Dermatology and Allergy of Hannover Medical School, Germany. AD was diagnosed in the patients according to Hanifin and Rajka criteria ⁵⁶. The ethics committee of Hannover Medical School (No. 8733_BO_S_2019) approved this study

and all study participants provided written informed consent. DNA samples from AD patients with and without a history of EH were derived from the GENEVA cohort, Biobank of the University Hospital Schleswig-Holstein (UKSH), Kiel, Germany.

Whole exome sequencing. Whole exome sequencing was performed at RCUG Genomics Core Facility of Hannover Medical School. The analysis involved 9 patients with a history of EH and first-degree healthy relatives of 7 patients. SureSelect^{XT} Target Enrichment System (Agilent, Santa Clara, CA, USA) and a NextSeq (Illumina, San Diego, CA, USA) sequencing device was used to perform sequencing. The analysis of data was performed using an established pipeline involving PrinSeq, FastQC, cutadapt, BWA, SAMtools or GATK. Genetic variants that occurred in more than one EH patient with a minor allele frequency <1% in the 1000 Genomes and ExAC databases and were rated 'deleterious', 'possibly damaging' or 'probably damaging' by MetaLR, Sift, PP2_HVAR, or PP2_HDIV, respectively were considered as the candidates. TaqMan-PCR was employed to re-analyze candidate variants in an age/sex-adjusted manner on three larger cohorts, comprising 117 AD patients with EH history, 117 AD patients who never experienced EH and 118 healthy controls from the POPGEN cohort and analyzed by χ^2 test (GraphPad Prism V5, Graphpad, LaJolla, CA, USA).

Cell culture. Primary hair keratinocytes were derived from the outer root sheath of the hair follicle as previously described (Wang et al. 2008). The primary foreskin keratinocytes were isolated from the foreskin of anonymous children undergoing surgery as described (Wittmann et al. 2005). The consent of patients for experiments involving primary foreskin keratinocytes was not required as German laws consider leftover human tissue after surgery as discarded material. Primary hair and foreskin keratinocytes were cultured in Keratinocyte Growth Medium 2 (PromoCell, Heidelberg, Germany) supplemented with Keratinocyte Supplement Pack (KGM2; PromoCell). Primary hair keratinocytes were pre-stimulated with 1.4 mM CaCl2 (Carl Roth, Karlsruhe, Germany) for 24 h for each experimental set-up. MaxGel[™] ECM (Merck, Darmstadt, Germany) was coated onto culture flasks to support the growth of primary hair keratinocytes. HaCaT cells, a spontaneously immortalized keratinocyte cell line ⁵⁷, were cultivated in RPMI 1640 medium (Gibco by life technologies, Thermo Fisher Scientific, MA, USA) supplemented with 2 mM L-glutamine (Bio & Sell GmbH, Feucht, Germany), 100 µg/ml penicillin-streptomycin (Bio & Sell), 1x non-essential amino acids (Bio & Sell), 0.05 mg/ml gentamicin (Bio & Sell) and 6% (vol/vol) fetal bovine serum (FBS; PAN Biotech, Aidenbach, Germany).

BHK-21 [American tissue culture collection (ATCC), certified cell line 10 (CCL-10)] were cultured in minimum essential medium (MEM; Cytogen, Sinn, Germany) supplemented with

10% (vol/vol) feta calf serum (FCS; Life Technologies, Gibco, Darmstadt, Germany) and Vero cells (ATCC, CCL-81) were cultured in MEM with 7.5% (vol/vol) FCS.

Viruses. We used either parental HSV1(17⁺)Lox (HSV-1) ⁵⁸, HSV1(17⁺)Lox-_{pMCMV}GFP (HSV1-GFP for short) ⁵⁹, or HSV1(17⁺)Lox-_{pMCMV}mChe (HSV1-Che for short) ⁶⁰ expressing soluble GFP or mCherry under the control of the murine cytomegalovirus major immediate-early promoter, respectively. Virus was amplified by infecting BHK-21 cells with 0.01 pfu/cell. 60-90 hpi, virus was harvested from the supernatant of infected BHK, sedimented and titrated on Vero cells as described ^{61, 62}.

HSV-1 infection. To reach 80% confluency of cells on the day of infection, keratinocytes were plated one day before infection. Next day, cells were washed with PBS (PAN Biotech, Aidenbach, Germany) and KGM2 containing HSV-1 inoculum was added onto cells for 1 h and incubated at 37°C and 5% CO₂. After 1 h incubation, the medium containing the virus was replaced with KGM2. A further incubation of 20 h was carried out at 37°C and 5% CO₂. The virus strain and MOI used were assay-dependent and are described in the respective sections. HSV-1 infection was performed as described unless stated otherwise.

mRNA isolation and RT-qPCR. Keratinocytes were lysed and RNA was isolated using the ReliaprepTM RNA Miniprep Systems (Promega, Germany) according to the manufacturer's instructions. cDNA was prepared by reverse transcription of RNA using the RevertAid RT reverse transcription kit (ThermoScientificTM, Dreieich, Germany). LightCycler[®] 480 SYBR Green I Master (Roche Molecular Biochemicals, Manheim, Germany) was used to perform quantitative real-time PCR (qPCR) on a LightCycler 480 (Roche Molecular Biochemicals). Expression of *COL23A1*, *UL19*, *UL27*, *UL23*, *UL42*, *UL54*, *US12*, *IL1R1*, *IL32*, *C3*, and *TLR4* were quantified relative to the expression of the host gene *RPS20* ($\Delta\Delta$ CT). Primers were purchased from Qiagen (QuantiTect Primers; Hilden, Germany) and TIB Molbiol (Berlin, Germany). Primer sequences are given in the supplementary table S1.

Flow cytometry. Keratinocytes infected with HSV1-GFP or HSV1-Che were washed twice with PBS, treated with 0.02% EDTA (5 min at 37°C; PAN Biotech, Aidenbach, Germany) and detached using 0.05% trypsin / 0.02% EDTA (5 min at 37°C; PAN Biotech). Trypsin inhibitor (PAN Biotech) was used to stop trypsinization, cells were then washed twice with 0.1% EDTA and fixed with 4% paraformaldehyde for at least 30 min at 4°C. GFP and mCherry expression were analyzed by flow cytometry (CytoFLEX, Beckman Coulter, CA, USA).

To detect Col23a1 cell surface levels, keratinocytes were washed twice with PBS, treated with 0.02% EDTA for 5 min and detached using Accumax (20 min at 37°C; PAN Biotech). Cells were incubated with either 8 μ g/ml IgG_{2B} isotype (cat. #MAB0041; R&D Systems, MN, USA)

or mouse monoclonal IgG_{2B} antibody against human collagen XXIII α 1 (cat. #MAB4165; R&D Systems, MN, USA) for 45 minutes at 4°C. Cells were then labeled with 1 µg/ml donkey polyclonal anti-mouse secondary IgG antibody (Alexa Fluor[®] 647 (AF647) fluorochrome) (Abcam, Cambridge, UK) for at least 30 min at 4°C. AF647 fluorescence was measured by flow cytometry (FACSCaliburTM, Becton Dickenson, NJ, USA).

To measure intracellular Col23a1 levels, keratinocytes were trypsinized as mentioned before. The protocol for the eBioscienceTM Foxp 3/ Transcription Factor Staining Buffer Set (InvitrogenTM, Thermo Fisher Scientific, MA, USA) was followed to stain intracellular Col23a1 levels by flow cytometry (CytoFLEXTM, Beckman Coulter, CA, USA) with the same antibodies used for detecting Col23a1 cell surface levels.

Protein lysate preparation and Western blotting. Cells were lysed on ice with M-PERTM Mammalian Protein Extraction Reagent (Thermo ScientificTM) containing protease inhibitor Pefabloc[®] SC (Merck) and incubated on a shaker for 5 min at 4°C. Cells were scraped off the culture plate and the contents were subjected to centrifugation at 14,000 x *g* for 10 min at 4°C. Supernatants were collected and protein concentrations were estimated using QubitTM Protein Assay kit (Invitrogen, MA, USA). Equal amounts of protein were loaded on 4-20% SDS-polyacrylamide gel (Bio-Rad Laboratories, CL, USA). The protein bands were transferred to the polyvinylidene fluoride membrane and blocked for 1 hour at room temperature with 5% milk. Proteins were probed using monoclonal mouse anti-GAPDH antibody (cat. #14C10; Cell Signaling Technologies, MA, USA) or monoclonal mouse IgG_{2B} anti-human collagen XXIII α 1 antibody (cat. #7076; Cell Signaling Technology). The blots were developed with SignalFireTM Elite ECL Reagent (Cell Signaling Technology) and images were captured using ChemiDoc Imaging System (Bio-Rad Laboratories). For quantification, the Image Lab software (Bio-Rad Laboratories) was used.

Furin inhibitor I. Primary foreskin keratinocytes were seeded to reach 80% confluency on the day of treatment. 75 μ M of Furin inhibitor I (FI) – Decanoyl-Arg-Val-Lys-Arg-chloromethylketon (Dec-RVKR-CMK; Bachem, Bubendorf, Switzerland) was added to the cells and incubated for 24 h at 37°C and 5% CO₂. The next day, cells were either used to analyze Col23a1 surface expression or their susceptibility to HSV1-GFP (0.75 pfu/cell) using flow cytometry.

Overexpression of *COL23A1***.** Control lentiviral particles (#LPP-NEG-Lv205-100) encoding EGFP and a puromycin resistance cassette and lentiviral particles encoding *COL23A1* (#LPP-Y2210-Lv205-100) in addition were purchased from GeneCopoeia, Rockville, MD, USA. One

day before transduction, HaCaT cells were seeded to reach 40% confluency on the day of transduction. Control and *COL23A1* lentiviral particles were incubated in transduction media containing RPMI and 3 μ g/ml polybrene (Merck) for 20 min at room temperature. Then, Y-27632 dihydrochloride (Rho kinase inhibitor; Abcam, Cambridge, UK) was added to the lentiviral particles at a final concentration of 10 μ M. This inoculum was transferred onto HaCaT cells (24 transducing units/cell) and incubated overnight at 37°C with 5% CO₂-atmosphere. The following day, media was replaced with fresh RPMI containing 10 μ M Rho kinase inhibitor and cells were incubated further at 37°C and 5% CO₂. 3 days after transduction, 15 μ g/ml puromycin was used for the selection of transduced cells. Overexpression was evaluated using RT-qPCR, flow cytometry and Western blot.

HSV-1 cell-to-cell spread analysis. HaCaT cells were seeded to reach 100% confluency on the day of infection. Cells were infected with HSV1-Che at very low MOIs of 0.001, 0.01 and 0.05 pfu/cell. At 20 hpi, cells were washed and fixed with 4% paraformaldehyde. Infection centers were visualized using the BioTek Cytation 5 Cell Imaging Multimode Reader, and plaque size and Cherry intensity were quantified using CellProfiler software (Carpenter et al. 2006).

HSV-1 temporal gene expression analysis. HaCaT cells were seeded to reach 100% confluency on the day of infection. Cells were infected with 5 pfu/cell of HSV-1 for 1 h at 37°C and 5% CO₂. After 1 h, media containing virus was replaced with fresh KGM2 and incubated further for 2 h (data not shown) 4 h, 6 h and 8 h. After 2, 4, 6 and 8 hpi, cells were lysed, RNA was isolated, and the expression of HSV-1 genes relative to the host gene *RPS20* was measured by RT-qPCR.

Bulk RNA-seq data analysis. Control and *COL23A1* overexpressing HaCaT cells were infected with 5 pfu/cell of HSV-1. At 2 hpi and 6 hpi, RNA and cDNA was prepared from cells as mentioned before. cDNA libraries were generated using 'NEBNext[®] Ultra II Directional RNA Library Prep Kit for Illumina' (E7760L; New England Biolabs) and sequenced using Illumina NextSeq 550 sequencer. The raw data files were processed using nfcore/rnaseq (version 3.9) and expression analysis was performed on the internal Galaxy (version 20.05). R package DESeq2 (version 1.42.1) was used to identify differentially expressed genes from raw gene counts, running on R version 4.3.3 within the RStudio IDE (version 2023.12.1+402)⁶³. A single-factor design was used in DESeq2. EnhancedVolcano package (version 1.20.0) was used to generate volcano plots of differentially expressed genes with a log2(FC) value of >0.5 or <-0.5 and heatmaps of the normalized counts of selected genes. Gene set enrichment analysis on

our list of differentially expressed genes to identify significantly enriched KEGG and GO biological processes was performed using R package ClusterProfiler (version 4.10.1)⁶⁴.

Statistical analysis. Data was assessed for normality and subsequently two-tailed Paired t-test (parametric test) or Mann-Whitney *U* test were used to compare group means or medians. Statistical analyzes and plots were generated using GraphPad Prism (version 8.0, GraphPad Software, San Diego, CA). Asterisks in the figures indicate p-values: *P < 0.05, **P < 0.01, ***P < 0.001. Box & whiskers plot represent the 10-90 percentiles.
