Table S2. Number of individuals per ancestry per cohort. By applying an ancestry percentage cut-off > 75%, the samples were stratified into the five super populations, South-Asians (SAS), East-Asians (EAS), Americans (AMR), Africans (AFR) and Europeans (EUR). Individuals who do meet the 75% cut-off were classified as ADMIX. Since most of the samples belonged to the European population, we also determined their percent ancestry to three major ethnicities, Northwestern (NWE), Southeastern (SEE), and Ashkenazi Jewish (AJE), using reference populations available from SNPweights v.2.1. European subjects were stratified into the above-mentioned ethnicities when their ancestry percentage was greater than 50%. Europeans who do not meet the 50% cut-off were classified as EUR. Note that NWE, SEE, AJE individuals are also EUR but are only counted in their respective column.
