Web Appendix 1: Transmission rates

The COVID-19 transmission rate. To estimate the transmission rate of COVID-19 for our stochastic model, we consider preliminary model based on a population divided into susceptible individuals (S), latently infected individuals (E), infected individuals (I), asymptomatic infected individuals (A), recovered individuals (R), and quarantined individuals (Q). Under this setup, we consider the force of infection given by

$$\lambda_{CW} = \frac{\beta_{CW}\alpha(t)(E+I)}{N},\tag{S1}$$

where N = and the transition between states of infection is given by,

$$\frac{dS}{dt} = -\lambda_{CW}S,$$

$$\frac{dE}{dt} = \lambda_{CW} S - \phi E - q_c E,$$

$$\frac{dI}{dt} = (1 - \psi)\phi E - \gamma I - q_c I,$$

$$\frac{dA}{dt} = \psi \phi E - \gamma A - q_c A,$$

$$\frac{dR}{dt} = \gamma I + \gamma A,$$

$$\frac{dQ}{dt} = q_c(E + I + A).$$

Using this differential equation model, we estimate the transmission rate $\beta_{CW} \approx 0.78/day$ (Web Figure 2) using data on positive COVID-19 tests, the proportion of asymptomatic to symptomatic cases (1), and the ratio of reported to non-reported incidence (2).

Social distancing function. To reflect the effect of social distancing in the local community we fit a piecewise function to cumulative incidence data of COVID-19 in New York State (Web Figure 2). The peicewise function assumes that adherence to social distancing decays exponentially, and is given by

$$\alpha(t) = \begin{cases} 1 & \text{if } t < 30 \text{ days,} \\ 1 - 0.55e^{-\frac{1}{280}(t - 30)} & \text{if } t \ge 30 \text{ days.} \end{cases}$$

Web Appendix 2: Incarceration and Release Rates

COVID-19 testing and quarantine rate. We estimate the testing and quarantining rate of the general community using available data on COVID-19 tests (3). Specifically, using a least squares procedure (Web Figure Y), we found that $\theta_C \approx 0.027/day$ (Web Figure 3).

Incarceration rate. To determine the rate of incarceration, ρ_{in} , we consider an incarceration facility with a capacity of 800 people that remain in the facility for an average duration of $1/\rho_{out}$ days. Therefore, for the facility to remain at capacity we require that inflow of newly incaracreated individuals equals the outflow of incarcerated individuals:

$$\rho_{in} C = \rho_{out} P$$
,

where C is the population size of the local community and P is the population size of the incarceration facility.

Web Appendix 3: The Reproductive Numbers and the Probability of a Major Outbreak

The basic reproductive number. To compute the basic reproductive number for COVID-19 infection we use standard next-generation techniques (4). Specifically, we use the stochastic model (Web Table 1-4), which has six compartments that contribute to transmission: C_I , C_A , W_I , W_A , P_I , and P_A , along with routines for robust numerical calculation of Jacobian matrices (5). It follows that the basic reproductive number for within incarceration facilities is

$$R_0^P = \rho \left(F |_{\substack{DFE \\ \beta_{CW} = 0}} V^{-1} \right),$$

and the basic reproductive number for local communities (Web Figure 4) is

$$R_0^C = \rho \left(F |_{\beta_{WP}=0}^{DFE} V^{-1} \right),$$

where DFE stands for the disease-free equilibrium, and ρ is the spectral radius operator.


The probability of a major outbreak. Given the definition of the basic reproductive numbers, the probability of a major outbreak in the incarceration facility given a single infected incarcerated individual (6) is approximately

$$1 - \frac{1}{R_0^P}.$$


Similarly, the probability of a major outbreak in the local community is

$$1-\frac{1}{R_0^C}.$$




Web Figure 1. Compartmental Diagram for COVID-19 infection and incarceration
