Supplementary Materials: Predicting pulmonary function from the analysis of voice: a machine learning approach

Supplementary Method:

Allergen challenge:

An allergen challenge test involves directly exposing a person to a substance to try to find out whether the person is allergic to it.

Bronchial challenge

A bronchial challenge test is a medical test used to assist in the diagnosis of asthma. The person's normal lung function will be measured first (also known as his/her baseline breathing). Then he/she will start the test. During the test, he/she will be asked to inhale doses of methacholine, a drug that can cause narrowing of the airways. If his/her lung function drops by 20% or more from his/her baseline, he/she may have asthma. The test takes about 90 minutes. The breathing test will be repeated after each dose of methacholine to measure the degree of narrowing or constriction of the airways, therefore, multiple test results will be produced from a person.

Forced Expiratory Volume (FEV)

Forced expiratory volume (FEV) measures how much air a person can exhale during a forced breath. The amount of air exhaled may be measured during the first second (FEV₁), second seconds (FEV₂), and/or third seconds (FEV₃) of the forced breath. A lower than normal FEV1 reading suggests that the person may be experiencing a breathing obstruction. In other words, a person who has asthma or COPD has a lower FEV₁ result than a healthy person. The normal values for FEV1 vary from person to person. They are based on standards for an average healthy person of their age, race, height, and gender. Each person has their own predicted FEV1 value based on these factors mentioned above. We can get our predicted normal value with a spirometry calculator. If we know our FEV₁ value already, we can enter it as well, and the calculator will tell us what percent of the predicted normal value our result is.

FEV1 can be converted to a percentage of the predicted normal value, termed as FEV1%. It is defined as follows:

$$FEV_1\% = \left(\frac{FEV_1}{Predicted FEV_1}\right) * 100$$

Reading material for participants.

Details of the features

- 1. **Roll-off at 85%/95%:** It represents the value in frequency below which is possible to find the 85%/95% of the total frequencies.
- 2. **Spectral flatness:** It is a measure to quantify how much noise-like a sound is, as opposed to being tone-like.
- 3. **Root mean squared energy:** The energy of a signal corresponds to the total magnitude of the signal. For audio signals, that roughly corresponds to how loud the signal is. The energy in a signal is defined as:

$$Energy = \sum_{1}^{N} |x(n)|^2$$

where x[1] is a frame of a signal and n is the length of a frame. The root mean squared energy in a signal is defined as:

$$\sqrt{\frac{1}{N}\sum_{1}^{N}|x(n)|^2}$$

- 4. Zero Crossing Rate: It indicates the number of times that a signal crosses the horizontal axis.
- 5. **Spectral centroid:** It is a measure used in digital signal processing to characterize a spectrum. It indicates where the centre of mass of the spectrum is located. Perceptually, it has a robust connection with the impression of brightness of a sound.
- 6. **Spectral bandwidth:** It is a measure of the extent of the spectrum. It is the wavelength interval in which a radiated spectral quantity is not less than half of its maximum value.
- 7. **Spectral contrast:** It considers the strength of spectral peaks and spectral valleys in each sub-band separately.
- 8. **Spectral Flatness:** It is defined as the ratio of the geometric mean to the arithmetic mean of a power spectrum.
- 9. **Mean amplitude:** It is the mean amplitude of various frequencies present in a sound signal. It is measured using Short Term Fourier transformation (STFT) of a signal. STFT converts a signal in such a way so that we can understand the amplitude of given frequency at a given time.
- 10. **Mean breath cycle duration:** Breath cycle duration is the duration from one breath chunk to the next breath chunk. The mean breath cycle duration is the mean of all breath cycle durations.

(a) Power spectogram of a breath segment

Supplementary Figure S1: Power spectrograms of a breathing chunk, and of a speech chunk from a sound file. It presents two power spectrograms: [a] Power spectrogram of a breathing chunk, [b] Power spectrogram of a chunk of a speech. In these spectrograms, we can observe that the breath segment exhibits higher frequencies, and the power of the signal is distributed more evenly throughout the time interval.



Supplementary Figure S2: Comparison of the breathing and speech chunks. The breathing chunks are compared with the chunks of the speeches. The features (please refer to Supplementary Background 1.5 for the details) have been extracted (by python package Librosa) from these chunks separately. Only 5 of them have shown substantial differences in terms of the features' values between the breathing chunks and the speech chunks. They are as follows: [a] Spectral contrast graph for the breathing chunks and the speech chunks; [b] Roll off at 95% for for the

breathing chunks and the speech chunks; [c] Root mean squared energy deviation for the breathing chunks and the speech chunks; [d] Spectral bandwidth for the breathing chunks and the speech chunks; [e] Mean amplitude for the breathing chunks and the speech chunks.



Supplementary Figure S3: Correlations of the features with each other. This figure represents the correlation of the features with each other. The Pearson correlation coefficient (PCC) has been calculated for each feature with others. Each box contains a correlation value between each other. The correlation values range from -1 to 1 where 1 means the features are highly correlated and -1 means they are also highly correlated but their correlation is negative.



Supplementary Figure S4: The patterns of the training and the testing datasets. This figure represents the patterns of the training and the testing datasets without considering any special case. In this case samples are randomly separated for the training and testing sets at a ratio of 0.7:0.3 respectively. The distribution pattern of the samples on each FEV1% in the training and the testing sets show an small difference. [1] the patterns of the training and the testing datasets while the training and the testing samples are separately in a balancing way (please refer to the Section 4.1.4). In this case, samples are also randomly separated for the training and testing sets at the same ratio mentioned above. Additionally, the samples are separated at this ratio in each FEV1% range. The distribution pattern of the samples on each FEV1% range in the training and the testing sets present a similar pattern.
