Supplementary Materials

Substantive deviations from pre-registered protocol

The fruit and vegetable outcome variable for RQ2 was pre-registered as an ordinal, categorical change score (increased, no change, reduced intake) computed by comparing intakes at each timepoint (consuming a few portions per day vs all other) to pre-COVID-19 intakes retrospectively reported at baseline (consuming a few portions per day vs all other). However, upon formulating the outcome variable and running models, there was insufficient variance in the data, and GEE models were not converging. This was due to having no participants in the 'all other' ethnicity level for decreasing fruit and vegetable intake. In order to retain the change element of the fruit and vegetable outcome and maximise value for guiding health policy by identifying unhealthy dietary changes, the outcome variable for fruit and vegetable intake was changed to a binary, categorical change outcome (reduced intake vs all other) computed by comparing intakes at each timepoint (consuming a few portions per day vs all other) to pre-COVID-19 intakes retrospectively reported at baseline (consuming a few portions per day vs all other). The GEE models used the logit link function for a binomial distribution.

Given that dietary behaviours are likely to impact on other dietary behaviours, HFSS meals intake explanatory variable was included in the predictors for a change in HFSS snacks, and HFSS snacks was included in the predictors for a change in HFSS meals.

Bayes Factors Robustness checks

Robustness checks were performed using alternative priors. For smoking status, a prior mean difference below -4.0 and above 11.0 HFSS snack portions per month produced the same outcome of no evidence for an effect.

Testing linearity of logit in the binary sensitivity analysis models

Continuous explanatory variables were tested for linearity of logit, and converted to categorical variables where the assumption was violated.

For binary fruit and vegetables RQ2 and complete case analysis, physical activity violated the assumption.

• Physical activity: based on a lower limit cut-off of heath recommendations of 150 minutes per week of moderate or 75 minutes of vigorous physical activity equating to 7.5 MET-hours per week [1,2], as the minimum recommended activity levels. (Table 3, Supplementary tables S2, S4 and S5).

For HFSS snacks sensitivity increase or decrease vs all other, HFSS meals violated the assumption.

 HFSS meals median intake: below median vs median and above at each timepoint. Supplementary tables S6 and S7.

Time-invariant predictors are obtained from participants' baseline responses. Time-variant predictors are collected at baseline, 3- and 6-month follow-up surveys.

- **Gender** (2 levels) 'Which of the following best describes how you think of yourself?' **female** (female), **all others** (male, non-binary, prefer not to say)
- Age. continuous.
- Ethnicity (2 levels) white (1 white), all others (Mixed/Multiple ethnic groups, Asian/Asian British, Black/African/Caribbean/Black British, Chinese, Arab, Other ethnic group, prefer not to say)
- Baseline occupation and working from home (3 levels) Unemployed, Employed from home,
 Employed not from home.
 - All participants were asked, 'What is your current main occupation (during COVID-19)?' Laid
 off during COVID-19, unemployed since before COVID-19, retired, homemaker, full-time
 parent or carer, unable to work due to disability, other, employed (full or part-time), selfemployed (full or part-time), student, furloughed during COVID-19.
 - Participants who answered as employed (full or part-time), self-employed (full or part-time), student, furloughed during COVID-19 to the question 'What is your current main occupation (during COVID-19)?' were asked, 'Can you do your work or study from home?' Yes, I can do all the work or study from home, I can only do some work or study from home, or No, my work or study cannot be done at home.

'What is the highest level of education that you have completed?' 0, below A-level (No formal qualification, GCSE/School certificate/O-level/CSE, Vocational qualifications (e.g. NVQ1+2)), or 1, A-level or above (A-level/Higher school certificate or equivalent (e.g. NVQ3), Bachelor degree or equivalent (e.g. NVQ4), Masters/PhD/PGCE or equivalent, Other).
 - Owned outright, Mortgage Rented from local authority, Rented from private landlord, Belongs to housing association, Shared ownership (part owned, part rented), Other. 'What was your household annual income before COVID- 19?' up to 13 499 GBP, 13 500-24 999 GBP, 25 000-49 999 GBP, ≥50 000 GBP, prefer not to say. 2 (Housing = Owned outright OR mortgage AND Income = 50 000+ GBP), 1 (Housing = All other AND Income = 50 000+ GBP), 1 (Housing = Owned outright OR mortgage AND Income = All other), 0 (Housing = All other AND Income = All other).

COVID-19 related (impact on well-being and lifestyle)

- Living arrangements (3 levels): alone, with children (with or without adults), with adults only.
 - Alone. Participants responding 'I live on my own' when asked 'How many persons other than yourself (including children) live with you now in the same flat or house? Participants answering, 'I live with 1 or more people' were asked: 'Do you live with any of these persons below?' Being able to select multiple responses: With my partner, husband/wife, boyfriend/girlfriend, with children 0-5 years old, with children 6-15 years old, with persons aged 16-69 (family or friends), with persons aged 70+ (family or friends), persons who you believe may be vulnerable to COVID-19 for any reason, persons who are in poor health

- With any children (with or without adults) (if participants respond with 'children 0-5 years old' or 'with children 6-15 years old')
- o **Adults only** (all other participants who did not say 'I live on my own' or did not select 'with children 0-5 years old' or 'with children 6-15 years old')

Socio-demographic

• **BMI.** Continuous. Participants were asked at baseline, 3 months and 6 months later, 'How much do you weigh? Please try to be as accurate as possible'. Participants could answer in 1lb/0.4-5kg increments, or answer 'don't know' or 'prefer not to say'. Participants were also asked 'What is your height? Please try to be as accurate as possible'. Participants could answer in 1 inch/2-3 cm increments, or answer 'don't know' or 'prefer not to say'. BMI was calculated as weight (kg)/height² (m), by converting height into metres. Prefer not to say or don't know responses were excluded.

COVID-19 related (impact on well-being and lifestyle)

- Isolation 'Which type of COVID-19 induced isolation are you experiencing?' (2 levels) total and some (Total isolation/quarantine, Some isolation), general and no isolation (General isolation, No isolation)
- Composite wellbeing, social and living measure: At baseline: 'How would you rate the below aspects of your life in the since COVID-19? (i) Living, (ii) wellbeing, (iii) social, (iv) family'. At follow-up: 'How would you rate the below aspects of your life in the past month?' 1-5: 1 poor, 2, 3 average, 4, 5 excellent. Continuous mean score of living + wellbeing + social + family (1-5)

Behavioural

- Fruit and vegetables intake. Continuous, from baseline-since-COVID-19 to 6 months. This predictor was used in the (i) HFSS snacks and (ii) HFSS meals intake analysis only.
- **HFSS snacks** and **HFSS meals intake.** Continuous, from baseline-since-COVID-19 to 6 months. These predictors were used in the (iii) fruit and vegetables intake analysis only.
- **Physical activity. Continuous.** A continuous measure of MET-hours per week from baseline-since-COVID-19 to 6 months was computed using weekly strength training and assuming a session length of 45 minutes, and using weekly aerobic training frequency and aerobic session length.
 - Weekly strength training. 'Since COVID-19, on average, on how many days per week have you done strength training?' 0 days per week, 1 day per week, 2 days per week, 3 days per week, 4 days per week or more.
 - Weekly aerobic training. 'Since covid-19, how long (in minutes) was your average session of moderate or vigorous aerobic physical activity?' (15-480 minutes) and 'Since covid-19 on average, how many times per week have you done 15 minutes or more of moderate or vigorous aerobic physical activity?' (0,1,2 to 13 times per week, or 14+ times per week).
- Alcohol consumption. Binary. Participants were asked 'How often did you have a drink containing alcohol in the past month?', 'In the past month, how many units of alcohol did you drink on a typical day when you were drinking?'. Scores were multiplied to compute a binary measure of weekly consumption, categorised into ≤14 and >14 alcohol units.
- **Smoking.** At baseline, 'Which statement about tobacco use and cigarette smoking best describes you?' At follow-ups, '2 months ago/previously, we asked about your tobacco use. Your situation may have changed since then, or not. Which of the following best applies to you now?' (2 levels) **Yes** (I smoke cigarettes (including hand-rolled) every day, I smoke cigarettes (including hand-rolled), but

not every day, I do not smoke cigarettes at all, but I do smoke tobacco of some kind (e.g. pipe, cigar or shisha), No (I have stopped smoking completely in the last year (at baseline)/in the past 2/3 months (follow-ups); I stopped smoking completely more than a year ago (baseline)/more than 2/3 months ago (follow-ups), I have never smoked any cigarettes/I have never been a regular smoker (i.e. smoked for a year or more).







