

# Supplemental Methods and Figures

## Section 1: Travel Behavior of Dogs

Each dog is assigned to a subgroup in their home geographic cluster, with each subgroup corresponding to the likelihood of travel to each of the three water sources; dogs do not change subgroups. All dogs use their home water source exclusively during the rainy season (from June to October). The probability that a dog travels to a geographic cluster's water source during the dry season is outlined in Table 1. These probabilities were determined based on research which suggests that a dog's mean travel range is 4.4 km<sup>2</sup> in Chad during the dry season, and 80% of dogs visit ponds within 100 meters from the dog owner's home (McDonald et al. 2020).

## Section 2: Model of Water Infectivity

The Chad GW Eradication Program (GWEP) documented GW infections in Chad in 19 districts representing 1674 villages. Wang et al. used K-means to group districts into three geographic clusters/regions using relative worm emergence per month, latitude, longitude, position along the Chari river and elevation.

Given parameters reported in Table S2, the probability that a dog is infected after visiting a water source on a given day (by consuming infectious copepods via drinking water or transport hosts) is calculated as follows. With the sigmoidal function given by (1), the basic infectivity of a water source when there are  $n$  infectious guinea worms in the water source is given by (2). With the addition of seasonality (with environmental factors developed by Perini et al. and based on rainfall and temperature measurements to account for dry vs. rainy seasons), the final infectivity function is given by (3). The infectivity parameters (Table S2) were calibrated by Wang et al. A compartmental diagram of the transmission cycle between dogs and a single water source is presented in Figure S1.

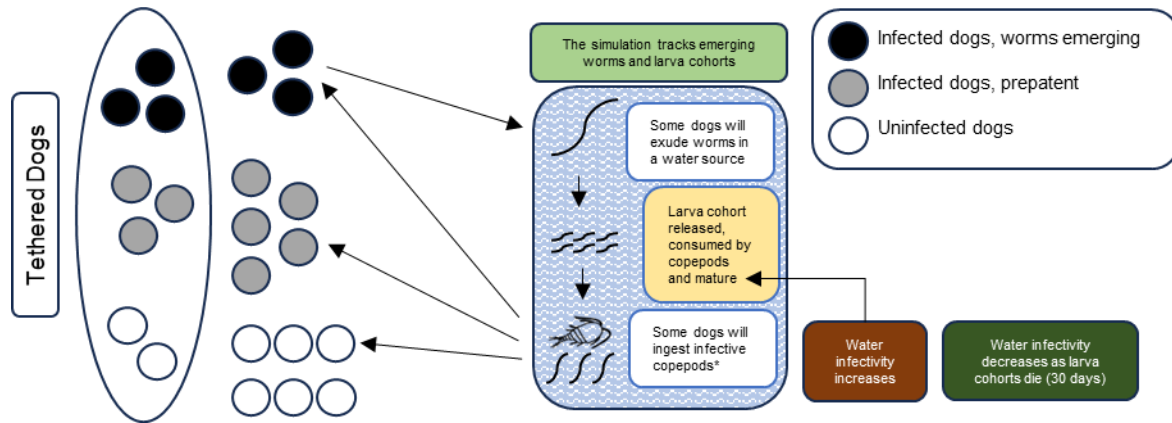


Figure S1 Diagram of the transmission cycle between dogs and a single water source on a given day, and the impact of exuded worms on the infectivity of a water source. In the dry season, dogs can travel to multiple water sources. If a dog is tethered, it does not visit a water source. Overall water infectivity is determined by environmental factors, abate levels, infectivity parameters, and the number of mature guinea worms in the water. \*Dogs are infected by ingesting infective copepods via consumption of water containing copepods or by consuming short-term transport/paratenic hosts.

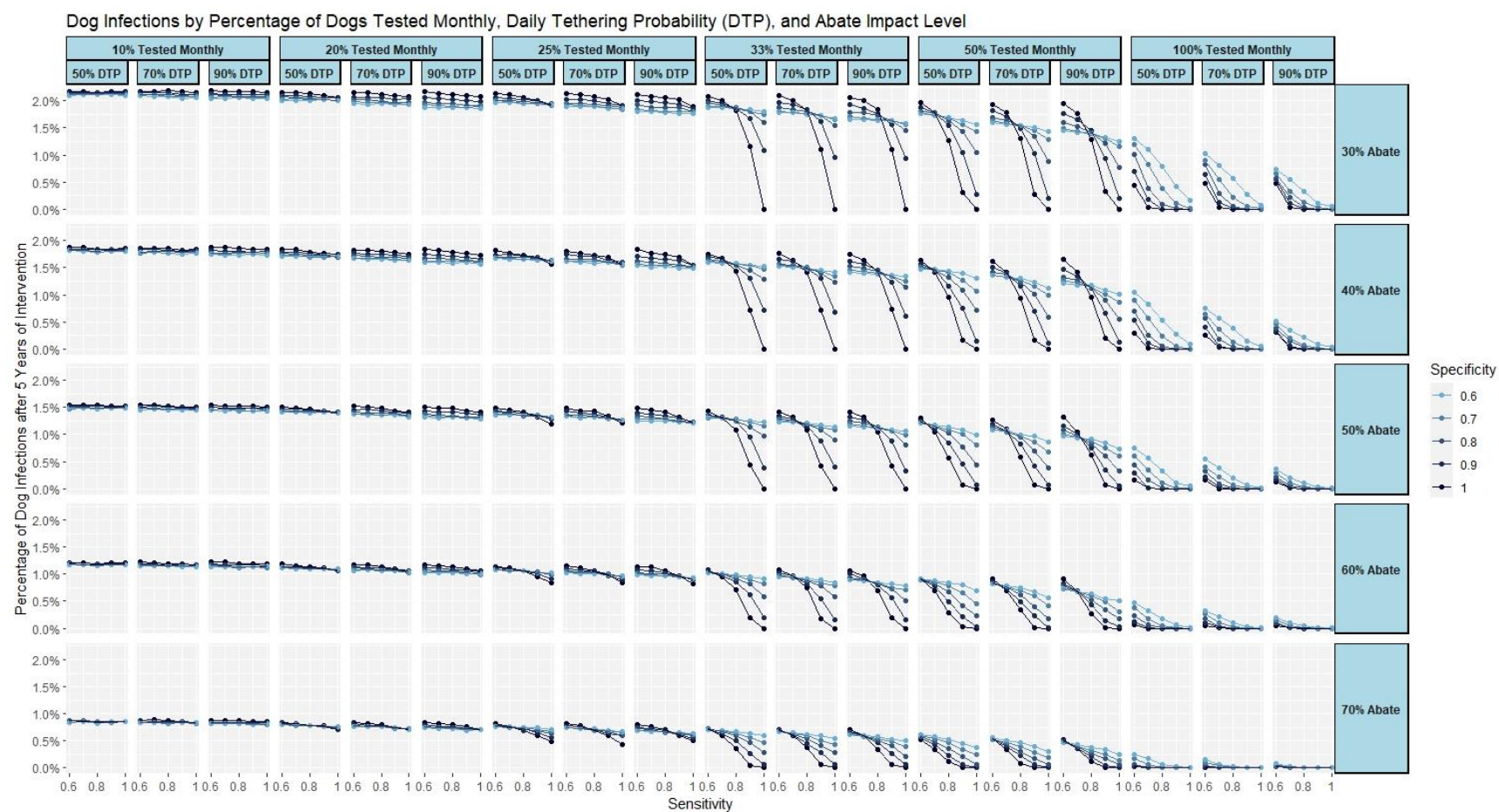

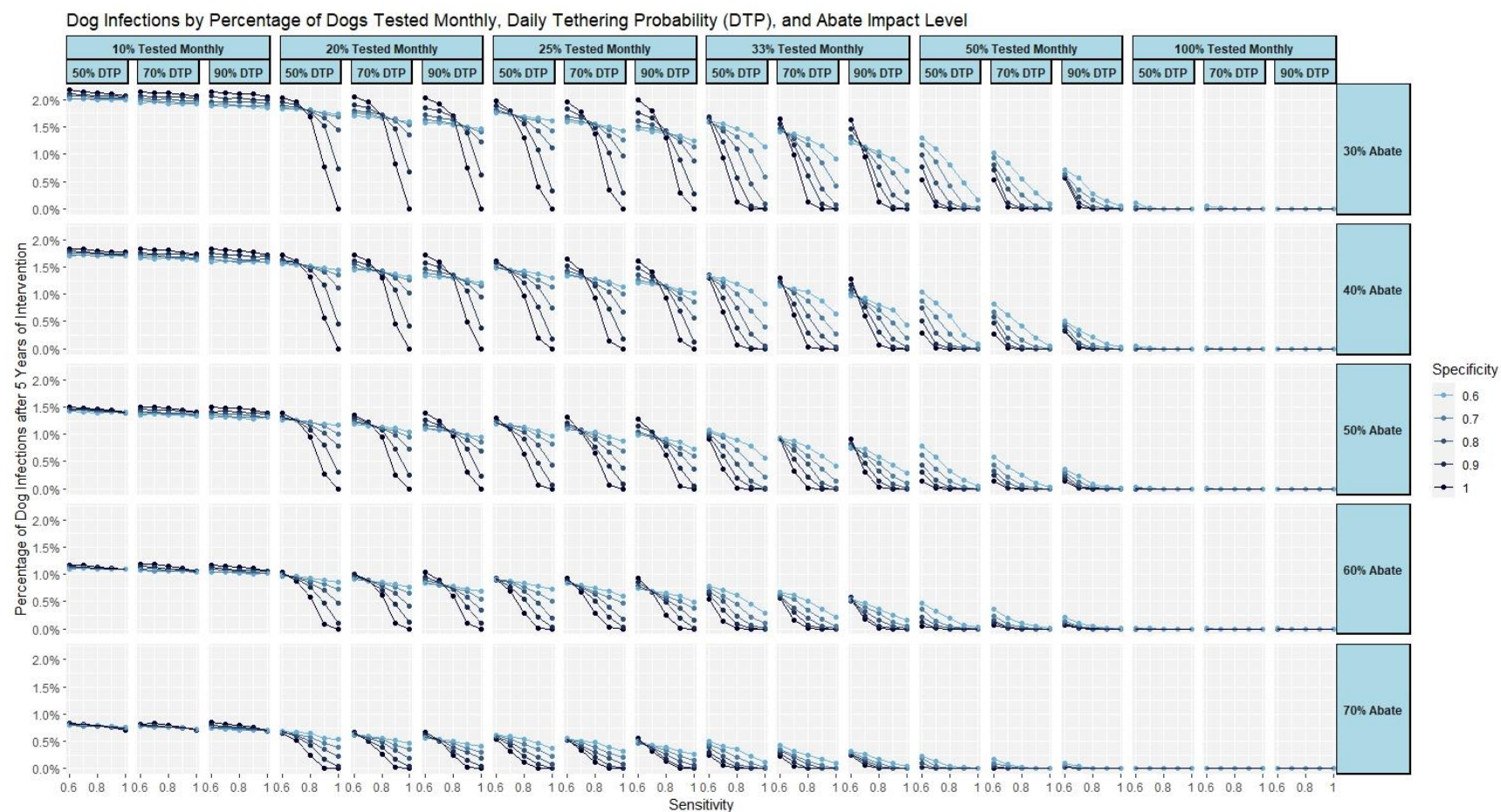

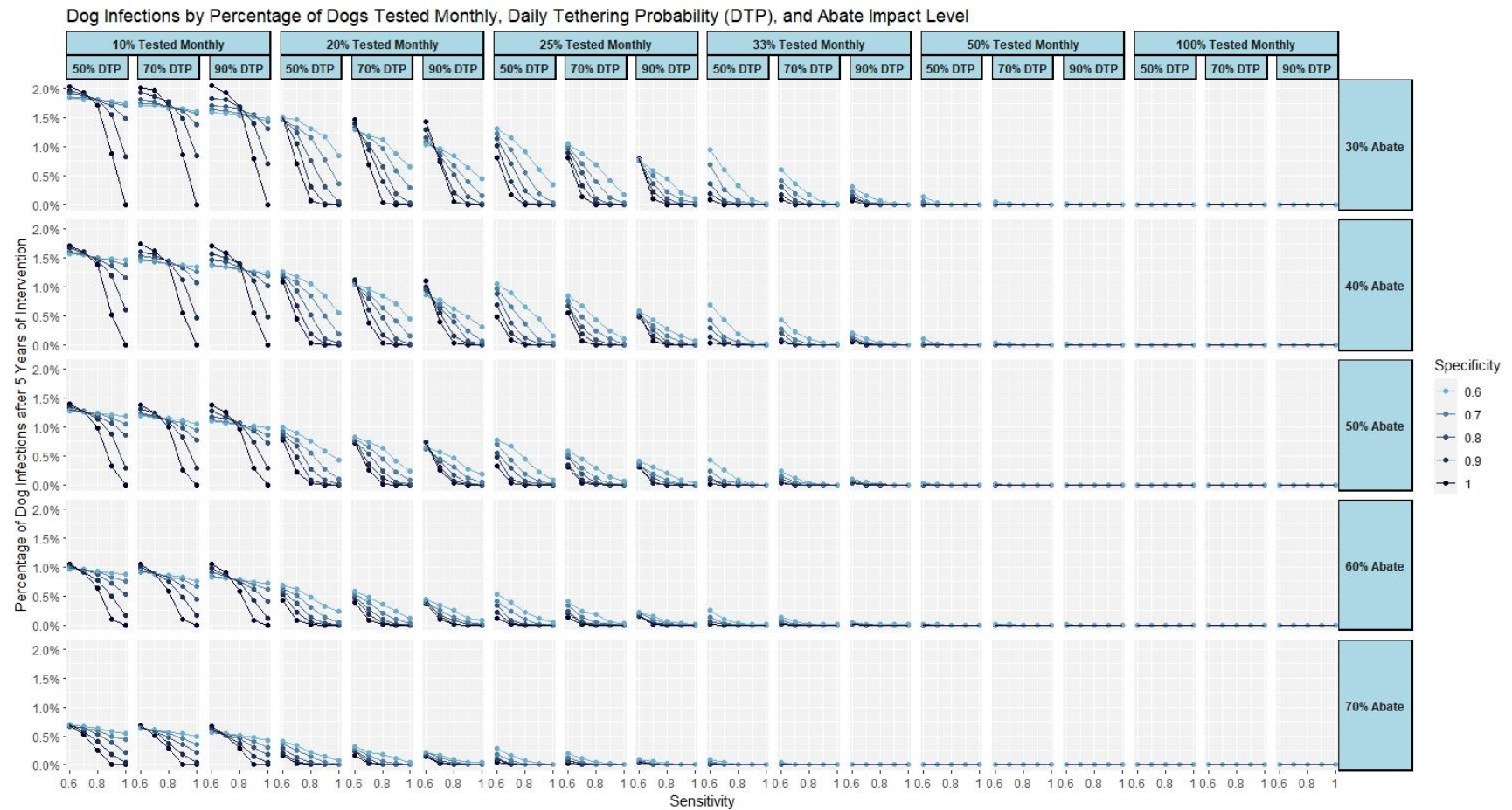
