


Figure S1. Weighted prevalence of each level of the HIV care cascade by end of the calendar year not considering incidence of death by sex, using an adherence level of 80%








Figure S4. Weighted prevalence of each level of the HIV care cascade by end of the calendar year not considering incidence of death by US Census Region, using an adherence level of 80%
